## t least one Lagos candidate in the Unified Tertiary Matriculation Examination, UTME, has always emerged among the 10 highest scores in the last three years.

A report by the Joint Admission and Matriculation Board shows that in 2023, a candidate, Gbolahan Ayinde from Lagos state scored 357 and he is among the 10 highest scores across the 36 states and the Federal Capiotal Territory.

Ayinde was three marks lower than the highest score by Nkechinyere Umeh from Anambra who scored 360. In 2022, a Lagos candidate, Ajayi Eberechukwu Isaiah, was the fourth best candidate, a male, with registration number 10067858JC. He scored 349. He hails from Lagos and sat for the examination

In 2021, a candidate from Lagos,, Monwuba Chibuikem scored 358, according to the examination board in a statement issued at its policy meeting and that the score was the highest.

in Lagos.

According to the document, Qomarudeen Alabi from Osun and Adeogun Oreoluwa from Ogun jointly came second as they both scored 350.


This Lagos position has been attributed to stiff competition due to the high number of registered candidates from the state. This high volume, investigation shows is due to the efforts of some Local Government and Local Council Development Areas in providing free UTME forms to brilliant indigent candidates.

In 2023, according to JAMB, Lagos registered a total of 270,573 followed by Oyo 94, 911 and Ogun with 91,970 candidates at the close of the extended period of registration.

Echonews collated some of the free UTME forms given by local government and local council development areas, individuals, lawmakers and Non-Governmental Organisations as candidates prepare for 2024 UTME in a few weeks. In 2023 UTME, Echonews gathered that about 6000 free UTME forms were given to indigent candidates by local government and local council development areas, which accounted for 18 per cent of the total number of registered candidates in the

## Free UTME Forms Raise Candidates'Scores

For the 2024 UTME, our correspondent observed that the number of free form may not be as high as in 2023, judging by a few number of the lawmakers, local government and local council development areas that have provided the opportunities.

At present the number of free UTME forms given to candidates is below over 7350 put together by the estimation of our correspondent,

For instance, a federal lawmaker, representing Amuwo-Odofin Federal Constituency Olawande Adegeye, presented 1000 free UTME forms to indigent youths

Beneficiaries cut across major groups like: Christian and Muslim Associations, Resident Associations, Professional Groups. Market Associations, Labour Party, Peoples Democratic Party, All Progressives Congress, and other political parties. Adegeye, popularly called

'Omogeye' by his followers and political admirers, while giving out the forms to beneficiaries, stressed that it was part of measures to uplift the educational standards among the demography of youth in the area.

He said it was purely an avenue to help as many youths as possible in the constituency with bright prospects to attain their set goals through education.

According to Adegeye tertiary education has the potential of building a virile and viable community but the major setback encountered by many families is financial constraints.

He said"It is targeted at ensuring that more deserving youths have equal opportunities to pursue higher education. That is the main reason behind this initiative to provide free JAMB forms to indigent youths.

"It is geared towards alleviating the financial

burden many families had to bear within the constituency and to ensure that a good number of youths are not denied the opportunity to further their education due to financial constraints."

At Mushin Local Government, the Chairman Emmanuel Bamigboye, gave free UTME forms to hundreds of indigents candidates.

Though he refused to

mention the number, he said the gesture would assist those who may not have the means to pursue their dreams of higher education. Bamigboye said, ""I count it as a sense of pride and purpose to embark on a noble mission to empower the indigent students of the community with free JAMB Forms as educational palliative, in order to assists

He added that significant steps are taken towards ensuring that every deserving student has a fair c h a n c e t o e x c e l academically.

their parents.

"The JAMB forms that we are distributing will serve as a passport to a world of knowledge, growth and endless possibilities, with the aim to enable our students in Mushin compete on an equal footing with their more privileged peers," he said.

He added that his administration will not relent in providing the best for youths and students in all ramifications.

About 200 indigent students were given the forms by the Chairman of Apapa-Iganmu Local Council Development Area (LCDA), Mrs. Funmilayo Muhammed, saying she has contributed to their academic pursuit.

The council boss stated that the forms would give beneficiaries the zeal to pursue their academic dreams for greater career in future.

She implored them to do away with the social media for now and focus on studies to achieve success that will make the LCDA and their parents proud.

To her the distribution of the free JAMB forms is part of the dividends d e m o c r a c y encapsulated in APC led administration.

A lawmaker representing Kosofe constituency 2 in the Lagos state House of Assembly, Hon. Femi Saheed also provided 400 free UTME forms to candidates in his constituency, saying that he had done so to pave way for more medical doctors, engineers, financial experts and other professionals in Nigeria have influenced his decision to distribute free 400 Jamb forms to indigent students in the constituency.

The chairman of Agboyi Ketu Local Council Development Area (LCDA), Hon, Dele Oshinowo, distributed free UTME forms to 500 indigent students in the council area.

To him, the distribution of the forms aligned with his administration's commitment to developing education in the council area.

"Today, we are distributing UTME forms to 500 indigent students in Agboyi Ketu. The forms are meant for those students who cannot afford them. They are the indigent ones, so we are doing this to uplift them. We are giving them this opportunity because if they do not sit for the UTME, there is no way they can go to the university. What we are doing today is to give equal opportunity to all the students in the council area. We are sure that so many students are financially challenged and so, we are doing this to support them," Oshinowo said.

In Oshodi/Isolo area of Lagos, a lawmaker representing Oshodi/Isolo constituency 2,Okey-Joe Onuakalusi gave free UTME forms to 300 students.

He said that the

initiative marks not just a fulfillment of a campaign promise but a step towards reshaping the educational landscape of the constituency.

"The distribution of free JAMB forms in Oshodi/Isolo 2 is a testament to a deeper commitment towards educational development. The beneficiaries, a mix of hopeful youths, have been given more than just examination forms: they've been entrusted with a responsibility to excel and to justify the faith placed in them. This is not just about passing an exam; it's about proving that we can be the leaders this community needs," he said.

In Ikeja Local Government, a foundation, the LOK Foundation doled out free UTME forms to 500 youths, describing the gesture as an effort to eradicate poverty at the grassroots.

The founder and CEO of

LOK Foundation, Engr. Luqmaan Olabode Kehinde Akerele, alluded that the reason for forming the foundation in 2019 was to promote and improve the quality of life of the people at the grassroots level and education is an integral part of it.

He noted that the free UTME form is an annual event and it is the fifth since the formation of the foundation.

However, the former Lagos State House of Assembly candidate further encouraged the beneficiaries not to let him down but make judicious use of the JAMB form by studying well so as to get high s c o r e s t o g a i n admission and come out of their respective schools with flying colors.

In Ibeju-Lekki Local Government Area, the current supervisor for education Hon. Ogungbo Temitope Sofwan flagged off the free tutorial classes and distribution of UTME form to over 200 candidates.

He said the initiative was geared towards complimenting the efforts of the Council Chairman of Ibeju-Lekki Local Government, Hon. Abdullahi Sesan Olowa on education.

The Vice Chairman, Chief Hakeem Olalemi, Lagos Central Senatorial District of the Peoples Democratic Party (PDP), also distributed 70 free UTME forms to indigent students in Surulere.

To him education remains a powerful weapon to reset the society, hence the need to invest heavily in it. "Today, I have just distributed 70 UTME forms to indigent children in our communities in Surulere Constituency 1 of Lagos State to give

them opportunity to pursue their educational dreams.

Olalemi said that the free UTME forms were distributed to children of PDP members and other less privileged children drawn from the six electoral wards in the constituency.

In Ikorodu Local Government Area, a federal lawmaker Babajimi Benson who facilitated a free form scheme said that 120 indigent candidates had benefited from the free UTME forms.

Tagged, "Oba Ayangbure Free JAMB Form" a former Executive Assistant (EA) to the Governor of Lagos State who is also the donor Prince Yommy Olusegun Shopitan said that the gesture extended to the 120 students who are residents of Ikorodu Division, is part of efforts to give back to the community.

Speaking on his expectations from beneficiaries, Prince Shopitan charged the beneficiaries to make good use of the opportunity by passing their JAMB examinations and gain admissions into various institutions of higher learning, and also emerge as professionals in their field of studies.

The Executive Chairman of Itire-Ikate LCDA, Hon. Ahmed Olanrewaju Apatira, distributed free UTME forms to 250 beneficiaries within the district.

The beneficiaries were

drawn from the market groups, religious bodies, political parties, artisans and the physically-challenged. The Council chairman urged beneficiaries to invest quality time studying in order to record success in the examinations to be able to advance in their learning.

One of the beneficiaries, Adelaja Oyinkansola, a graduate of Eva Adelaja Senior Secondary School, Bariga thanked the donor for the gesture.

For Osho Babatunde, another beneficiary, the initiative has restored hope to many who are financially challenged.



### Land Grabbing: Lagos Govt Prohibits Illegal Entry of Landed Properties

n a bid to curb and tackle the unscrupulous activities of land grabbers in the State, the Lagos State Government, through the Lagos State Special Taskforce on Land Grabbers under the State Ministry of Justice, on Tuesday organised stakeholders meeting with the theme: "Safeguarding Possessory Rights in Lands: The Role of Lagos State Special Taskforce on Land Grabbers", at Leawood Hotel, Sangotedo, Eti-Osa The Attorney-General and General and Commissioner for Justice, Mr. Lawal Pedro, SAN, in his address at the event, noted that the rise in cases of Land grabbing is an issue of great concern to the State Govrnment.

According to the Attorney General, the purpose of organising the Stakeholders' Meeting is to foster open dialogue, share in form at ion experiences, and



collectively identify solutions to the problems inherent in the activities of land

"As part of the effort to address the issue of land grabbing in the state, the Lagos State Government enacted a law to prohibit forceful entry and illegal occupation of landed properties, as well as violent and fraudulent conducts in relation to landed properties in the State", Pedro stated.

Pointing out that resolving land-grabbing issues is of great importance to the S a n w o - O I u Administration, Pedro stated that the menace of Land grabbers has led to conflicts on lands in the State which has resulted in the

destruction of properties and even loss of lives.

"It is a fact that property transactions in Lagos State have been greatly hindered by the activities of the O m o - O nile and Ajagungbales", he said.

Furthermore, the Attorney-General emphasised that the law on land grabbing that was enacted in 2016 still stands regardless of one's status in society.

He explained some of the provisions of the Lagos State Property Protection Law, 2016 and in particular, Section 2(1) of the Law, which prohibits the use of force or selfhelp by anyone to take over any landed property or engaging in any act inconsistent with the proprietary rights of the owner of any landed property in Lagos.

Speaking earlier, the Solicitor-General and

Permanent Secretary, Mrs. Titilayo Shitta-bey Jeje expressed delight towards participants and key stakeholders present for honouring the invitations provided for the event for the event.

She noted that the gathering is of utmost importance which is to explore the role of the Taskforce in Safeguarding Possessory Rights in land within the State, saying "The issue of land grabbing has been a persistent challenge in various parts of our state causing unrest state, causing unrest, stifling commercial activities, and disrupting the lives of Lagos residents".

Shitta-bey-Jeje stated that all hands must be on deck in shaping the policies and strategies that will curb landgrabbing activities in the State.

While urging participants and key stakeholders to work together in ensuring the safety of landed

properties in the State, she wished everyone to present, a fruitful and engaging discussion towards eradicating illegal acts of land grabbing in the

Also speaking, Director of Public Prosecutions and Guest speaker of the occasion, Dr. Babajide Martins stated that since its inception, the Task Force has been actively engaged in addressing this menace, receiving and resolving numerous petitions.

"The Taskforce has received 7500 petitions out of which 1251 are frivolous, 4283 disputes have been resolved, 205 land grabbers have been arrested, 60 cases are being prosecuted in various courts while 1566 petitions are currently pending before the Task Force. However, our work is far from over. Challenges persist, and we must come together as a

community to find sustainable solutions", he said.

The Elejigbo of Langbasa, HRM Oba Hafeez Olakunle Badiru, said that Land grabbers for decades have constituted a threat to property acquisition in Lagos, noting that there have been alarming reports of land grabbing across the State.

While acknowledging the State Government efforts in curbing Land grabbing in Lagos, Oba Hafeez Badiru, implored the State Government and the Police to ensure immediate prosecution of identified land grabbers and their sponsors to and their sponsors to serve as a deterrent to other individuals in the State.

Delivering the vote of thanks, the Coordinator, Lagos State Special Taskforce on Land Grabbers, Ms. Rukayat Shomade expressed gratitude to the State Government and the Ministry of Justice for their immense support towards the agency and looked forward to future collaborations.

Food Logistics hubs for storage a n d distribution.

Gov. Babajide Sanwo-Olu and his Niger State counterpart, Mallam Umar Mohammed Bago, signed the contract on behalf of the parties.

Sanwo-Olu said: "We have just put the pen to paper and signed the Government-to-Government agreement between Lagos and Niger states for agricultural production. Lagos,

being the smallest State in terms of landmass, and Niger, being the largest State, is no coincidence that the biggest and the smallest are looking for at opportunities to citizens of our both states to be the beneficiaries of this historic partnership.'

The prosecutor told the court that the defendant allegedly

unlawfully assaulted The defendant pleaded the complainant, not guilty to the charges.

The magistrate, A.O. Onalaja, granted the defendant bail of N500,000 with two sureties in like sum.

Ms Onalaja held that one of the sureties must be a clergyman or a respected

community leader with evidence of tax payment.

He adjourned the case until March 28 for mention.

## Ayra Starr Sparks Online Gender Debate


