



Ejigbo Sodomy: Suspects finally regain freedom, eight years after

ight years after they were arraigned, parties to the alleged sodomy case at Oba Morufu Ojoola Market, Ejigbo have been finally acquitted and freed by Court.

On Monday, last week, June 6, the counsels to the defendants were able to secure their release except one of the defendants, the then market leader (Baba-Oja), Isiaka Waidi, who had filed for plea bargain.

The application seeking the release of the defendants was filed by the counsel to the 1st and 4th Defendants, Barr Kayode Ademiluyi.

The application, filed in 2016, asked the Court to strike out the case since there was evidence that the victim allegedly killed is still alive, and that the defendants could not be kept in remand for ever.

In the process of giving justice, the court had slated March 30 as the deadline to submit their final addresses.

The Lagos State Government, represented by the office of the Attorney-General, was accusing 10 defendants of assault on a woman, Mrs. Nike Salami and her two daughters -Juliana Agomo and Ajoke Agomo.

Set to dispense justice was Her Lordship, Hon. Justice Atinuke Ipaiye of the Lagos High Court, Igbosere.

She was formerly of the Ikeja Judicial Division but continued to handle the case when she was transferred because the case was already on trial.

And apparently determined to round it off, she declared that any party that failed to file its written address for adoption by March 30 has waived its

preparations to continue the case. But the case was stalled because the counsel representing the fifth to 10th defendants, J. H. Bashir was yet to file his written address before the commencement of court proceedings. Similarly, Barrister Tunji Busari, representing the second and third

accused was not in court. Justice Atinuke Ipaye, therefore, adjourned the case till March 30 to enable parties file final addresses.

Mrs. Nike Salami and her daughters (Juliana Agomo and Ajoke Agomo) were alleged to have stolen pepper at the Ejigbo market on February 11, 2013 and a video posted by one Tola Julius showing how they were assaulted went viral a year after.

At the court, Counsel for the 6th-10th defendants substituted their final written address with a new one filed dated 4th March, 2020. Counsel for the 1st & 4th defendants complained that he had not been served with the said final written address of the 6th - 10th Defendants.

The Prosecution's Counsel informed the Court that they have responded to the 1st Defendant's application for plea bargain and in the said response, the prosecution is recommending 12 years commencing from the date of remand.

Counsel to the 1st & 4th Defendants, Barr Anthony Ezeadebor, while admitting receipt of the said response with respect to the plea bargain, stated that same was served on him there in court just shortly before the matter was called, and would need to confer with the 1st Defendant as well as with his Principal-in-Chambers who was expected to append his signature on the received documents before having the documents properly before the Court. The Court ordered the registrar to issue Hearing Notice on the 2nd, 3rd & 5th Defendants Counsel as the matter shall progress and any party who has not filed their final written address on the said adjourned date might as well be waiving his right to do so.

The Defendants were initially arraigned at the Magistrates' Court Igbosere, Lagos Court 1 in charge number A/37/2014 before Mrs. A.O. Adebayo, the Chief Magistrate Administration by

the office of the Commissioner of Police Federal SARS Adeniji wherein the 10 defendants were arraigned on a 9 count charge of murder among other charges. They were, however, admitted to ball subject to terms and condition which was perfected and the case file was thereafter duplicated and transferred to the office of the DPP for advice.

By virtue of the DPP advice dated the 2nd day of September, 2014, it was advised that there was available evidence that linked and implicated all the 10 defendants to the heinous crimes committed in varied degree.

While the matter was pending at the Magistrate court, the prosecution filed charges at the high court on the 17th February, 2005 for hearing on the 18th day of March, 2015, the matter was called at the Magistrate Court, Igbosere, DPP and team were absent at the proceedings.

Magistrate Court and transferred to the Lagos High Court.

The first accused, isiaka Wahidi, made a plea bargain when hearing.

His counsel, Barrister Kay Ademiluyi Chambers, contended that since the accused has been remanded in prison for the period he would have served if he had been found guilty at first appearance, he would be pleading guilty to the charge to secure his freedom.

According to document obtained by ECHONEWS, part of the address stated that:

"On the 1st defendant, the mere fact that his name was mentioned by the prosecution witnesses is not enough to establish a prima facia case; the persecution must prove his case beyond reasonable doubt."

The defence counsel also argued that the fourth accused, Jimoh Busari, has no case to answer.

The counsel, in its final written address,

established between the accused and the crime, the verdict should be positively resolved to his advantage. On Monday, June 6, 2022, nine of the ten defendants were released by the court. The 1st Defendant, Isiaka Waidi was retained in detention due to his plea bargain.

The counsel to the 1st and 4th Defendants, Barr Kayode Ademiluyi told ECHONEWS that the 1st Defendant may still be in detention till December, 2023. Speaking on the ruling that set the defendants freed, Ademiluyi said the ruling was based on the application he made citing the section 36 of the 1999 constitution.

He said his chamber had flied the application since 2016 asking the court to strike out the case since investigation showed that the girl earlier alleged to be killed was still alive.

According to him, "since the case has been on for a long time and we cannot keep the defendants in prison for ever. we asked the court to strike the case out and finally we got the ruling last week and all of them were released except the first defendant who had filed for plea bargain. "On Monday the 6th day of June, 2022, at the High Court of Ikeja where the Ikeja Division administrative judge is, Justice Atinuke lpaye delivered a ruling by striking out the names of the remaining nine defendants out of the 10 defendants charged for several count charges."

Appearing for the office of the Attorney General of Lagos State which is prosecuting the case, Barrister Bisi Bello said the government was ready to proceed with the matter.

Gbagada residents frown at cell construction within Estate

esidents of Gbagada Phase 2, Kosofe have accused the National Drug Law Enforcement Agency of attempting to construct holding cells for suspects in the Estate. The Estate residents' association wrote to the Lagos Building Control Agency and the Lagos State Physical Planning Permit Agency when it noticed the structure, which was being erected in a residential building on Jogunomi Street. The estate wrote the firm in charge of the construction, requesting necessary approvals from the Lagos State Government for the structure. According to the estate, the company claimed it was constructing a store for a federal government agency and that the necessary documents for approval had been submitted to regulatory agencies.

The Vice President of Gbagada Estate Residents' Association, Kenneth Odusanya, buttressed more on the accusation.

"At about eight weeks ago, We realised that some men were constructing an unusual building in the estate without authorization and so we reported to the Ministry of Environment and Lagos State Government agencies that came to seal up the place. "Afterwards, the developer's lawyer and the architect came to tell us they wanted to erect a store, but we do not want it because our estate is a residential area and the armed security personnel guarding the construction site are threatening the lives of residents, which also infringes on the peace and security of the estate. "The Chairman of NDLEA, General Mohamed Buba Marwa (retd) came and told his men to

cooperate with us and that they would soon move out of the estate."

The General Secretary of the residents' association, Mr. Chigozie Ajaonu disclosed that the construction work started in March.

"People, who go for strolls, get afraid because of the armed men. Then men of the NDLEA lied to us

with the construction." Ajaonu feared the construction was risky for residents.

According to a resident, Gbenga Babington, the estate is a quiet one that should not be experiencing such issue from the NDLEA.

"The vehicle of the NDLEA is parked in such a way that obstructs people whenever they



Forex trader bags two years jail for theft

he Domestic Violence and Sexual Offences Court, Ikeja, Lagos State has sentenced a forex trader, Shola Henry, to two years imprisonment for stealing.

The convict was arrested by the Economic and Financial Crimes Commission (EFCC) after it received a petition from a businessman, Anyasi Matthew, who claimed that Henry defrauded him of N20 million in the guise of investing the money in forex with 20 per cent profit in 30 days.

The defendant was subsequently arraigned on August 8, 2020, on amended six counts bordering on obtaining by false pretenses and stealing contrary to Section 1 (3) of the Advance

The defendants took the

Fee Fraud and Other Fraud Related Offences Act 2006. and Section 285 of the Criminal Law of Lagos State, 2011.

He pleaded not guilty to the charges.

During the court sitting, the prosecution team, led by Ahmed Yerima, called five witnesses through whose documentary evidence was tendered against Henry and his company.

The petitioner, who testified as the first prosecution witness, told the court that he met the defendant through a friend. Godwin Umoru, who told him that the defendant could help him make mouthwatering returns on his investment.

Matthew said N1 million was initially transferred to the defendant's account "just to find out if it was genuine" and



he received returns from Henry.

The petitioner said he transacted with the defendant for about six to seven times.

Matthew said the defendant gave him returns on the money as promised, but after he increased the investment to N5m and later N20m, the defendant stopped giving returns.

Henry, while defending himself, stated that he was into crypto currency as a middle man, adding that the scheme crashed in 2018. He noted that his brother,

Abiodun, who was at large,

was the lead trader.

Delivering judgement in the matter, Justice Oluwatoyin Taiwo noted that the socalled crypto currency business was nothing but a Ponzi scheme.

Justice Taiwo further held that based on the evidence before the court, the allegation of obtaining by false pretences was not proved by the prosecution and so discharged and acquitted the defendant on count one.

The judge, however, held that the prosecution proved the charge of stealing, found the defendant guilty as charged and sentenced him to two years in prison.

Following the allocutus of the defence counsel, Adeola Onikosi, the defendant was given a fine option of N2m and ordered to restitute the N20m to the victim.

The defendant's company was also fined N1 million and given one year to make restitution to Matthew.

Magistrate Kubeinje did not take their pleas and ordered that they should be kept at the Kirikiri Correctional Centre pending advice of the state Director of Public Prosecutions.

He therefore adjourned the case till July 7, 2022 for mentioning.

Lagos to implement Integrated Multi-modal transportation

he Lagos State Government has reaffirmed its position in implementing Integrated Multi-modal Transportation in the state.

At the opening ceremony of the National Transport Technology Conference and Exhibition on Victoria Island, the State Governor, Babajide Sanwo-Olu affirmed that Lagos State has been at the forefront of investment in a technological driven Multi-modal transportation system to address the technical challenges in the transport sector.

The Governor, who was represented by the Secretary to the State Government, Mrs. Folashade Jaji, reiterated that the goal of the Lagos State Government is to synchronize all modes of transportation to reduce travel time in a safe and affordable way for the citizenry, adding that his administration had remained resolute in completing existing mass transit line project to cater to the growing population.

He stated that an innovation such as the Cowry Card was created to synergize connectivity of the modes via centralized payment to simplify accessibility to all mode intervention and harness economic advantage.

Sanwo-Olu also explained that the Automatic Number Plate Recognition (ANPR), Traffic Management Solution (TMS) were technology introduced to curb excesses and recalcitrant road culture with reduced human intervention on Lagos roads.

Disclosing further, the governor said that over 6,000km of Metro Network Connection Fiber has been laid within the State to fast track higher bandwidth, faster internet speed with stronger security to make Lagos a 24-hour driven Smart City, assuring that his administration is open to collaboration that can aid successful reform in the transport sector. Earlier in her address, the Minister of State for Transportation, Mrs. Gbemisola Saraki, aligned with the need to achieve a greener transportation system to promote

environmental friendliness across the country

The Minister, who was represented by the Permanent Secretary, Ministry of Transportation, Mrs. Magdelene Ajani, explained that the Ministry was in the process of reviewing a policy on Non-Motorised Transportation (NMT) to further strengthen greener transportation in the country. Lagos Commissioner for Transportation, Dr. Frederic Oladeinde reiterated the resolve of the government to sustain and improve the existing technological interventions in the Transportation sector, adding that all types of challenges encountered daily require creative solutions.

Oladeinde expressed confidence in the Integrated National Security and Waterways Protection Infrastructure and proper leverage on technology to address transport and logistics challenges in the country. He assured that all modes of transportation will be adequately reviewed for the benefit of stakeholders and improved economic turnaround.

"The meeting is taking place at a pivotal moment in our nation where a sustainable roadmap is required to shape the future of transportation." the Transport Commissioner averred.

Ukada ban targeted at northern operators, groups lament

he Coalition of Northern Groups (CNG) has alleged that the ban on okada by the Lagos State Government was targeted at the northern operators.

The group while lamenting the rate of destruction of seized motorcycles (Okada) within the affected Mainland axis, therefore, described the action as "completely unacceptable". Its spokesperson, Abdul-Azeez Suleiman, said the action was irrational, alleging that the Lagos State Government had, in just 72 hours of announcing the ban, seized and destroyed about 7,548 bikes, mostly owned and operated by northerners.

"We noted that of recent, state governments in the south have resorted to imposing and enforcing controversial, unfriendly and damaging legislation that effectively curtail the right to freedom of movement of the northern people living in their midst.

"More disturbing is that in the current case of Lagos, the enforcers of the discriminatory law almost all the time fail to draw the decent distinction between the northerner as citizen, or commercial motorcycling as an occupation,

from criminality.

"To the makers of these laws and their formal and informal enforcers, it matters little that just because some Okada riders commit certain breaches does not make all motorcyclists criminals.




