# Chinamanda: Petition Medical and Dental Council, medics advise

**A** Professor of Pathology and former President of the Nigerian Medical Association (NMA), Dr Francis Faduyile, has advised renowned author Chimamanda Ngozi Adichie to formally petition the Medical and Dental Council of Nigeria (MDCN) over the death of her son, Nkanu.

Dr Faduyile made the call while reacting to media reports surrounding the child's death, stressing that the MDCN is statutorily empowered to investigate allegations of medical negligence involving licensed practitioners.

Adichie had accused a Lagos-based hospital, Euracare, of negligence, alleging in a leaked private message that the hospital's anaesthesiologist acted "criminally negligently" in the care of her 21-month-old son. The hospital has denied the allegations in a public statement.

The author has since initiated legal action, while the Lagos State Government has ordered an investigation into the circumstances surrounding the death.

While sympathising with the family, Dr

cautioned against practitioner's drawing name from the conclusions before medical register.

"We must be careful about media trials. A comprehensive investigation is concluded. "I am not sure Mrs Adichie has approached the MDCN, which is in the best position to handle allegations of professional misconduct," he said.


"There are established rules, procedures and penalties for erring medical personnel. A panel of experts will investigate the matter and interact with all parties involved." According to him, where negligence is established such as inappropriate drug dosage or professional misconduct, the MDCN has the authority to impose sanctions, including suspension or removal of a not necessarily

formally formal incidents without proper investigation. The process is clearly laid out, and Nigerians should allow it to run its course," he added.

Faduyile explained that adverse drug reactions do not always result from overdose or expired medication, noting that hypersensitivity reactions can occur even when correct dosages are administered.

"Many drugs react differently in different bodies. Dosage is calculated on a patient-by-patient basis, and sometimes it is the body's reaction to a drug that leads to complications," he said.

He stressed that the MDCN exists primarily to protect the public, not medical practitioners, and register for negligence that urged that all negligence. This does not mean allegations be formally reported. Nigerian doctors are bad. Many are disciplinary committees. work under very difficult conditions," he said.

On Adichie's legal action, Faduyile affirmed her right to seek justice but advised restraint. "There are two levels: the professional disciplinary process through the MDCN and the criminal process through the courts. Ideally, the MDCN process should come first. If the complainant is dissatisfied, the courts remain open."

He noted that proceedings of the Medical and Dental Disciplinary Committee are accessible, and that doctors under investigation may be suspended pending the outcome.

Also speaking, a public health expert, Professor Alero Roberts, described the death as tragic and deeply painful.

"As a grandmother, the pain is double. I feel the grief of a mother. It is mournful," she said.

Roberts, who oversees paediatric care at the Lagos University Teaching Hospital (LUTH), said deaths of young children often reflect systemic failures in Nigeria's health sector.

# LASEPA Reviews 2025 Milestones, Unveils Strategic Priorities for 2026

The Lagos State Environmental Protection Agency (LASEPA) has held its Annual Performance Appraisal and Media Parley, with the General Manager, Dr. Babatunde Ajayi, engaging media representatives and key stakeholders on the Agency's achievements in 2025 and its strategic direction for 2026. Speaking at the session, Dr. Ajayi described 2025 as a landmark year for LASEPA, noting that virtually all departments recorded significant milestones. He said it would be impossible to tell the environmental story of Lagos State without acknowledging the Agency's central role in driving environmental advocacy, regulation, and enforcement across the state.

According to him, effective communication remains essential not only for institutional visibility but also for ensuring that critical information reaches the public and stimulates positive behavioural change. He explained that the parley was designed to provide a comprehensive review of LASEPA's 2025 activities, while clearly outlining expectations and operational goals for 2026.

"Setting clear goals makes it easier to measure performance at the end of the year," Dr. Ajayi said, while underscoring the

priority," he stated. Addressing environmental governance. He identified enforcement as a core pillar of LASEPA's mandate, disclosing that the Agency carried out 244 enforcement actions across Lagos State in 2025. These covered religious centres, hospitality establishments, warehouses, markets, hotels, and residential households. He noted that while environmental compliance is often associated with corporate entities, households also bear environmental responsibilities which LASEPA enforces where violations are identified.

On industrial monitoring, Dr. Ajayi revealed that LASEPA intensified oversight of critical sectors, with particular focus on the Ojota Chemical Market, one of the largest chemical hubs in Lagos. He explained that regulating chemical handling is a strategic step toward curbing food fraud and mitigating environmental and public health risks. Working in collaboration with the National Environmental Standards and Regulations Enforcement Agency (NESREA), LASEPA ensured that chemical handlers were properly registered and compliant with safety standards, preventing illegal access to hazardous substances.

"Protecting public health remains our top


production capacity. Two kilns were deployed in 2025, with plans to introduce four or five additional units in 2026, subject to community assessments and private sector partnerships. On public health support, Dr. Ajayi explained that LASEPA collaborated with the Lagos State Ministry of Health and other stakeholders to collect and analyse water samples, interpret findings, and treat water sources, supporting early detection and prevention of cholera outbreaks.

He further disclosed that under the LASEPA-UNIDO cholera prevention initiative, funded by a ¥225,000 grant from the Government of Japan through UNIDO, the Agency distributed 223 food and water vendor kits across 12 markets, benefiting 770 participants in targeted local government areas, including Ikorodu, Lagos Island, Lagos Mainland, Alimosho, Ojo, and Kosofe.

Dr. Ajayi also highlighted major strides in air quality management, citing collaborations with the Air Quality Monitoring Research Group (AQMRG), the University of Lagos, AirQo of Makerere University, and C40 African Cities under the AC4A Initiative. These partnerships enabled the deployment of low-cost air quality sensors across Lagos, development of a greenhouse gas and air quality emissions

inventory, health commitment to impact assessments, prioritising public health, environmental sustainability, and the protection of lives and livelihoods of Lagos residents. He also emphasized the importance of strengthening collaboration with the media and stakeholders to build a cleaner, healthier, and more resilient Lagos in 2026.

# 16-Year-Old Student Donates To Tinubu Health Centre

A 16-year-old student, Oluwatariiresimi Agbeyangi, has donated essential baby items, including diapers and baby wipes, to Senator Oluremi Tinubu Primary Healthcare Centre in Ikoyi-Obalende Local Council Development Area (LCDA), in Lagos State, under her initiative, "The Cradle Project."

The donation, presented over the weekend, was aimed at supporting newborn babies, young mothers, and vulnerable families undergoing difficult circumstances, particularly during hospital stays.

Miss Agbeyangi, a student at The Hockaday School in Dallas, Texas, described The Cradle Project as a student-led humanitarian initiative committed to supporting new mothers and families in hospitals and care homes across Nigeria. 


# Lagos Plans To Address Menace Of Abandoned Buildings

The Lagos State Ministry of Housing has reaffirmed its commitment to providing more shelters for Lagosians and positively addressing the housing needs of residents across the state.

The Ministry also assured residents that the completion of all ongoing housing projects at various stages of construction across the State remains a key priority in Governor Babajide Sanwo-Olu's vision, which must be achieved

by 2026. The Commissioner for Housing, Hon. Moruf Akinderu-Fatai, gave the assurance while reviewing the progress the Ministry made in 2025, especially with the successful delivery and commissioning of the Akinsanya Sunny Ajose and A b r a h a m Adesanya Parcels A and B projects. Hon Akinderu-Fatai charged all heads of departments to ensure tasks and progress of work at all the project sites reflect quality planning and excellent delivery.

"We must all work assiduously to ensure Sangotedo Phase II, Egan-Igando Cluster II and III, Ibeshe Phase II, as well as all joint venture projects are delivered for Mr Governor's commissioning," he said.

The Honourable Commissioner further added that the Ministry will continue to collaborate with relevant stakeholders, private developers and financial institutions to ensure the successful implementation

of its housing programmes, in alignment with the State Government's THEMES Plus Agenda.

# Three-Month Amnesty: Lagos Cuts Cost of Replacing Faded Number Plate

The Lagos State Government has approved a temporary reduction in the cost of replacing faded and damaged vehicle number plates from 30,000 to 20,000, as part of a three-month amnesty and rebate window running from January to March 2026.

The initiative, approved by Governor Babajide Sanwo-Olu, applies to both private and commercial vehicle owners across the State and is aimed at improving vehicle identification, strengthening security architecture and enhancing overall road safety.

The Permanent Secretary, Motor

Vehicle plates are fundamental to public safety and security. This amnesty period allows motorists to replace faded plates at 20,000 instead of 30,000, reducing the financial burden while supporting collective efforts to make Lagos safer," Muri-Okunola stated.

He explained that the rebate applies strictly within the January to March 2026 window, urging motorists with faded or damaged number plates to take immediate advantage by visiting the Pilot Centre at Oshodi One Stop Centre, Oshodi or any of the agency's 140 stations across the state for the replacement

process. The Permanent Secretary emphasised that the initiative responds to rising security concerns linked to unreadable plate numbers, noting that legible and standardised plates are critical to crime detection, traffic management, digital vehicle tracking and emergency response systems. Muri-Okunola warned that upon the expiration of the three-month amnesty period in March 2026, the replacement fee will revert to the original 30,000, and enforcement measures will be fully applied to ensure compliance.

# Lagos Listed Among Top Seven Art Destinations

Lagos has been named as one of the seven art destinations to visit in 2026 by Artsy, the leading global online Art Marketplace.

# Lagos Deports Chadians Nationals Over Armed Robbery

The Lagos State government has ordered the deportation of two Chadians, who were also released from custody following their remand in prison over offence of drug peddling. The Chadians, Musa Abubakar and Yusuf Aliu, were released to decongest the state's

correctional centres as revealed by the chief judge, Kazeem Alogba. Alogba informed that Abubakar and Aliu were handed over to the Lagos State Controller of the Nigeria Immigration Service for immediate deportation to Chad, citing the nature of their offences. Alogba gave the

order at the Ogbaba Magistrates' Court shortly after approving their release from the

Nigerian Correctional Service under a special session organized for the release of eligible

inmates. The two men were among 18 inmates released during the exercise, which

drew beneficiaries from the Borstal Home, Adigbe; the female correctional centre; and medium- and maximum-security custodial centres across the state.

While addressing the inmates who had regained their freedom, Alogba advised them to seize the opportunity to reform and be fully reintegrated into society.




The police in Lagos have held four suspects for trial over accusations of stealing raw materials worth N5 million.

The accused, consisting of two males and females each, identified as Mohammed Ibrahim, 34, Taiwo

Ogunsanya, 40, Abiola Adebayo, 37 and Blessing Chukwu, 40, were said to have stolen the items and are facing a four-count charge of conspiracy and conduct likely to cause breach of peace as disclosed by a police prosecutor, Aminu Isaac, during the suspect's trial at the court. Isaac held that the alleged

lawbreakers contravened the stipulated laws of the state after stealing petroleum jelly belonging to PZ Cussons alongside receiving stolen products and promo items, all allegations pleaded not guilty to by the litigants. During their arraignment at the Ikorodu Magistrates' Court on Thursday, the policeman added that the offences which he said were committed on December 25, 2025, violated Sections 168(d), 287, 328 and 411 of the Criminal Law of Lagos State, 2015. The defendants were granted bail of N500,000 with two sureties in like sum by the Presiding Magistrate, Bola Osinuga, who fixed February 5 for their next re-arrangement.

# Rising Interest Rates Trigger Corporate Pivot from Debt to Equity

**N**igeria's prolonged high-interest-rate regime is triggering a quiet but decisive shift in corporate financing, with more companies turning their backs on expensive bank loans and opting instead to raise money through the equity market. As borrowing costs climb to multi-year highs, businesses are increasingly finding debt unattractive. The Central Bank of Nigeria's benchmark policy rate stands at 27 per cent, while

commercial lending rates in some cases hover around 36 per cent—levels that have made traditional loans a heavy burden on balance sheets. In response, firms are seeking relief in the capital market, where equity offers funding without the pressure of recurring interest payments.

This trend has become evident on the Nigerian Exchange (NGX), which has recorded a surge in equity fundraising

activity in recent months. Since mid-2024, non-bank corporates have raised an estimated N1.72 trillion through rights issues and public offers, with major players such as International Breweries and Nigerian Breweries leading the charge. Rather than accumulating fresh debt, these companies are tapping shareholders to finance expansion plans, acquisitions and operational restructuring.

Analysts say the

shift is a rational response to rising financing risks. High interest rates significantly increase the cost of servicing debt, compressing profit margins and reducing financial flexibility—especially in an environment of uneven revenue growth. Equity, while more complex from a governance standpoint, allows companies to preserve cash flow and lower the risk of default, even though it comes at the cost of ownership dilution. From a corporate finance perspective, the

logic is clear. When interest rates rise sharply, debt loses its appeal as firms are forced to commit a larger share of earnings to interest payments. Equity, while more complex from a governance standpoint, provides breathing space and strengthens balance sheets, making companies better positioned to withstand economic volatility.

Beyond short-term survival, equity

financing is also helping firms refocus on long-term strategy. Freed from the pressure of meeting frequent loan obligations, management teams can channel resources toward growth initiatives, innovation and market expansion rather than debt servicing.

Still, the approach is not without its drawbacks. Issuing new shares dilutes existing investors' stakes and can complicate decision-making. Yet for many companies navigating today's high-rate environment, the trade-off is increasingly seen as worthwhile. With interest rates expected to remain elevated in the near term, analysts believe more Nigerian firms will continue to rebalance their capital structures—leaning toward equity as a safer and more sustainable path to funding growth while safeguarding liquidity.



# Nigeria Advances Mining Drive with Lagos Gold Refinery

Nigeria is accelerating its push to reposition the mining sector as a key pillar of economic diversification, with a new gold refinery commencing operations in Lagos and a \$600 million lithium processing facility in Nasarawa State nearing official launch.

The start of gold refining in Lagos marks a significant departure from Nigeria's long-standing role as an exporter of unprocessed mineral resources. Instead of shipping raw gold abroad for refining, the country is now retaining more

value locally—a core objective of the Federal Government's solid minerals reform agenda. Minister of Solid Minerals Development, Dr. Dele Alake, has described the refinery as a flagship project under the value-addition drive, noting that it is the first in a planned network of four gold refineries nationwide.

The Lagos refinery is designed to produce high-purity gold that meets international standards, a move expected to boost export earnings, improve traceability across the gold supply

chain and curb illegal mining and smuggling. Industry experts say local refining will also stimulate job creation, enhance regulatory oversight and improve transparency in a sector long plagued by informal operations.

Beyond Lagos, additional gold refineries are under development in other parts of the country, signalling a coordinated effort to expand domestic processing capacity and deepen Nigeria's participation across the precious metals value chain.

While gold anchors

Nigeria's traditional mineral wealth, lithium represents its future-facing ambitions. In Nasarawa State, a \$600 million lithium processing plant is at an advanced stage and awaiting commissioning. Once operational, the facility is expected to position Nigeria as a supplier of processed lithium for global markets, particularly for electric vehicle batteries and renewable energy storage systems.

With demand for lithium surging worldwide amid the energy transition, the project places Nigeria on the radar of critical minerals producers and clean-energy

investors. Officials say the lithium plant reflects the government's intention to move beyond extraction into processing and industrial use, creating higher-value outputs and long-term economic benefits.

Nigeria's solid minerals push has also been backed by increased international engagement. Government officials unveiled details of the gold and lithium projects around the Future Minerals Forum in Riyadh, where mineral-rich countries and global investors converge to explore

partnerships, technology transfer and financing opportunities.

At the forum, Nigeria highlighted its reform efforts, including improved licensing processes, updated geological data and incentives aimed at attracting credible investors. Authorities stressed the importance of collaboration with countries that possess advanced mining and processing expertise to accelerate sector development.

With gold refining already underway and lithium processing set to follow, Nigeria is steadily reshaping its mining narrative—from a source of raw materials to a hub for mineral processing and value creation. Analysts believe these projects could significantly raise the sector's contribution to GDP, generate skilled employment and strengthen Nigeria's competitiveness in both traditional commodities and critical minerals.

As more processing facilities come on stream, Nigeria's solid minerals sector appears poised to play a larger role in supporting industrial growth, export diversification and participation in the global clean-energy economy.

# CBN Steps Up Cash Mop-Up Amid Cooling Inflation

The Central Bank of Nigeria (CBN) has significantly stepped up its campaign to drain excess liquidity from the financial system, recording a dramatic 182 per cent increase in cash mop-ups over the past year as inflationary pressures begin to show signs of relief. Fresh data from the apex bank indicate that liquidity absorbed through Open Market Operations (OMO) surged to about 33.12 trillion in 2025, compared with roughly 11.75 trillion in the previous year. The sharp rise highlights the CBN's more aggressive deployment of market-based monetary tools to rein in excess money supply, widely viewed as a key contributor to inflation and exchange-rate instability. OMO transactions allow the central bank to pull cash out of the banking system by selling

government securities to banks and qualified investors. By tightening liquidity, the CBN aims to cool price pressures, stabilise the naira and restore confidence in macroeconomic management. Analysts note that the approach mirrors strategies adopted by central banks globally during periods of elevated inflation, where tighter monetary conditions are used to anchor

expectations and curb speculative activity. The intensified liquidity tightening has also been designed to improve the attractiveness of naira-denominated assets, encouraging foreign portfolio inflows seeking higher yields and helping to support the foreign exchange market. This has become increasingly important amid efforts to stabilise the currency and rebuild external confidence. Measured shown that large Notably, the adjustments to OMO and Treasury aggressive mop-up has coincided with a gradual easing of inflation. Nigeria's headline inflation rate moderated to 14.45 per cent in November 2025, down from 16.05 per cent in October, suggesting that tighter monetary conditions are beginning to filter through to prices. Even so, the CBN has remained cautious, holding monetary major policy parameters steady for much of the year and opting for

# Lagos Land Dispute Pits Cleric Against Longtime Resident Amid Alleged Intimidation

**A** long-running dispute along the Lagos-Abeokuta Expressway in the Ojokoro axis of Lagos has escalated into a bitter confrontation between resident of Shorunke Street and the controversial Venerable Sowerun, a cleric who runs a Celestial Church of Christ cathedral in the same area. What had for years been a quiet, uncontested parcel of land has now become the subject of competing claims and mounting tension.

Mr Ashamu told our correspondents that he purchased the land in question in 1998 from Mr Abiodun Joseph Olufemi, popularly known as Cosmos, the owner of Cosmos Hotel located around

kilometre 30 of the Lagos-Abeokuta Expressway. He said the transaction, which cost

500,000 at the time, was properly concluded and that he has exercised control over the land ever since. For decades, he said, the property was used


only for auto mechanic activities without challenge or interference.

That relative calm, according to Mr Ashamu, ended last year when Venerable Sowerun allegedly began making moves that suggested an attempt to take over the land. He claimed that officials of the Lagos State Land Authority were brought to the site to inspect and

measure the property, an action he found puzzling and alarming in what he insists is a purely civil ownership matter.

While acknowledging that Venerable Sowerun has been in the area longer and commands influence through his church, Mr Ashamu maintained that longevity and prominence cannot replace valid ownership documents. He alleged that many residents are reluctant to challenge the cleric because of his standing in the community, describing him as someone widely feared by landowners in the area, an allegation that remains unverified.

According to Mr Ashamu, Venerable Sowerun later contacted him and asked that the present documents proving ownership of the





land. He said that he paid him in order to "reclaim" the land. Mr Venerable Ashamu said he flatly refused, insisting that he would not pay three occasions, for property he bought nearly three decades ago. Efforts at dialogue, he claimed, were unsuccessful. He

said that he and his brother visited Sowerun's church on three occasions, only to be told that he was not around. He further alleged that although the cleric later claimed he was ill and staying in

Now in his late 60s, Mr Ashamu said he fears losing the land he has lawfully owned for almost 30 years. Our correspondent also visited Venerable Sunday Sowerun at his Celestial Church of Christ residence. When our reporters got to the church, Sowerun threatened to seize their electronic devices. He declined to provide a detailed explanation about the ongoing dispute, but presented a survey plan dated 2022 and 2023 relating to a different streets in the area, asserting that it reflected official measurements relevant to his claims.

Venerable Sowerun told the reporters that he had repeatedly invited Mr Ashamu




to his residence to negotiate a settlement over the land, claiming that the matter could have been resolved amicably if the meetings had occurred.

He described Mr Ashamu as avoiding these engagements. The cleric insisted that Mr Ashamu has no formal ownership documents for the property, and argued that the land was never legally transferred to him. Instead, he claimed that a person he identified as "Concord" had allowed Mr Ashamu to use the land, implying that his current occupation was without proper title.

He also highlighted his connections within the community and broader networks, suggesting that his influence should not be underestimated. While some might see this as an assertion of authority, it



underscores the play in disputes where wealth, power over land in religious dynamics at Lagos outskirts, leadership, and

social influence often intersect with legal ambiguities.

In contrast, High Chief Julius Aderemi Adeniyi, the Baale of the area, offered what he described as historical clarity. He confirmed that the land originally belonged to Mr Abiodun Joseph Olufemi, also known as Cosmos, and was legitimately sold to Mr Ashamu with proper receipts. He explained that the Oyero family, who owned significant portions of land in Ojokoro decades ago, had sold multiple parcels, and that the Cosmos sale to Ashamu was consistent with these transactions.

The Baale emphasized that Mr Ashamu still possesses the original receipts, which serve as legal evidence of ownership. He further cautioned that the figure referred to as "Concord" by Venerable Sowrun is known locally as a land grabber, a claim that casts doubt on

the cleric's version of events. By providing historical context, the Baale positioned himself as a neutral arbiter, underscoring the importance of documented transactions and longstanding community knowledge in resolving disputes.

Ashamu later confirmed to our correspondent that he has reported the matter to the police. According to him, the police have asked Venerable Sowrun to present his own ownership documents if he claims title to the land.

Last Thursday, both parties showed up at the police station where Sowrun was represented by his lawyer.

As of the time of this report, the dispute remains unresolved, as the police had asked the them to go to court.

# Ibeju Lekki Rulers Urge Patience in Akodo Land Case

Traditional rulers in Ibeju Lekki, Lagos State have called on residents, prospective land buyers, and the wider community to exercise patience and allow the judicial system to settle the ongoing Akodo land dispute, warning against taking matters into their own hands. Led by HRM Oba Abdul Hakeem Olokodano, prominent Alakodo of Ibeju Land, the Ibeju

Lekki Traditional Council stressed that ownership of large portions of Akodo land remains tied up in multiple legal battles. The council cautioned that anyone purchasing property in the contested area without waiting for court rulings could face significant financial losses. The dispute involves at least 16 families, including

Oniwonlu Abejoye, Kejibo Elejide, Ogunlaja, Ogbeni, and Abdullahi Baba Egbe families, all asserting claims to the land. The complexity has compounded by the involvement of several real estate companies.

Historical judgments, including Supreme Court decisions dating back to the 1920s, cover parts of the land but do

not resolve all current cases still before the Lagos State High Court, such as Suit No. EPD/8283/LMW/2019, brought by descendants of the Oba Olumoye Oniwonlu family. The council emphasized that while customary institutions remain respected, ultimate clarity on ownership can only come through the courts. Rushing into sales or ignoring ongoing litigation

could result in disputes, eviction, legal battles, and wasted investments. The traditional council's message echoes similar calls from other royal figures across Nigeria, who have urged disputing parties to abide by judicial outcomes. For instance, in Delta State, a monarch recently reminded communities to respect court rulings in land

disputes, highlighting the importance of legal processes over self-help solutions. For the Ibeju Lekki Traditional Council, the priority remains peace, stability, and clarity. The leadership urged all stakeholders to let "justice take its course through the legal system," reaffirming that courts are the proper authority to determine rightful ownership in the Akodo land saga.

She said the engagement was convened to clearly outline the objectives and scope of the initiative, stressing that it was important for constituents to hear directly from her to avoid misinterpretation of the programme's intent and implementation. Addressing residents of Agboyi-Ketu LCDA, Ikosi-Isheri LCDA, and Kosofe Local

Government, Hon. Ogbara extended New Year greetings and reaffirmed her commitment to their welfare. She described the people of Kosofe as hardworking, resilient, and enterprising, noting that 2026 would be a year of deliberate action rather than mere rhetoric.

According to her, the Kosofe Mega Empowerment Programme is scheduled to hold on Sunday, January 25, 2026, at the CMD Funplex Centre, CMD Road, within the constituency. The initiative is targeted at youths, women, artisans,

traders, and small business owners, and is aimed at providing tools, opportunities, and resources to boost income generation and drive sustainable economic growth. Hon. Ogbara explained that the empowerment exercise builds on several skills-development initiatives she has sponsored over the past year. These include the training of mechanics and artisans under the National Automotive Technicians Association (NATA) in Compressed Natural Gas (CNG) conversion in Abeokuta, in preparation for emerging trends in automotive status, and technology. Beneficiaries of the training, she said, will now be empowered with the tools required to independently carry out vehicle conversions.

She also recalled the professional makeup training organised for young women at a reputable makeup studio in Victoria Island, as well as specialised technical training conducted by

Bosch, one of the world's leading manufacturers, for artisans in the constituency. Many of the participants, she disclosed, will receive Bosch tools as part of the empowerment package.

The lawmaker emphasised that the programme is not a routine distribution of items, but a deliberate, data-driven intervention aimed at achieving long-term impact. She explained that beneficiaries were profiled through physical and online forms to assess their skills, age, economic status, and experience, in order to match them with empowerment support best suited to their needs.

"This programme focuses on people who have already acquired skills and those who truly deserve support, including low-income earners and vulnerable constituents," she said. "By equipping trained beneficiaries with

the right tools and support, we are ensuring that skills translate into income, prosperity, and shared growth."

Hon. Ogbara noted that the initiative aligns with the Federal Government's 2026 budget vision on shared prosperity, as articulated by President Bola Ahmed Tinubu, adding that her empowerment drive reflects the broader national agenda of inclusive economic growth.

She announced that close to 1,000 constituents will benefit in the current phase of the programme, assuring those not selected that the exercise would be continuous throughout her tenure. "We have comprehensive data, and empowerment will rotate. Everyone will be reached in due course," she said.

the formal capping of the new White Cap Chiefs—an historic ceremony that once again reinforced the city's rich traditional heritage.





who showcase their culture internationally but struggle for equal visibility compared to artists based in Nigeria.

Speaking on the hurdles, Young Game noted that physical distance from Nigeria's music ecosystem remains a major barrier. "Afrobeats is global now, but access is still very local," he said, pointing out that diaspora artists often lack the industry connections, media exposure, radio support, and live performance opportunities

necessary to break records.

He further explained that, while many diaspora musicians invest heavily in production, promotion, and distribution, their efforts are frequently


overlooked due to industry gatekeeping and location bias. "You can have the sound, the story, and the consistency, but without proximity to the industry, it's easy to be ignored," he

stated.


Young Game also highlighted an identity challenge for diaspora artists, who are sometimes considered "too foreign" for the local market and

"not African enough" internationally. Despite this, he stressed their importance to Afrobeats' global expansion, noting that exposure to diverse audiences fuels innovation and introduces the genre to new territories.

Calling for inclusivity, the singer urged the industry to embrace diaspora creatives as essential contributors to Afrobeats culture. "Afrobeats is strongest when it is unified. Diaspora artists should not be treated as outsiders, but as extensions of the culture," he said.
