Ejigbo community mourns boy, 8 who drowned searching for plastic bottle cover

he incident
happened on
Monday last week.
onyekachi Umeh, an 8year-old boy, and his
cousin, a 9- year old had
left their home at No 15,
Ganiyu Street Ejigbo, to
pick plastic bottle covers
to play near the canal at
Baptist Street behind
Orilowo in Ejigbo, about
eight kilometres away.

It was gathered that the little boys, sometimes four in number, had always come to the place to pick bottle covers knowing they would get enough there. But elderly some residents, who knew the dangerous terrain, had always sent them away from the canal area.

"I have always pursued the boy and his colleague from the canal any time I see them there looking for plastic bottle covers. I don't know where they come from but I always send them away from the canal. In fact, I sent them away that afternoon, not knowing that they came back there. It is a pity that he finally lost his life inside the canal," one of the residents in the area told Echonews.

Narrating the incident to our correspondent, Obe said the chairman of the Christian Association of Nigeria, CAN, Rev Oyinlola alerted him.

"On that very day, it was a sunny day, I was called by the chairman of the Christian Association of Nigeria (CAN) who alerted me that a boy had drowned in the canal at Baptist Street, behind Orilowo. I immediately went there. I called the officers of the Lagos State Fire Services at our secretariat. In fact, I was amazed by their prompt response because they arrived at the scene in less

than 10 minutes. We wanted to be sure there was a body inside the

"The CAN chairman who alerted me said he was moved by the cry of the other boy who came along with the one who got drowned in the canal. It was the one who survived that alerted the residents. I invited all the security personnel including the LNSA, the police, and the firefighters. The firefighters brought all their divers who entered the canal and started looking for the boy whether he was alive or dead, just for us to be sure that a body was inside the

"The firefighters who entered the water began searching for his body s about 3 pm on Monday but could not find anybody till about 9 pm. Later, a diver who was just recruited by the fire service was invited all the way from Agbara. When the guy came, he just entered the water and brought out the dead body of the boy in less than 10 minutes. That was around 11 pm to 12 am.

"We couldn't locate the parents. I told the police to take his partner to their station and investigate him. He was sharp enough to give them some phone numbers but all the numbers were not reachable. It was a passerby who claimed to have once sent them away that said they told him that they came from Ganiyu Street.

"We traced their parents to the street but we could not locate them. Though the neighbours recognised the boy and confirmed they lived in the street, we could not get the mother, she was nowhere to be found. We went there again in the

night we still could not find her. It was then we learned that the father of the boy has died and that the boy was the only child. The woman had brought the second boy from her village in the Southeast to live with her. "After recovering the dead body, we took it to the mortuary at Isolo General Hospital. They initially rejected the remains, claiming that they could not take the remains of an underage, that we should take them to Yaba. But it was too late in the night, it

was around midnight. After much talk, they admitted the remains and we paid all expenses requested.

"We returned to the police station and later we got the mother who lost her husband about two years ago. She was speechless, we could not get much from her because she was just crying.

"Indeed, the water in the canal is toxic, we had to take those firefighter officers who first entered the canal to search for the body to our health centre

for treatment."

Though Obe blamed the incident on the negligence of the mother, he said the man-made canal was a danger zone.

According to him, the canal was dug by the Ojomu family to scoop filling sands from the area which later expanded to become a big canal and has since been a dangerous zone to the people, especially the little children.

Although, the council boss said the local government authority

under his leadership immediately started working in the area, putting a perimeter fence around the canal to save people. He, however, said the project is beyond the capacity of the local government, calling for the state government's intervention.

"We have started our effort to make the place safe, the state government needs to come in quickly to cordon off the area and clear the area. The area is not good for people to live," he said.

Citing a landmark case


decided by Justice Oguntiyinbo in suit marked FHC/L/CS/1497/2017, wherein the Social Economic Rights and Accountability Project, filed an application for an order of mandamus, to direct the Attorney General of the Federation Abubakar Malami (SAN) to recover on behalf of the federal government the pension collected by former governors who are collecting salaries in other public services. Justice Oguntoyinbo was quoted in the judgment to have

was quoted in the judgment to have ordered the federal government to recover the pension collected by the former governors and also directed the AGF, to challenge the legality of state

pensions laws permitting former governors and other expublic officials to collect such pensions.

Onigbanjo said Justice Oguntoyinbo in the judgment, rejected the argument of the AGF, that he cannot challenge the states pension laws for former governors, stating that the AGF should be interested in the legality or validity of any law in Nigeria and how such laws affect or will affect Nigerians being the Chief Law Officer of the Federation.

He said," In addition to her judicial duties, Justice Oguntoyinbo has also contributed significantly to the development of alternative dispute resolution in Nigeria."

Ministry of Justice Stages Moot Court To Strengthen The Capability of Lagos Counsels

n a bid to achieve the objective of cross-fertilisation of ideas amongst counsel, the Lagos State Ministry of Justice has recently organised a moot court competition for the state counsel at the Treasury Resource C e n t r e , D e b t Management Office, Alausa, Ikeja.

The one-day mock court proceedings had state counsel of the Ministry of Justice, prosecuting and defending cases towards honing their budding advocacy skills. The proceedings were presided over by a Judge.

In his address, the Attorney-General and Commissioner for Justice, Mr. Moyosore Onigbanjo, SAN, noted that a moot court session is very informative because it gives first-hand experience of court sessions to the participants by

drawing expertise of colleagues from different fields and by strengthening the relationship between state counsel and the court.

"Mooting is an excellent skill that is capable of assisting law officers to think and analyse in the style of an advocate, looking for loose threads, analysing legal logic and presenting conclusions accurately and effectively", he said.

"It gladdens my heart that I'll be witnessing the next Fawehinmi's today and I wish all participants the best today as we proceed", he enthused.

The Commissioner advised participants that knowledge of the law is the foundation of confidence, saying "You must know the law".

He noted that while presenting cases in court, it is of utmost importance that a counsel presents his or her strongest point first, as this will prove to the judge that the counsel knows what he or she is doing.

Onigbanjo also urged the state counsel to be a u d i b l e when speaking to arrest the attention of the judge and the court.

The Attorney-General later congratulated

the winners and other participants of the competition, noting that advocacy requires preparation and unshakable confidence, as this will prove to the judge and court that the counsel knows what he or she is trying to achieve.

In her remarks, the Solicitor-General and Permanent Secretary, Ms. Titilayo Shittabey, stated that it is not uncommon to not be fully prepared before coming to the court, stressing that 9 0 % of case preparation happens in the chambers.

"I understand that some of us have so

many cases to deal with daily, but it is imperative for us to always make time to be 70% prepared at least before appearing in court", she added. The participants expressed the unique opportunity the moot court presented in

opportunity the moot court presented in "creating the interface involving the judge, defense counsel, prosecutors and investigators.

Equally, the session encouraged the exchange and development of constructive ideas and suggestions for addressing some of the key practical challenges relating to civil matters.

Standardising Commodity Export: Lagos Govt Agrees To Work With CIECOBON

Commissioner for Commerce, Industry and Cooperatives, Dr. (Mrs.) Lola Akande stated this when she received the representatives of the Institute, led by its President, Dr. Ayobami Omotosho at the Ministry recently.

Represented by the Permanent Secretary, Mrs. Adetutu Ososanya, FCA, Akande stated that, regulating export processes is a laudable initiative and the Ministry is willing to work with CIECOBON to discuss strategies on how to simplify and standardise the exportation of commodities in Nigeria for the benefit of

entrepreneurs, the State and the Country.

Her words: "I see that the project will allow for the promotion of commodities of our MSMEs and it will encourage them to step up production when they see patronage. The Ministry is committed to promoting exports and ensuring that the process is simple and regulated. We are also working closely with relevant stakeholders to create an enabling environment for exporters to thrive in Nigeria".

She reiterated that entrepreneurs can increase their production and profit while the nation can record high foreign exchange earnings when the exportation of commodities is standardised in line with the expectations of the destination countries, saying Nigeria is losing so much revenue to neighbouring countries due to her inability to regulate and ensure that the nation's products meet export standard.

"The Ministry will make recommendations to the Government. We will set the ball rolling and we will put out a bill of proposal to Mr. Governor", she said.

President of the Chartered Institute of Export and Commodities Brokers of Nigeria (CIECOBON) Dr. Ayobami Omotosho emphasised the need for a robust regulatory framework that will streamline and enable exporters to easily navigate the export process and promote the commodities of the MSMEs, just as he highlighted the importance of building the capacity of exporters and providing them with access to finance and markets.

While expressing gratitude for the platform provided to them to make the proposal, Omotosho and his team presented a couple of items that

were locally made in Nigeria to buttress their proposal.

A member of the Team, Mr. Adewale Fosudo stressed the need for collaboration among stakeholders and the importance of promoting value addition in the export of commodities. "The Ministry can form a Committee to hold a technical meeting on how to do things in the Private Sector way and this Committee can then make a proposal to the State Government". he said.

They also agreed to work together to address the challenges facing exporters in Nigeria and ensure that the export processes are simplified and regulated for the benefit of all.

Heaps of Wastes: Lagos Seeks Huge Wealth From Dumpsites

billion being lost economy annually, the Lagos State Government is set to turn its wastes to wealth and it is not leaving any stone unturned to realise this.

A new visitor to Lagos sees Olusosun dumpsite as heaps of wastes but Lagos government sees it as heaps of wastes, which in the nearest future should add to the state's Internally Generated Income, that stands at N50 billion monthly at present.

Successive administrations in the state had failed to convert wastes to wealth due to so many reasons, including lack of local and foreign investors with modern technology in circular economy.

However, the present administration of Mr. Babajide Sanwo-Olu is poised in making good money from wastes as he prepares to begin his second term on May 29.

A few days ago, the Lagos State Government held a stakeholders workshop to review the preliminary report on gaps and needs assessment for Suggestions and recommendations towards moving the waste management process to circularity.

Speaking during the Stakeholders meeting held at the LCCI building, Alausa, the Permanent Secretary, Office of Environmental Services, Omobolaji Tajudeen said the meeting was aimed at facilitating the implementation of prioritized high impact actions towards achieving the goals of the Lagos Climate Action Plan.

He stressed that it had been proved that Lagos generates over 13,000 Tonnes per day of Municipal Solid Waste (MSW) which amounts to over 4.5 TPA (Tonnes Per Day) with a high greenhouse gas emission rate.

He added that the amount of waste generated has

demanded a concerted effort on the part of the State government and the citizens to effectively manage waste as well as convert and recycle these waste to other useful resources.

Gaji said the report of the gaps and needs assessment undertaken by an environmental consultant will be laid bare at the workshop for discussion and suggestions in order to improve the waste management system in the

"It is my expectation that this assessment will assist the State Government to successfully achieve a diversion of organic waste from landfill, create jobs from recyclables and also reduce the Greenhouse gas emission from the current 25% to lower percentage ratio, He said.

While thanking partners from C40 Cities for facilitation of Technical assistance through the Climate Action Implementation (CAI) Africa Programme, Gaji said the initiative would come handy in developing the states capacity to effectively implement the Lagos Climate Action Plan.

He urged all participants to actively share their insights and experiences adding that it was only through collaborative effort that innovative solutions to address the gaps in our waste management system can be achieved.

Recall that a study by World Bank shows that Lagos State loses \$7 billion annually for not recycling its waste, especially the plastic wastes generated cross the metropolis.

Our correspondent observed that individuals now visit dumpsites across the states to pick plastic bottles, pack it and transport out of Lagos. At Kara on Lagos-Ibadan Expressway, our correspondent observed loads of plastic bottles picked by people, mostly northerners to be transported out of Lagos.

Some of them who spoke to our correspondent said that they bought it from dustmen who scavenge the dumpsites to pick the bottles.

It was gathered that may of these plastic bottles were sold to some recycle factories outside Lagos. The plastic bottles are recycled to nylons by most factories. Reacting to the plans of Lagos to go fully into circular economy and also regulate the movement of plastic wastes in the state, the General Manager, Lagos

State Environmental

Protection Agency

(LASEPA), Dr. Dolapo

Fasawe said that the agency

recently had a one-day workshop on circular economy organised in collaboration with United Nations Industrial Development Organisation (UNIDO, the Federal government and other organised private sectors.

According to her, circular economy is the type of economy in which wastes are recycled and turned to

She said that Nigeria by 2025 will be the largest producer of plastic waste, therefore, there is an urgent need to step up the activities in recycling and practicing a circular economy. "Once the plastic is used, it should not just be deposited anywhere. It can be reused, recycled, rethought and reduced to something else because plastic is not degradable". She said "And when we say

economic and plastic, it means that there's a lot of money that can be made out of plastic waste. A study done by the World Bank a few years ago shows that the cost of not practicing a circular economy in plastic waste is about 7 billion dollars just for Lagos State. We are losing 7 billion dollars annually; and the essence of this workshop is to invite investors to join us in this advocacy for recycling, reusing and creating industries, job

opportunities and more importantly a cleaner environment. You will not see these plastics on the road again if we put this approach of the circular economy on plastic waste". In the light of this, Fasawe announced that the state would be partnering with the United Nations Industrial Development Organisation (UNIDO) to advocate and deepen the value chain in the circular economy.

She stated that the workshop was designed to broaden the knowledge of the participants and stakeholders about the economic benefits of adopting friendly lifestyles as well as a holistic approach towards achieving the goals of a circular economy.

The UNIDO National Programme Coordinator, Mr. Oluyomi Banjo, disclosed that UNIDO was pleased to work and achieve a circular economy in Lagos, adding that this would set the stage for other states in Nigeria as well as other regions in Africa.

He declared that to achieve the aim of the project, Lagos state would be developing its action plan on the circular economy of plastics in Nigeria and also embark on some activities with UNIDO and other relevant stakeholders.

"We will bring everybody together to sensitise them on what circular economy is about; the benefits of a circular economy for the environment, socially and economically. The private sector would be encouraged to be more productive and efficient to make more profit. We will also look at the informal sector to see how we can incorporate them in achieving this, knowing that we cannot achieve this without the informal sector", Banjo said.

Also speaking at the event, the Managing Director/Chief Executive Officer (CEO) of LAWMA, Mr. Ibrahim Odumboni, reaffirmed the commitment of the government to promoting the reuse and recycling of plastics in the State.

Odumboni said that LAWMA was partnering with Polysmart, one of the largest plastic recyclers in Africa on converting many tonnes of plastic waste in the state to reusable products.

According to him, the authority is enforcing its adopt-a-bin policy to inculcate the value of waste separation at the source.

He also hinted that LASEPA, LAWMA and some other agencies of government had banned the use of single-use plastics in their offices to lead by example.

Building Collapse: Lagos, Professionals Wage Fresh War Against Criminal Developers

ecords have shown that approximately only 15 per cent of the building constructions going on in Lagos have government approval and that only five of the 15 per cent conform with the approved plans.

The immediate past Chairman of the Nigerian Institute of Town Planners, Lagos Branch TP Ayo Adejumo revealed this, adding that this has contributed greatly to the incessant collapse of buildings in the state. Corroborating Adejumo, the Public Relations Officer of the Lagos State Chapter of the Nigeria Institute of Builders Godfrey Chukwurah said that 80 per cent of Lagos building projects lack approval.

This may sound unbelievable, it is true and it is due to the

compromise of some government officials and the flagrant breaking of the law by developers themselves, a c c o r d i n g t o investigation by EchoNews.

Our correspondent who was at the two sites where building recently collapsed observed that many developers break government's order to continue with their building projects because they have the backing of some government officials.

At Apapa where a three-storey building collapsed, it was discovered that the developers actually breached government regulation. The developer, according to Mr. Mukaila Sanusi, Deputy Director, Public Affairs, Lagos State Building Control Agency, LASBCA was served a seal up orders but the order was ignored.

Sanusi said that the

developer continued with the project behind the scene. He said, " The collapse incident, which was flagged on the Physical Planning incident management platform on Sunday evening, triggered immediate preliminary enquiries that showed that officers of the States Building Control Agency had issued a number contravention notices, stop work and seal up orders which the developer ignored and carried on construction without any recourse, whatsoever, to the authorities.

Also, the Permanent Secretary, Lagos State E m e r g e n c y Management Agency, D r. F e m i O k e - Osanyintolu said that the property had earlier been served the CN, STW & Seal Up Notices accordingly but the developer ignored the order.

According to him the

ongoing construction only had Provisional Development Permit of a Two (2) floor structure but went ahead to build three-storey structure.

LASEMA also observed that the developer failed to stage its authorization and building permit by LASBCA.

However, the former NITP Chairman, TP Adejumo would not totally agree with the government that it did not know that the developer had ignored the seal order.

He said that his institute had noticed that some unscrupulous developers break government laws arbitrarily, adding that this cannot be possible without some civil servants compromising the laws.

Adejumo lamented that many members of NITP had been attacked by developers at various sites across the state for standing against erection of illegal structures and that the reports had since been sent to the governor's office.

" W e engage government agencies in charge of Physical planning and development control and submission of papers on how to reduce the menace. We also educate and sensitize our members that are working for government to always obey all rules to the letter and do a lot of public enlightenment programmes such as town hall meetings, visits to markets, places of worship and schools to always alert government of any distressed building. We have a yoruba weekly radio program we run on Trafic Radio for about 3yrs now....on town planning and related matters," he said.

To Lagos State

Governor, Mr. Babajide Sanwo-Olu, no government official that is involved in the incident of building collapse will be spared over incidents of building collapse across the state, including the illegal structures at Banana Island in Ikoyi area of the State.

Governor Sanwo-Olu blamed the collapse of the recent seven-storey building on First Avenue, Banana Island on 'reckless' operations of some developers hiding under the pretense that Federal Government agencies had issued approvals to hood wink unsuspecting property owners.

He said his administration will no longer tolerate the activities of greedy developers who reclaim land from water illegally in connivance with some government agencies.

He had since ordered the immediate demolition and sealing of many completed and uncompleted buildings with various building infractions and those that were not granted appropriate approvals for construction by a gencies of government.

The Governor's order was carried out immediately by officials of the Lagos State Building Control Agency, who immediately marked the affected buildings for demolition.

Speaking specifically on the Banana Island building collapse the governor said: "A lot of investigation is going on right now and you can see that they are still clearing the rubbles at the site. We have given the order to stop work, not only at this site but also at all of the construction sites in Banana Island.

sites in Banana Island. "You have all seen the extent of what I will call an unapproved extension into the water. You can see that the original line for Banana Island is even not where we are. It is way in front there and you can see that several extensions have been granted by both the Federal Ministry of Work and Housing and the National Inland Waterways Authority (NIWA). These are the two federal agencies that have been culpable for those extensions.

"They have done these extensions even without our knowledge. We have the responsibility for building approvals and from what I have been told, all of the four buildings around the collapsed building never applied for approval.

"This is total recklessness of the developers and we will make a strong point out of this place and all around Banana Island. Any officers found culpable will also be sanctioned."

Governor Sanwo-Olu stressed further that "It is heartbreaking each time we have to go through this and it shows sometimes how irresponsible those developers and some of our citizens that just want to make quick money are. And of course, our officers who are also not alive to their responsibilities.

"We have had to change staff here and there so that we can bring forward robust and very strong monitoring officers. We will continue to do what we need to do to ensure that we keep the lives of our residents safe at all times."

Governor Sanwo-Olu disclosed that an

external seven-man committee has been set up by Lagos State Government to independently ascertain the remote cause of the incident, saying that the committee will come up with a robust work plan that can be enforced going forward.

"We have set up an external seven-man committee. We are giving the people two weeks to independently ascertain what has gone wrong there. They should finish their work maybe towards the end of next week or thereafter.

"This will also further strengthen us to also come up with a robust work plan that we can enforce going forward," he said.

This particular incident, like similar others, reinforces governments repeated calls for responsible behaviour on the part of all stakeholders in the built environment.

Lagos State Government has immediately activated inquiries into the collapse to unravel the minute details and guide appropriate actions.

Meanwhile, the state Building Control Agency has started the demolition of illegal structures in Banana Island, Ikoyi.

Lagos Govt Resolves To Complete All Infrastructural Projects

he Lagos State Government has reiterated its commitment to the completion and delivery of existing and ongoing infrastructural projects and ensuring that the contractual procedures are adhered to in project execution.



Akinpelu said the clearance operation was duly authorised to dislodge traders who have completely taken over the walkway opposite the market State Government after repeated warnings.

The Corps Marshal said the female trader was only trying to whip up sentiments to stop the officials from carrying out their duties with the false allegations.

According to her, an investigation into the claim had revealed that the said woman was notorious for constituting a nuisance the vice chairman of

"The recalcitrant street trader and several others flouted the Lagos Environmental Management Protection Law by erecting a wooden kiosk with the intent to display raw foodstuffs for sale on the walkway at Oyingbo, thereby impeding vehicular and human movement in the area.

"As the premier environmental enforcement Agency set up by the Lagos under the Ministry of Environment to rid the State of environmental nuisances in response to complaints from motorists and pedestrians, we are committed to enforcing the State's law by dislodging illegal street traders."



"Again in 2016, I was close to the job, I was to get the job with the local coach Salisu Yusuf, but they chose Paul Le Guen for the

"He refused and it would have been normal that I would have been there with Yusuf.

"I considered myself as the second or third choice, but it was Amaju Pinnick who didn't follow the Technical Committee decision and went for Gernot Rohr, who was not shortlisted; it was a big disappointment."

The experienced gaffer added despite getting a lucrative offer in Bangladesh but the ambition to coach the Eagles was always top of his agenda.

"Then I went to Bangladesh and got a lucrative offer for a short term, but the ambition was always there to coach Nigeria and guide them to a successful AFCON and also guide them to World Cup success."

Mustapha further stated that he has no ambition for the chairmanship position and urged his supporters to focus on other positions at the federal and state levels.


He also cautioned the general public to ignore any information from such fake online platforms and campaigners as they are all baseless.



"Emzor never wrote to me regarding the road. God forbid that I demand money from someone trying to carry out a good cause."

Olasoju reveals that rehabilitation of the road has already started.

"Our engineers are working. I can't tell vou when the work will commence because if I tell you that it will commence tomorrow and it fails, it means I'm lying; the engineers are working on it, and we want to make it a lasting solution. I may give you a date and it will fail.

"There is no functional drainage from the Five Star Bus Stop to the Aswani junction. So, we are working on it. We have written to the state government and I am sure that our governor, Babajide Sanwo-Olu, is a

listening governor.

"You can go to Isolo and verify, we are a listening government, and we are very proactive. We have done roads in one and half years, and the road we are talking about is a state road, but we are only trying to make life easier for our people," he stated.


