





"On behalf of my family, the government, and the people of Lagos State, I congratulate our Amazon, Justice Kudirat Kekere-Ekun, on her appointment as the Acting Chief Justice of Nigeria. The emergence of a Lagos indigene, Justice Kudirat Kekere-Ekun, as the second female Chief Justice of Nigeria is a thing of joy to us, and we are happy to associate with her. faithful and loyal to the constitution when discharging your duty as the acting Chief Justice of Nigeria. I also encourage you to defend the judiciary's independence and always promote the cause of justice. It is vital that you strengthen all mechanisms for integrity, discipline, and




transparency in the judicial sector, and pursue other reforms or initiatives to sustain and build public confidence in the judiciary," the President stated.

Speaking to the media after the swearing-in, the acting Chief Justice of Nigeria pledged to elevate the judiciary to new heights, improve its reputation, and sustain public confidence in the judicial system.

" We will make sure that people have more confidence in the judiciary, and I believe that it is not a one-man job. We all have to be on board because we all see the areas that are in need of improvement. I believe that there will be maximum cooperation because we all want to see a better judiciary. A better judiciary is for the benefit of the entire nation. Whatever the shortcomings that we see today are, we are all members of the society so, if we want to see a better society, if we want to see improvement, let the improvement start with each and every one of us and our approach to justice. Let us all have faith in the system and then also be particular about the process of appointment, I know it is a source of a lot of concern; the issue of discipline on the bench and at the bar as well."

All of these things are aspects that we will look into and I believe that by the grace of God, at the end of my tenure, we should be able to have a judiciary that we will all be proud of," she said.



# Kekere-Ekun: A Trajectory From Magistrate To Supreme Court

aving passed through legal education like many others, the current Acting Chief Justice of Nigeria, Hon. Justice Kudirat Motonmori Olatokunbo Kekere-Ekun began her career as a senior magistrate Grade II, Lagos, in December 1989 and rose to become a high court judge in July 1996.

With over 30 years in the judicial service, Kekere-Ekun rose through the system, building capacity through every phase of her career to what would become her zenith in the Nigerian judicial space on Friday August 23, 2024 when she was sworn in as the 23rd Chief Justice of Nigeria.

As a high court judge, she served as chairperson of the Robbery and Firearms Tribunal, Zone II, Ikeja, from November 1996 to May 1999.(Daudu(

She was then promoted to the court of appeals in September 2004 and served as a member of its ICT committee between 2011 and

2013.

In 2013, Kekere-Ekun, fondly called Young Toks, was appointed a Supreme Court justice. She is the fifth and youngest female to be appointed as a justice of the Supreme Court of Nigeria.

Kekere-Ekun is the second female to emerge as CJN in Nigeria after Aloma Mukhtar, who held the position between July 2012 and November 2014. Interestingly, it was Mukhtar who swore in Kekere-Ekun as a supreme court justice in 2013.

# ekere-Ekun read the ruling in the controversial case between Emeka Ihedioha and Hope Uzodinma in the Imo State governorship election in 2020.

Most observers have described as the most controversial judgement in Nigeria's post-independence history, however, trails Kekere-Ekun's profile.

The Imo state governorship election case, a watershed moment in Nigerian politics, saw her deliver a verdict that would put the legal system to the test and set precedence for future rulings.

Kekere-Ekun read the supreme court judgement in the January 2020 verdict that sacked Emeka Ihedioha and proclaimed Hope Uzodinma as lawful Imo state governor, based on claims that results from 388 polling units where Uzodinma led were not included in the original results.

Uzodinma, who came a distant fourth position in the result announced by the Independent National Electoral Commission

She was also among the judges who sat on the hijab (head cover) controversy between the Lagos state government & others v. Asiyat Abdulkareem. The apex court overruled Lagos on its restriction of the use of hijab by female Muslim students of public schools in the state.

Speaking about her quality, a senior advocate, Jospeh Daudu said that Kekere-Ekun is eminently trained and has occupied great positions that only a few female had occupied, which shows that gender was never her barrier.

He said, "Going by her track records and leadership in the administration of magistrate, high court, appeal court and supreme court and now in the big shoes as the CJN, we can always pray for her to succeed."

To another senior advocate, Mr. Kunle Adegoke, Justice Kudirat Kekere-Ekun is a disciplinarian. She is disciplined in every respect. She is not frivolous in any way. She is apolitical. In other words, she is not a politician. She is free of political encumbrance or baggage. Because she is free of that political garbage, she is going to be very professional. I can assure you. She will be

Hon. Justice Kudirat Motonmori Olatokunbo Kekere-Ekun was born on May 7, 1958 in London, United Kingdom. she is the eldest of eleven siblings in a polygamous home. Her father, Hassan Adisa Babatunde Fasinro, was also a lawyer and politician, while her mother, Winifred Layiwola Ogundimu (née Savage),

is a UK-trained nurse. Fasinro, popularly called HAB, was a senator representing Lagos in the second republic and the first clerk of the Lagos City Council. Having a father who is a lawyer may have influenced Kekere-Ekun's passion for the legal profession.

She commenced her secondary education in 1970 at Queens College, Lagos, and studied law at the University of Lagos from 1977 to 1980. She then proceeded to the Nigerian Law School and

was called to the bar in July 1981. After that, she underwent the compulsory National Youth Service Corps (NYSC) from 1981–82 at the ministry of justice in Benin City, Edo (then Bendel state).

Upon completing her service year, she proceeded to the London School of Economics and Political Science (LSE), obtaining a master's degree in law in 1983.

While charging the participants to maximise the training seminar organised by her office to support them through the competition, she enthused that constituted monitoring

teams would visit their gardens periodically to a s c e r t a i n t h e progression process of their crops

Earlier in his remarks, the Commissioner for Information and Strategy, Mr. Gbenga Omotoso lauded the initiative as he opined that it will encourage residents to embrace home gardens. Omotoso revealed that some participants were disqualified due to their inability to provide their LASRRA Identification Number, which calls for residents yet to register to do the needful.

While enlightening the participants on the importance of the LASRRA registration and all-purpose card, Omotoso pointed out that the Government, throughthis registration, acquired comprehensive data of residents across the

State, in a bid to provide various amenities for citizens. In his words, "Lagos is

### New Engagement Channels Record High Feedback-Afolabi

he Special Adviser to the Lagos State Governor on Political, Legislative and Civic Engagement, Dr. Tajudeen Abiodun Afolabi has revealed that the recently launched new engagement channels by the present administration, aimed at enhancing communication between the State Government and Residents, are recording a significant volume of feedback from Lagosians.

# Lagos Resumes "Alaafia Eko" Medical Outreach

#### ... As Sanwo-Olu's Free Health Initiative Receives Praise from Beneficiaries

he Lagos State Government has successfully resumed the second phase of its free medical outreach, known as "Alaafia Eko", across 12 designated centres spread over the six health districts of the state. The initiative, which was temporarily halted due to the cholera outbreak that has now been contained, witnessed an overwhelming turnout of elated residents eager to access a wide range of medical services.

The outreach aims to provide free healthcare to residents, offering services such as blood pressure and blood sugar checks, HIV counselling and testing, eye examinations, and distributing free medications and eyeglasses. Additionally, attendees received free consultations, treatment for basic ailments, and registration for the llera Eko health insurance scheme.

The second phase of the programme was officially flagged off at the Old Nursing School Complex in Ikoyi-Obalende LCDA and the Surulere Local Government Secretariat. Dignitaries present at the ceremony included the Special Adviser to the Governor on Health, Dr. (Mrs) Kemi Ogunyemi, and the Permanent Secretary of the Lagos State Ministry of Health, Dr. Olusegun Ogboye.

They were accompanied on the tour of the Ikoyi-Obalende site by the Permanent Secretary, Lagos State Health District III, Dr. Monsurat Adeleke and the Permanent Secretary of the Lagos State Health Management Agency (LASHMA), Dr. Emmanuella Zamba. Meanwhile, the tour of the Surulere site saw the presence of the Permanent Secretary of Lagos State Health District IV, Dr. Abimbola Bowale and the Chairman of Surulere Local Government Hon.

Speaking during the visit, Dr. Ogunyemi highlighted the economic challenges faced by residents, which have made healthcare increasingly unaffordable. She emphasised that the "Alaafia Eko" initiative, under the state's "Eko Cares" programme, was designed to address these challenges by providing free healthcare services to all residents. "We believe prevention is better than cure to underscore the importance of early detection and treatment", she said.

According to her, the outreach is strategically spread across all six health districts to ensure maximum reach, stressing the importance of residents registering for the llera Eko health insurance scheme, which is crucial for continued access to affordable healthcare services beyond the outreach.

At the Surulere site, Dr. Ogunyemi expressed her satisfaction with the turnout, noting that over 700 people had already registered by the time of their arrival. She

commended the local government for its proactive efforts in adding Tuberculosis (TB) and Human Papillomavirus (HPV) screenings to the services offered, further enhancing the outreach's impact.

Dr. Ogboye, in his remarks at the Ikoyi-Obalende site, added that the outreach serves as a vital opportunity to enrol more residents in the Ilera Eko scheme. He praised the logistical efforts involved in organising such a largescale programme, noting that the first phase had successfully reached over 24,000 residents, and the second phase aims to reach an additional 12,000.

Permanent Secretary of Health District III, Dr. Monsurat Adeleke emphasised the outreach's role in promoting health-seeking behaviour among Lagos residents. She pointed out that despite the state having 329 Primary Health Centres (PHCs), many residents still prefer visiting General Hospitals. The "Alaafia Eko" initiative aims to reverse this trend by bringing healthcare

closer to the people.

Permanent Secretary of Health District IV, Dr. Abimbola Bowale echoed similar sentiments during his visit to the Surulere site. He noted that the overwhelming response from residents demonstrated the importance of the outreach and the need for continued government support in healthcare provision.

Chairman of Surulere Local Government, Hon. Sulaiman Yusuf expressed his gratitude to the state government, noting that the initiative had greatly benefited the people of Surulere. He highlighted the importance of health to the well-being of the community and expressed hope that the outreach would continue to be a regular feature in the state's healthcare agenda.

Meanwhile, Lagos State Governor, Babajide Sanwo-Olu, has been lauded by residents for this free medical outreach initiative. At the Ikoyi-Obalende screening site, several beneficiaries expressed their gratitude and satisfaction with the services received.

The testimonials from the beneficiaries highlight the positive impact of the free medical screening initiative, underscoring the state government's commitment to providing quality healthcare services to all Lagosians, especially those in economically

disadvantaged areas.

As the second phase of the "Alaafia Eko" outreach draws to a close, the state government is already considering future rounds, based on the data collected and the feedback received from residents. # Global Fund Boosts Lagos Healthcare With Five MICU Ambulances

... As LASG Restates Commitment to Swift Medical Emergency Response



he Lagos State Government has received five brand new state-of-theart Mobile Intensive Care Unit (MICU) ambulances from the international donor organisation, Global Fund, to enhance swift medical emergency response in the state.

The multi-million naira MICU Ambulances. donated to the Lagos State Ambulance Service (LASAMBUS), are equipped with essential medical and emergency equipment, including a main ambulance stretcher, trauma kit, patient monitor, automated external defibrillator, respiratory kit, dressing equipment, wheelchair,

among other items required to stabilise and support patients before further medical intervention.

The Ambulances were received on behalf of the Lagos State Government by the Special Adviser to the Governor on Health, Dr. (Mrs.) Kemi Ogunyemi, the Permanent Secretary, Lagos State Ministry of Health, Dr. Olusegun Ogboye, and the Director LASAMBUS, Mrs. Wuraola Makinde. The handover was conducted by the Coordinator of the Global Fund Grant Management Unit, Mr. Abiodun Omoloja.

After receiving the Ambulances, the Special Adviser to the Governor on Health, Dr. (Mrs.) Ogunyemi appreciated Global Fund for its productive partnership with the state government in providing effective emergency services and sustaining healthcare delivery in the state.

She explained that the five new ambulances would expand the coverage area of LASAMBUS, supporting the State Government's efforts to overhaul and strengthen trauma and medical emergency response systems.

According to her, the overarching goal is to transform LASAMBUS to meet global benchmark standards, with more staff, equipment, ambulance bases, and points to reduce emergency response time in the state.

"We are training more doctors and nurses and acquiring more equipment because we believe that emergency services represent the critical point between life and death. When accidents or emergencies occur, we need fully equipped, skilled professionals on-site", she said.

Reiterating the government's commitment to providing prompt emergency services, Dr. Ogunvemi assured that the newly donated ambulances would be utilised effectively for service delivery.

Echoing her sentiments, the Permanent Secretary, Lagos State Ministry of Health, Dr. Olusegun Ogboye emphasised LASAMBUS's dedication to providing swift and professional emergency services, ensuring that residents can rely on prompt care when needed.

"We are committed to ensuring that we provide emergency services with a dedicated team of highly trained professionals. All of them are certified for ACLS, and these MICUs allow pre-hospital interventions, ensuring that patients receive excellent care while being transported", he said.

Dr. Ogboye also revealed

plans to build ambulance bases across all Local Government Areas in the State, hinting that the Ministry of Health is currently in negotiations with Local Government Chairmen to secure spaces for these bases. "The aim is to ensure that Ambulance and Emergency services are accessible within the shortest possible time", he stated.

Earlier, Head of the Global Fund Grant Management Unit in Lagos, Mr. Abiodun Omoloja highlighted Global Fund's commitment to defeating HIV, Tuberculosis (TB), and Malaria, while also ensuring a healthier, safer and more equitable future for all. While noting that the donation of the Ambulances is part of the Global Fund's initiative to strengthen health systems in Lagos State, Omoloja disclosed that the five MICU Ambulances are in addition to the eight MICU Ambulances earlier donated to the Lagos State Ambulance Service in 2022, bringing the total number of MICU Ambulances donated by the Global Fund to 13.

Omoloja explained that the Global Fund saw the need to further strengthen LASAMBUS' emergency response by providing additional ambulances, particularly because of the excellent management of the eight Ambulances earlier donated.

"These donations align with Mr. Governor's THEMES Plus agenda, supporting the provision of highquality pre-hospital and medical emergency services. The expanded LASAMBUS fleet will enhance operational coverage, contributing to significant improvements in the State's health indices", he said.






