Excel College:JSS3, SSS3 resume tomorrow, others Oct 19

■inal year junior and senior students of troubled Excel College will resume tomorrow Tuesday as the management begins building temporary classes to accomodate 492 students expected to resume on Monday, October 19, this year.

To ease ongoing examinations of science subjects, the school has struck a deal with neighbouring Ronik College to share laboratory facilities while other papers will be taken at a building formerly used for boarding if the National Examinations Council approve. The management announced these measures last Saturday at a meeting with parents on its building that collapsed Saturday September 19, this year.

To replace the collapsed structure, the school is waiting for the results of on-going investigations by the Lagos State Ministry of Physical Planing whose officials have taken away samples that may explain why the building fell.

The measures were backed by the parents, who in a sympathetic show of solidarity resolved to tax themselves to support the management's revival plan.

The director, Dr.Dele Oke told Echonews the measures were more buses for transport."

taken to avoid putting parents through the ordeal of searching for new schools for wards midway into the school year and throwing 77 teaching and administrative staff into the pool of jobless citizens.

He said teaching and learning would be done online following the school curricula with well prepared time tables during the three-week period.

He said: "I thank the staff and all parents. The first day it happened I cried, when the commissioner spoke to us again I cried. We are pleading for a little bit of patience and in three weeks time by God's grace, we should have all the children back to school.

"Another thing I want to promise is that our temporary structure will present a better learning experience and the students will be able to sit well. Our founder already said that we are going to be using audiovisuals full time and as God will have it, last year we completed our computer acquisition skill for all our teachers, so all teachers in the school have laptops.

"All teachers are also told that after each class, all students notes should be dropped at the school portal and any student that does not complete his or her note will be known through the portal. We are also trying to get

On how soon the reconstruction of the school would be. Oke said they were working on it, stating that the school is ready to partner with the government and private organisation to raise the funds to rebuild the school. Debunking the allegations of a few ex-students that the building had been shaking for a long time, t h e proprietress, Mrs. K. Oke explained that holopot was used in constructing each floor adding that the foundation and all materials used in building the school were certified by the government.

Narrating her experience, Mrs. Oke who retired from the Lagos State Civil Service 25 years ago, said: "It was not expected. We were all in school on Wednesday because we come to school every day to plan for the resumption of the students. We had a meeting in the school on Thursday. It was on Friday we noticed cracks on the wall. Then, the Director sent a message to the parents immediately that the resumption would be rescheduled due to the crack noticed on the wall because the parents were to initially bring their children to school on Sunday to resume on Monday last week.

"We invited building engineers immediately that Friday, they came and promised to come back on Saturday to assess what could have caused the crack. The Director also called another structural engineer who also promised to come on the same Saturday. The three people who came on Saturday entered but were directed by divine sprit to come out of the building. It was not later than five minutes after they came out that the building collapsed. So, God was really on our side to have saved every soul who might have been inside the building.

"That building was supposed to be for commercial activities but through prayer, I was directed to use it for school and that was

why we converted it to school so, the foundation and the structure were solid.

"When the incident happened, the Lagos State Commissioner for Physical Planning and Urban Development, Dr. Idris Salako came here and took sample of the wall for test. They have also carried out integrity test on the other buildings used for the boarders as the governor ordered that every 3-storey building in this community be subjected to integrity test. I really appreciate the community, the parents and all others who stood by us. We shall come back better by His grace."

Speaking on the association's effort to get the school back, the PTA chairman, Mr. Ndubuisi Udeagu said they have been planning and working along with the management, giving them moral and logistic support.

Based on the good standards and quality education provided by the school as testified to by some parents, Udeagu urged the parents not to lose focus, appealing to them to retain their children in the school.

"What we have is a collapsed building, the knowledge, quality and standard of education in Excel College has not collapsed rather, the school is bringing new ideas and innovation to teaching," he sai

But punching holes in this narrative, Alhaji Femi Olowu who chairs the NURTW in Ejigbo The incident, which occurred on LCDA said none of the union's workers was at the scene when the incident happened.

> Olowu, who wondered why the hit and run driver was not arrested when he committed the offence by the security officer

presentsaid it has been difficult to investigate the identity of the culprit because no one has come up with the name of the driver or the number of the vehicle.

"At that point where the accident occurred, no union worker could have been there collecting money. If truly it was a union member chasing the driver, some people would identify the union member and would have told us. The accident happened in the day time not in the night. We don't condone any act of indiscipline in the union.

The person who confirmed the accident to me said she could not ascertain the number plate nor identify the driver. She explained that the bus came out from Mechanic village and sped off to take one way. The reason for taking one way by the driver is still not known as we always warn our members and the drivers against taking one way. It is hard for us to search for the escaped driver since we don't have any hint on his identity but we are on the look out for him and gathering information about him as instructed by the police," he explained.

Meanwhile, the Ejigbo DPO CSP Olabisi Okuwobi told ECHONEWS that she and her team have commenced manhunt for the fleeing driver, promising that he shall be brought to book.

olice operatives of Ejigbo Police Divisional Station have arrested 18-year old boy Pelumi Oloyide for, allegedly,raping a 15-year old girl.ECHONEWS gathered that the incident happened at an undisclosed hotel at Jakande Estate, Ejigbo. The suspect, who resides at Uriel Adegbenro Street, Egan area of Igando, was said to have gone to the victim's house in llepo area of Ejigbo to install a prepaid meter.He later took advantage of the victim when she went to get the code number of the meter at Jakande Estate. According to the police, Oloyide lured her into a hotel, drugged her drink and then raped her. "The girl slept off and when she woke up, she discovered that she was raped. She then informed her parents about what had happened to her. "The matter was reported to the Police at Ejigbo Division and the DPO, CSP Olabisi Okuwobi, ordered for the arrest of the suspect. He was eventually tracked and arrested at Igando.During interrogation, the suspect admitted that he actually drugged and raped the victim but was done under the influence of drugs. He revealed that he took 400mg of Tramodol everyday without the knowledge of his parents. He pleaded for forgiveness but the police source said he would be charged to court for the alleged offence.

PTA urges LASUBEB to speed up school fence repair

he Parents Teachers Association (PTA) of Kusoru Primary School, Ilasamaja has appealed to the Lagos State Universal Basic Education Board (LASUBEB) to hasten the re-building of the school's broken fences to make the environment conducive for learning.

The chairperson, Mrs. Rose Umukoro, made the appeal to adequately prepare the school for resumption.

Umukoro, who noted that the repair has been unduly delayed, emphasised that it is necessary to guarantee the safety of the pupils especially the new intakes who have been registered

ECHONEWS reported earlier this month that the Education Secretary (ES), Oshodi-Isolo Local Government Area, Barr. Femi Ogunwusi confirmed the awareness of LASUBEB about the collapsed fences of the complex that houses Kusoru Primary School and other three

schools, revealing the plans by the Board to rebuild the fences before school resumption.

The fences were damaged by the heavy rains in February and July this year.

Meanwhile, ECHONEWS gathered that due to its current state, persons suspected to be hoodlums have turned the school to venue for meetings. Besides. some residents dispose and burn their refuse

When our correspondent visited the school during the weekend,

there was no sign of preparation for resumption as the fallen fences had not been mended while the premises was bushy. Commenting on the situation of the school, Umukoro said: "We want SUBEB and the authority of Isolo Local Council Development Area (LCDA) to come to our aid and see what can be done to make the school environment secure and safe for the pupils as they resume soon. "The grasses have over grown, the broken fences have exposed the school to unimaginable

security threats. As the PTA we would have taken all these upon ourselves but most of us are financially constrained as many households are still trying to make headway from the adverse effect of the pandemic on our means of livelihood.

"The PTA has been so impactful in the school on several occasions. Prior to the pandemic, I took it upon myself to wash the school toilets but this time around we need more than the cleaning of toilets to make the school and its premises

more conducive ahead of resumption. No hand washing equipment is available for the pupils, the school compound is yet to be fumigated and also the fallen fences are yet to be rebuilt

"The children's lives will be at stake without the fences being mended and other needful being put in place. We hope the Board hears our voice through this medium and speeds up its plan while the council complements the efforts. "

How OPC tamed 'one million boys' in Isolo - Sotomakanaki

of the commandants of Aare Gani Adams' faction of Oodua People's Congress (OPC) in Isolo Local Council Development Area (LCDA), Saheed Orulebaja popularly known as Sotomakanaki, has explained how the security outfit played an important role in tackling the invasion of the infamous group known as "One million Boys" during the lockdown.

Orulebaja disclosed that OPC apprehended not less than seven suspected members of the cult groups in the community through full surveillance, working with the police of Isolo Divisional Police Station.

He said after conquering the group, the security body still sustains its surveillance in the community to ensure peace in the local council area at all

He listed other efforts of the security outfit in keeping the community peace to include the arrest of members of another dreaded cult groups such as 'One minute Boys' and Eiye fraternities terrorising the community.

He recalled how the two cult

groups engaged in supremacy rival clash early this year, inflicting injuries on the residents and vandalising properties including the Chief Imam's car.

"We intervened in the clash and apprehended the alleged cult members and handed them over to the police.

"During the time of the 'one

million boys' we were proactive in our preparation having heard about their activities in other areas about how they formalised their invasion by writing letters to announce their coming and all that. We were summoned to a meeting by the Osolo of Isolo, Oba Kabiru Alani Agbabiaka who charged us to beef up the

security in the community by complementing the efforts of the police.

"All members of OPC including my dogs immediately swung into action and ensured that the menace was kept at bay here in Isolo community. We were able to apprehend about seven of them and handed them to police."

The OPC boss therefore appealed to parents and guardians in the community to keep close eyes on their children and ensure that morals and discipline are instilled in them, adding that they should be kept busy with life-impacting activities to prevent them from joining cult groups.

esilting drains, building culverts and sensitising residents on flood control being used by the Ejigbo Local Council Development Area to combat incessant flooding are yielding results, says its chairman, Hon. Monsuru Bello Obe.

In an exclusive interview with Echonews, Hon. Obe said the recent tour of flood-prone communities by the Community Development Committee following flood alert of the Lagos State Ministry of Environment led to the discovery of infractions that could expose them to the floods and prompted the council to construct drains and desilt.

To sustain compliance, the

council has also embarked on sensitisation programme, educating the residents on what to do to control flood, asking those in the highly prone area to vacate their residence in case of heavy torrents.

Commenting on the preparations by the government and communities, the Ashamu Bucknor CDA Chairman, Mr. Toyin Saka said: "As per the flood, the community has done everything humanly possible to reduce the effects of the devastation on the community but as you're quite aware, no community can provide the infrastructures for curtailing

Street Sweepers demand road caution sign posts,regular salary payment

he sweepers attached to Oshodi -Apapa Expressway have appealed to the state government to provide road sign posts for them to control vehicular high speed and avert accidents while on duty. The high way cleaners also appealed for regular payment of their salaries, stating that they were yet to receive their August salary.

One of the sweepers who spoke on anonymity told ECHONEWS that the job exposes them to unforeseen accidents due to abscence of sign posts to caution oncoming vehicles as some of them have been victims ofsuch accidents while discharging their duty.
