# 4,000 Killed in Road Crashes – FRSC

No fewer than 4000 road users who could have wished each other Merry Christmas last week were resting in graves nationwide. Records of the Federal Roads Safety Corps indicate that Nigeria recorded a rise in road crashes and fatalities from 3800 in 2025 to 4000 this year. According to the corps, many of the crashes were caused by drivers' recklessness, prompting renewed calls for caution, especially during festive periods. Data from FRSC's Operation Zero covering December 15, 2024 to January 15, 2025, recorded 531 crashes nationwide, out of which 169 were fatal, resulting in 402 deaths. The figures capture the core of the December festive travel season. Beyond the festive window, overall statistics between January and September 2025 show



a continued upward trend.

During the nine-month period, 3,915 persons died in 7,715 crashes compared with 7,011 crashes and 3,811 deaths during the same period in 2024.

This represents a 10 per cent increase in crashes and an 11.5 per cent rise in fatalities year-on-year.

The report indicates that crashes typically spike during festive travel periods, while unsafe road user behaviour, including speeding, overloading and distracted driving, remains a consistent factor.

Globally, the World Health Organisation (WHO) notes that road traffic mortality

remains high, with millions dying annually and no rapid decline in fatality rates, despite increased safety campaigns.

The FRSC Lagos State Sector Commander, Kehinde Hamzat, said the corps had intensified public awareness and sensitisation campaigns to

educate motorists on the dangers of risky driving, particularly during the festive season.

He noted that crash rates usually rise at this time of the year and disclosed that the agency had partnered with Pernod Ricard Nigeria to step up public education against

drunk driving through town-hall meetings, media engagement and community outreach.

"In collaboration with private sector partners such as Carloha Nigeria, FRSC has also pushed messages against distracted driving and distributed reflective jackets and informational materials to improve awareness and officer visibility," Hamzat said.

He added that the campaigns focus on responsible driving, including obedience to speed limits, traffic signals and avoidance of alcohol while driving.

The 2025 Don't Drink and Drive (DDD) Campaign, launched in Lagos by the Beer Sectoral Group in partnership with FRSC, brings together transport unions, media organisations and corporate partners to reduce alcohol-related crashes during the Christmas and New Year travel peak.

Meanwhile, the Lagos State Drivers' Institute (LASDRI) has urged motorists to prioritise



safety during the festive season and after.

The General Manager of LASDRI, Mrs Afusat Tiamiyu, said increased traffic volume, festive activities and hazy weather conditions heighten crash risks during the period.

She described safety consciousness as "the greatest gift road users

can give their loved ones."

"Do not drink and drive, avoid distractions such as mobile phones, get enough rest to prevent fatigue, obey speed limits, and ensure all passengers wear seatbelts," Tiamiyu advised.

She encouraged motorists to take

advantage of LASDRI's annual training programmes, noting that the institute operates about 15 training centres across Lagos State.

LASDRI, in partnership with Guinness Nigeria Plc and the Coalition of Driving Schools Association in Lagos State, has also staged an ember months safety advocacy auto-

cade, targeting motor parks and transport hubs across the state.

According to Tiamiyu, the campaign focuses on reducing crashes by addressing human factors such as speeding, overloading, distracted and drunk driving, particularly among commercial drivers.

At the national level, the Corps Marshal of FRSC, Shehu Mohammed, has ordered 100 per cent deployment of personnel and operational assets across the federation under the Operation Zero Tolerance Exercise.

A statement by the Corps Public Education Officer, Olusegun

Ogungbemide, said the operation, which runs from December 15, 2025 to January 15, 2026, involves round-the-clock patrols, strategic traffic management, emergency response and strict enforcement of traffic laws.

The Corps Marshal also directed road construction companies to open up carriageways, clear bottlenecks and ensure proper traffic control at work zones during the festive period to ease congestion and improve safety.

The Lagos State Waste Management Authority (LAWMA) has reaffirmed its readiness to maintain a clean, safe, and healthy environment across the state during the New Year festivities.

A statement signed by the Managing Director/Chief Executive Officer of LAWMA, Dr. M u y i w a Gbadegehin said the Authority had activated a comprehensive waste management plan to address the anticipated increase in waste generation across residential, commercial, and public areas during the period.

According to him, LAWMA has deployed waste evacuation trucks, personnel, and supervisory teams to strategic locations, including major highways, markets, motor parks, and other high-traffic public spaces, to ensure prompt and continuous waste collection throughout the holiday period.

# LSSTF'S Permanent Office: Adebutu Donates Operational Headquarters To Agency

Efforts to enhance security and safety in Lagos State, on Monday, received a boost with the groundbreaking for the construction of a multi-storey building that will serve as the operational headquarters of Lagos State Security Trust Fund (LSSTF).

Governor Babajide Sanwo-Olu turned the sod for the commencement of the project, which will be the permanent office of the State-owned agency established in 2007 by the State Government to support security operations.

Frontline businessman and philanthropist, Sir Adebukunola Adebutu Kessington, single-handedly took up the funding of the project, sited along Assfibi Road in Alausa. The new LSSTF office complex is expected to be ready by October 2026.

Sanwo-Olu noted that the agency held a strategic mandate to promote safety but had been operating without permanent office since its establishment.

When completed, the Governor said the permanent office complex would boost capacity and service delivery of the agency, adding that the State's security architecture would be enhanced if LSSTF moved to its permanent headquarters.

The Governor said: "LSSTF has been operating from a rented facility in the last 17 years, which has necessitated the need to build and deliver a permanent facility from where the agency will operate. This will make LSSTF to discharge its statutory obligations with utmost

professionalism and integrity.

"The completion of the project will make no excuse for its leadership in providing the best quality of security support services expected from the agency. The new office complex would bring about significant improvements in the support being given to all security agencies. The Fund is part of the legacies being bequeathed to Lagos and it will continue to do well."

Sanwo-Olu praised the philanthropic spirit of Sir Kessington, noting that the donation represented the donor's high sense of patriotism and commitment towards keeping the State secure.

The donor's gesture,

the Governor pointed out, lifted a financial burden off the Government, bypassing bureaucratic constraints that could have delayed the implementation of the project.

"This project will outlive all of us and one man that God has used to kick off this journey of a permanent office is Sir Adebutu Kessington. The donor of the project has taken off the burden of bureaucracy from the agency's shoulders to ensure security operations in Lagos are not undermined," the Governor said.

LSSTF Executive Secretary, Dr. Ayodele Ogunsan, said his vision for the restructuring of the Fund's operations had started to materialise

with the groundbreaking for the agency's permanent office.

Upon his appointment as Chief Executive Officer of the Fund, Ogunsan said his desire was to ensure the agency move from rented accommodation into a permanent headquarters befitting its strategic mandate, responsibilities, and mission.

He said: "Our benefactors, Sir Kensington Adebutu, immediately embraced this vision and graciously agreed to solely undertake the construction of this office complex as a donation to the Fund. This singular act of generosity remains both humbling and inspiring, and it speaks volumes about the

donor's unwavering commitment to the safety, stability, and progress of Lagos.

"Today's ceremony is more than a routine project milestone; it is a powerful symbol of leadership, trust, and the impact of purposeful philanthropy. This purpose-built facility will significantly enhance LSSTF's operational efficiency, institutional capacity, and ability to coordinate effectively with our security partners in delivering on our mandate."

Ogunsan disclosed that the building would be named after Sir Kessington in honour of his philanthropy and contribution to public safety.

Sir Kessington, a nonagenarian and Lotto mogul,

described the project donation as "a call to duty", noting that the intervention would further strengthen the Government's efforts to protect citizens and their properties.

Describing Lagos as "pulsating heart of the nation's commerce and enterprise", Sir Kessington said the building would stand as a lasting monument to residents' collective responsibility, shared safety, and quest for peace.

He said: "Through this landmark intervention, we take a decisive step toward safeguarding our people, securing our markets, and ensuring that Lagos remains a sanctuary of peace, stability, and opportunity for all who dwell within her borders."



# Court Convicts 48-year-old Man For Multiple Sanitation Offences

A special Offences Mobile Court in Oshodi on Monday sentenced a 48-year-old man, Makinde Rasaq, who was arrested with a Honda SUV filled with refuse last week at Lagos Island, to 13 months community service at Kirikiri. The accused, who faced seven charges, pleaded guilty to all seven charges and was subsequently sentenced to varying terms of imprisonment



with an option of community service for all the offences, totalling 13 months' community service, which will be served at Kirikiri. The offences included breach of peace, indiscriminate dumping of waste, non-patronage of

PSP operators, illegal transportation of waste without a valid license and obstruction of officers from carrying out their duties. The convicted man who was arrested in the act of illegally dumping refuse on

Saturday night at the Tinubu fountain in Central Lagos is suspected to be part of a syndicate deliberately dumping refuse around the state to create a narrative that Lagos is dirty. He was

subsequently placed in detention at Adeniji-Adele Police station before he was handed over to Kick Against Indiscipline (KAI) officers for arraignment by the legal officials from the State Ministry of Justice.

Speaking on the latest conviction which went viral, the Managing Director of LAWMA, Dr M u y i w a Gbedegesin, said the message of the conviction is a declaration of zero tolerance on indiscriminate waste disposal to everyone. He warned residents to ensure proper

waste disposal through patronage of the LAWMA-accredited PSP operators, as this is in accordance with the Environmental Laws of Lagos State.

He reiterated that residents should desist from the unwholesome waste disposal, as generation of waste is an unavoidable aspect of existence, adding that residents must always patronise the Private Sector Partnership (PSP) for better service delivery.

## 30yr Old Thrift Collector Faces Prosecution Over Alleged N4.8M Fraud

A female suspect, Mary Towolawi, has been remanded in prison custody over allegations of fraud valued at N4.8million. The Police, while arraigning Towolawi, a thrift collector, before the Magistrates' Court in Badagry, held that she is standing trial on charges bordering on stealing and conversion. Police Prosecutor, Edet

Ekpo, claimed that Towolawi committed the offence between January 2022 and October 2025, at LAPO Microfinance Bank, in Badagry, Lagos. Ekpo alleged that while working as a thrift collector for the bank, the defendant stole money kept under her care and converted the same to her personal use, after which she was nabbed and handed over to the police. "The offences

contravene the provisions of section 287 of the Criminal Law of Lagos State 2015," the policeman said. The defendant, however, pleaded not guilty. Thereafter, The court granted the defendant bail in the sum of N500,000 with two sureties in the like sum, ordering that one of the sureties must be a community leader. The case was adjourned till January 26, 2026.

## Man Remanded Over N170K Fraud

A sitting at the Badagry Magistrates' Court has ended with the remand order of one Anax Isah, over allegations of indulging in fraudulent activity to the tune of N170,000. During the proceeding, Isah, 30, pleaded guilty to the allegation after which the court remanded him till next arraignment on January 12, 2026, for facts finding and sentencing. Prior to the adjournment, the prosecutor, Edet



Ekpo, told the court complainant with that the defendant committed the offence on November 1, at about 2:00 p.m in the Ibereko area of Badagry. Ekpo said that the defendant obtained N170,000 under false pretences alleging that the defendant had promised to supply the

complainant with two bags of beans but failed to do so. "He was later arrested and handed over to police for prosecution," the prosecutor said, adding that the offence contravened the provisions of section 314 of the Criminal Law of Lagos State, 2015.

# Assembly to wade into alleged ejection of artisans

The Lagos State House of Assembly has promised to see into the occurrence of a reported threat to livelihood and displacement of artisans operating within the Isheri-Idimu Powerline corridor, following a protest made by them. The lawmakers made this known following the artisa's protest at the Assembly complex, stating that a group of suspected hoodlums made way to the their place of work alleging that they were acting on the instruction of the Chairman of the Egbe-Idimu Local Council Development Area, LCDA, Idris Balogun, to take over their mechanic village for private interests. The agitators carried placards with messages



such as "Save us from land grabbers," "Powerline belongs to government, not Omo Onile," and "We demand competency and decency at Egbe-Idimu," to mention a few, promoting the artisans in making appeal to the legislators to intervene and protect them from what they described as persistent harassment. Speaking on behalf of the protesters, the Chairman of the mechanic village, Adeleke Odufeko, maintained that the land was lawfully allocated to them by the Lagos State Ministry of Transportation.

"It was the Ministry of Transportation that allocated the space to us for use as a mechanic village. We have official approval," Odufeko said. "There are no permanent buildings there, only spaces where we keep our tools and equipment. We were also directed to pay annual royalties to the traditional rulers in Idimu and Isheri, and we have consistently done so," he added. The group leader alleged that tensions escalated when Balogun, whom he described as a royal family member but not a reigning monarch, allegedly demanded

payments from the artisans. "He came and said we should start paying him money. He is related to the royal family, but he is not the king. His father was the late monarch. Since 2016, he has been harassing and intimidating us," he claimed. "There is hardly any police station he has not taken us to. Some of our members were even sent to Ikoyi prison without committing any offence," he alleged. Odufeko also stated that despite a court order directing all parties to maintain the

status quo, violence erupted at the site late last month. "When the harassment became unbearable, we went to court in 2021. In 2024, the court ordered that the status quo be maintained and warned him not to interfere with us," he said. "However, on November 29, thugs accompanied by soldiers and police officers invaded the area. Vehicles undergoing repairs were damaged and shops were vandalised." "The Ministry of Transportation later intervened, deploying a task force to remove the hoodlums. But shortly after they left, the thugs returned and resumed attacks, beating people. Although some were arrested during a second intervention, we later learnt that influential individuals secured their release. Since then, peace has eluded us," he added. "They shut down the entire place and warned us not to

work. I am being hunted because I am the chairman representing about 10,000 artisans. That is why we came to the Assembly for help," he said. Addressing the protesters, a member of the Lagos State House of Assembly representing Oshodi-Isolo Constituency, Stephen Ogundipe, assured them that their grievances would be addressed. "We are here on behalf of the Speaker, Mudashir Obasa. We have listened to your concerns and will formally present them to him," Ogundipe said. "We commend you for remaining peaceful. The House will invite all concerned parties, including the Ministry of Transportation and your representatives, and ensure that the matter is thoroughly investigated. We urge you to remain calm and law-abiding."

# Public-Private Alliance Unlocks \$3bn for Emerging Markets

A growing alliance between governments and private investors is reshaping the way infrastructure is financed, with a global support platform now credited with unlocking close to \$3 billion in private capital for critical projects across emerging economies. The Public-Private Infrastructure Advisory Facility (PPIAF) says the milestone reflects the success of its renewed strategy, which prioritises policy reform, stronger regulation and institutional capacity—key ingredients that

make large-scale infrastructure projects more attractive and commercially viable for private financiers. Midway into its current five-year plan, the facility's impact has far outpaced its direct spending. Its 2025 annual report shows that just \$13.3 million in grants approved in the past year alone helped catalyse about \$400 million in early-stage private investment, alongside additional funding through co-financing arrangements. Since the start of the strategy period, PPIAF estimates it

has mobilised nearly \$3 billion in private financing, with another \$3 billion worth of projects already in advanced pipelines awaiting financial close. A significant share of this capital has flowed into Sub-Saharan Africa, which accounts for more than a third of PPIAF's approved projects and grant commitments. In West Africa, years of support for electricity market reforms and stronger utility governance have translated into broader energy access, lower operating costs and renewed investor confidence—outcomes that would

have been difficult to achieve under traditional, state-only funding models. The results highlight a wider global shift in infrastructure financing. As governments and development institutions increasingly acknowledge that public funds alone cannot bridge infrastructure gaps running into trillions of dollars, attention has turned to innovative public-private partnerships. These models combine policy and regulatory reform with risk-

sharing mechanisms and private sector expertise, allowing projects in transport, power, water and digital infrastructure to move forward on more solid commercial footing. Similar momentum is building elsewhere, with new frameworks designed to attract private capital into sustainable and climate-resilient infrastructure, as well as efforts by national treasuries to deepen domestic capital markets for long-term public-private investments. Together, these initiatives signal a growing recognition that private finance must play a central role in meeting future infrastructure needs. Even so, analysts caution that the scale of global infrastructure demand—especially in developing economies—remains enormous. While facilities like PPIAF demonstrate how targeted reforms and institutional strengthening can unlock billions in private capital, they also underline the urgency of sustaining and expanding such efforts to deliver resilient, inclusive and future-ready infrastructure worldwide.



# Zero Piracy: Global Boost for Nigeria's Maritime Sector

Nigeria's Agency (NIMASA), maritime Dr Dayo Mobereola, industry wrapped up 2025 on a strong and reassuring note, recording zero piracy incidents in its territorial waters while clinching a return seat on the International Maritime Organisation (IMO) Council, for maritime achievements that signal renewed global confidence in the country's maritime safety and governance framework. The Director-General of the Nigerian Maritime Administration and Safety

Project, backed by closer collaboration among security agencies. The achievement builds on previous successes, extending Nigeria's run of piracy-free waters to three consecutive years and earning commendation from international maritime stakeholders. Beyond improved security, the NIMASA boss highlighted Nigeria's renewed alignment with global maritime standards. He noted that President Bola Tinubu's signing and deposition of three Instruments of

Accession to key IMO conventions reinforced the country's commitment to international best practices. Combined with relative industrial harmony across the sector, these steps helped Nigeria secure election into Category C of the IMO Council, marking a significant comeback after years outside the influential global body. President Tinubu has since welcomed the development, describing it as a reflection of Nigeria's restored credibility and

growing voice in international maritime affairs. Mobereola stressed that safer seas translate directly into economic gains, pointing to reduced risk premiums for shipping, offshore operations and port investments, all of which enhance investor confidence and lower operating costs. He commended maritime operators, labour unions and other stakeholders for their cooperation, assuring that NIMASA will consolidate the gains in 2026 by further strengthening

safety standards, environmental protection and compliance with international conventions. As Nigeria resumes its role on the IMO Council, Mobereola noted that the position comes with higher expectations and greater responsibility. He urged industry players to sustain the momentum, deepen collaboration and continue strengthening the maritime domain, positioning Nigeria not just as a regional leader but as a respected contributor to global maritime governance.



# How Former Ejigbo LCDA Secretary, Paul Fregene, Facilitated Drainage Project for Bucknor Estate

**B**ucknor Estate, Oke-Afa, Ejigbo, Lagos, a fast-growing and densely populated residential community, has for years struggled with infrastructural development despite the quality and diversity of its stakeholders.

The estate, largely inhabited by non-Southwestern Nigerians, recorded a major milestone when it produced its first Secretary to the Local Council Development Area (LCDA), Deacon (Dr) Paul Fregene, who served as Secretary to Ejigbo LCDA.

During his tenure, Fregene made sustained efforts to attract development projects to Bucknor Estate but was unable to achieve this for over eight years due to institutional limitations.

In 2022, the then

Chairman of Ashamu Estate Community Development Association (CDA), Mr Adeola Jimoh, formally wrote to the relevant authorities requesting the construction of a comprehensive drainage system within the estate. However, the request did not yield results.

Undeterred, Deacon Fregene took personal initiative in 2023, writing directly to the Lagos State Ministry of the Environment, Office of Drainage Services, seeking the construction of a drainage system along Sarah Faboyede Street—the longest and most populated street in Bucknor Estate and a major access route to other parts of the community.

For two years, Fregene consistently followed up on the request as a stakeholder. The effort eventually paid off when the project was approved and captured in the 2025

Lagos State Appropriation Budget.

Following the approval, officials of the Drainage Services Department contacted Fregene to inform him that the project had been awarded and the contractor mobilised, with a community engagement scheduled for Wednesday, December 10, 2025.

Community Engagement and Project Details

On the scheduled date, residents of Area 1, Bucknor Estate, mobilised en masse for the meeting, filling the venue to capacity—an indication of the community's strong support for the project.

In his opening remarks, Deacon Fregene paid tribute to the late Mrs Sarah Faboyede (CP, rtd), the first Chairperson of the pioneer CDA in Bucknor Estate, who played a critical role in the early

development of the community before her passing earlier this year.

A four-man Lagos State Government drainage team, led by Engr. Ogunyemi, Deputy Director, Drainage Services—and National President of the Environmental Engineers of Nigeria—explained the scope and technical details of the project, including its depth, width, and alignment.

Engr. Ogunyemi disclosed that the Lagos State Government had achieved 95 per cent completion of the main canal drainage leading to Fasheun Bridge, noting that drainage from Sarah Faboyede Street would be channelled through Pedro Street into the main canal.

He further assured residents of John Obafemi Street (Area 4) that their drainage project

would be executed as Phase Two of the current intervention.

The Site Engineer, Engr. Ekerin, explained that the project would commence with a sensitisation exercise, during which survey markings would be carried out.

He advised residents to remove any structures or objects encroaching on the project's right-of-way to avoid delays.

On behalf of the Bucknor Estate Initiative (BEI), residents expressed gratitude to Governor Babajide Sanwo-Olu, the Commissioner for the Environment, Mr Tokunbo Wahab, and officials of the Drainage Services Department for approving and initiating the project.

A landlord and stakeholder, Mr Austin Ukete, described the development as a turning point for the estate.

"Today is one of my happiest days in Bucknor Estate, where I have lived for over a decade. I believe

many residents will now breathe a sigh of relief.

We appreciate the state government and assure them that our disposition towards governance will continue to improve," he said.

The community also pledged to take ownership of the project, assuring the safety of contractors, workers and materials throughout the execution period.

Those in attendance included Deacon (Dr) Paul Fregene, immediate past Secretary to Ejigbo LCDA and Patron of BEI; Comrade Toyin Saka, Chairman, BEI; Alhaji Yinusa Sule, Deputy Chairman, BEI and Chairman, Area 1; Surveyor Richard Akinyemi, Chairman, Area 4; Mrs Nike Fashoyin, Financial Secretary, BEI; Elders Omosuyi and Obafemi; Mrs Remi Oke; Mr Austin Ukete, and other residents.

In a closing appeal, the community urged the Lagos State Government to extend further infrastructural development to Bucknor Estate, noting that residents have consistently supported development through self-help initiatives, including the provision of over 20 electricity transformers, construction of internal roads and drainage systems.

# Eti-Osa Marshals Arrest Suspected Hoodlums

Security operatives attached to the Eti-Osa Local Government Street Marshals have arrested suspected hoodlums at the Igbokusu Under Bridge along the Jakande-Lekki axis of Lagos, reinforcing the council's renewed clampdown on street crime and disorder. The suspects were apprehended during a routine patrol of identified flashpoints, following complaints from residents and



commuters about rising safety concerns in the area.

The Street Marshals, a newly inaugurated task force, were established to complement existing security agencies by addressing minor

crimes, environmental violations and public disturbances at the grassroots level. Their deployment aligns with broader efforts by local governments across Lagos State to improve community safety

through early intervention and intelligence-led patrols.

Officials of the Eti-Osa Local Government said the operation underscores the administration's zero-tolerance stance on criminal activities,

particularly in public spaces often exploited by miscreants. The Igbokusu Under Bridge has in the past been flagged as a hotspot for loitering and petty crime, prompting increased surveillance and coordinated enforcement.

Under the leadership of the Executive Chairman, Omo'ba Adeola Alimot Adetoro, the council has intensified security measures aimed at restoring public confidence and ensuring a peaceful environment for residents, traders

and road users. The chairman reaffirmed the administration's commitment to working closely with security agencies, community leaders and residents to flush out hoodlums and sustain law and order across Eti-Osa.

Authorities have urged members of the public to remain vigilant and continue reporting suspicious activities, assuring that proactive measures will be sustained to keep the local government safe and secure.

## Adetoro Visits Elegushi Market Fire Scene, Vows Support for Traders

Omo'ba Adeola Alimot Adetoro, Executive Chairman of Eti-Osa Local Government, personally visited Elegushi Model Market in Lekki following a devastating fire that had razed nearly 48 shops in the early hours of December 15, 2025. The hands-on visit reflected the council's commitment to supporting traders and

restoring normalcy to one of the area's busiest commercial hubs.

The blaze, which broke out around 2 a.m., was swiftly contained by the Lagos State Emergency Management Agency (LASEMA), preventing casualties but leaving substantial material losses. Fire investigators said the inferno started in a makeshift stall before spreading to adjoining shops, highlighting the vulnerabilities in

market safety infrastructure.

At the scene, Chairman Adetoro engaged directly with traders, listening to their concerns and offering assurances that the local government would coordinate with traders' associations and relevant authorities to fast-track recovery and rebuilding efforts. He emphasized that reconstruction would incorporate modern fire prevention systems

and safety protocols to minimize the risk of future incidents.

The incident also spotlighted wider challenges facing Lagos markets, including overcrowded stalls, faulty electrical connections, and inadequate fire detection mechanisms, issues that authorities and market unions are jointly addressing. Adetoro stressed that proactive planning and risk

awareness are critical for safeguarding the city's commercial centres.

In pledging targeted support, the chairman vowed that the council would mobilise resources and work with state agencies to provide relief, guidance, and safety training for traders, ensuring that the market not only recovers but emerges more resilient. Market leaders welcomed the visit, expressing optimism that the

joint efforts of government and stakeholders would restore livelihoods while building stronger safeguards against future disasters.

The visit underscored the pivotal role of local governance in emergency response and community recovery, signalling a proactive approach to protecting both lives and commerce in Eti-Osa.

Super Eagles' Group C clash against Tanzania on Tuesday, Davido placed a \$25,000 bet predicting that both teams would score. Sharing a screenshot of the betting slip on his X page, he captioned it, "Let's get this W Nigeria." The prediction came true as

social media, describing him as a "joy giver" and urging Twitch to review and potentially reverse the ban. Online discussions suggest the suspension may have resulted

from mass reporting triggered by comments or behaviour during the livestream.

Contrary to circulating rumours, claims that Carter Efe was banned from other digital platforms have

been debunked.

The news has left many followers disappointed, especially during the festive season, with supporters hoping for a swift and positive resolution.
