# agosians Mobilise Against Protest

ody of chairmen of Local Government and Local Council Development Area of Lagos, Conference 57 has said that it will not allow any protest to take place within their areas.

The body rose from a meeting over the planned protest and declared that even though the citizens had the rights to protest, it would not allow Lagos to be the centre state for a violent rally.

Some faceless people had been calling on Nigerians for a protest against bad government tagged, "Days Of Rage Protests across social media platforms., beginning from August 1.

The demands of the faceless organisers as released on social media platforms include; freedom for IPOB leader, Nnamdi Kanu, scrapping of the 1999 Constitution and replace it with a Peoplemade CONSTITUTION, Toss the Senate arm of the Nigerian Legislative System, keep the House of Representatives (HOR), and make lawmaking a part-time endeavour, Pay Nigerian Workers a minimum wage of nothing less than N250,000 monthly and Invest heavily in education and give Nigerian students grants, not loans among others.

Against this backdrop, the chairmen represented by their leader and chairman of the Bariga Local Council Development Area, Kolade Alabi argued that their decision to kick against the demonstration was based on the belief that the rally would not solve challenges raised by the impending demonstrators, but rather create new challenges across the country.

The chairmen noted that rather than disrupt existing peace and harmony among Nigerians, the protesters could wait for the 2027 general election and express their displeasure against the government through ballots.

According to them, the polls provide a legitimate Salawu

platform for citizens to make their voices heard and impact governance.

The council chairmen appealed to the protest organizers to reconsider their approach, stressing that the future of Nigeria depends on positive and proactive engagement from its citizens.

They noted that fostering innovation and creativity among youth remains an essential tool for the country's development and prosperity.

Alabi called on residents not to allow themselves to be used for protest, alleging that the organizers of the planned August 1 protest do not mean well for the

"We are here to appeal to Lagosians that they should not allow themselves to be used for any planned protest in the state. We the council chairmen in Lagos will not tolerate any form of protest within our council. Rather than engage in this protest that disrupts commercial activities across the state, you can use your vote to protest during the election", he

In his words, The Chairman of Somolu LG, Abdulhamed Salawu has advised the youth to reconsider planned protests, emphasizing that federal, state, and local governments are actively working to alleviate the hardships faced by Nigerians.

Salawu highlighted the



recent approval of a N70,000 minimum wage as a testament to the government's commitment to improving workers' living standards.

Salawu pointed to significant economic measures taken by the Tinubu administration, which includes direct monthly allocations to local governments. These allocations are aimed at ensuring grassroots development and providing much-needed financial

This approach he argued, reflects the federal government's dedication to addressing economic challenges head-on and supporting the community. The council boss added that Governor Babajide Sanwo-Olu has introduced various initiatives to ease economic pressures on residents.

The measures include reducing workdays for civil servants, lowering public transportation fares, and distributing food packages to 300,000 households. Additionally, Sanwo-Olu's administration has reinstated free child delivery services in state hospitals and suspended tax payment requirements for school enrollment to prevent student absenteeism.

"We urge the youth not to be misguided into unnecessary protests," Salawu said.

"The extensive palliative measures being implemented are clear signs of the government's dedication to improving the lives of Nigerians. Protests are not needed at this moment; what we need is patience and understanding."

Salawu's applauded the concerted efforts by the Tinubu-led administration and state governments to tackle economic hardships. He emphasized that while current hardships are a global issue, dialogue repairs, whereas protests can be destructive.

Corroborating Alabi, his counterpart for Ibeju-Lekki Local Government Area, Abdullahi Sesan Olowa decried the planned protest at a period that the current federal government had barely spent a year in office. He stated that President Bola Tinubu ledadministration is doing all to improve the economy of the country, saying protest is uncalled for at this period for the country.

"We are not going to sit back and watch the organisers of this protest to


disrupt the peace across local government and local council development areas of the state, "he said.

Speaking, Mr. Olusesan Daini, the Public Relations Officer of Conference 57, stressed that youths should focus their energy on creative and innovative contributions to support Nigeria.

Daini urged young people to invest their efforts in nation-building rather than participating in protests, which he believes do not provide constructive solutions to the country's challenges.

In the same vein, the Lagos State Chapter of All Progressives Congress had appealed to Lagos residents to let peace reign in the state

In a statement by the state Chairman of APC, Cornelius Oyemade, APC acknowledges peaceful protests as an integral component of democratic governance, the predictable attendant violence and loss of lives and property remain undesirable.

"In the past days, we have watched with keen interest, most especially, in the social media, the mobilization for the protest, laced with bitterness, hate speeches, hostility divisiveness and threats to citizens with contrary opinions," it said.

The party noted that the mass destruction of public and private assets during the Endsars protest which started as a harmless demonstration remains fresh in our memory.

"The loss of targeted critical infrastructure across various sectors set our dear state back by decades and in billions. We urge the government at the federal, state and local levels to remain sensitive, attentive, receptive and responsible to the yearnings of our terming population, most especially the youth, in order to continue to engender confidence and uphold its onerous constitutional responsibility to protect the lives and property of all and sundry. We're not unmindful of the political undertones with the otherwise moribund opposition fanning the embers of blood letting to soothe their bruised ego as a result of losing the last national elections. We take solace in the assurance that patriotic Nigerians will not be deceived into avoidable carnage by people with





ulterior motives," it said. The party appealed to the

security agencies to uphold the best professional standards to forestall any unpleasant development. "We, as a party, will are duty bound to fulfill our part of the social contract with the citizens who have graciously entrusted us with the mandate," it said.

Students of various tertiary institutions in Lagos State on Tuesday have distanced themselves from the planned national protest by some Nigerians, tagged '#EndBadGovernanceinNig eria, 'scheduled for August 1 to 10 to draw the attention of President Bola Tinubu's administration to the plight of Nigerians, hunger, and rising cost of living in the country.

Also kicking against the protest are students under the aegis of the National Association of Nigerian Students (NANS) in Lagos, who had promised to rather embark on a "Solidarity Walk" to encourage the state government.

The student leaders across tertiary institutions in Lagos State said their solidarity walk would also be held from August 1 to 10 to drum for peace, especially to ensure that the ugly incident of #EndSARS" of 2020 does not repeat itself.

The Chairman, National Association of Nigerian

Students (NANS), Lagos axis, Comrade Lekan Alimi, who addressed iournalists

on behalf of the students of various tertiary institutions in Lagos State, described the planned nationwide protests against the touted hardship in the country as "absolutely uncalled for."

He said, "In these trying times, it is crucial that we remember the importance of stability, peace, and constructive dialogue in achieving our collective goals. Given these significant contributions and the progress we have witnessed, we strongly state that we are not in support of any protest against the government in Lagos. We

understand the frustrations and challenges faced by many, but we must also recognise the advancements and opportunities that have been provided to cushion the economic effect on the nation, and we hope other states can emulate the Lagos State Government.

Also speaking, Chairman, National Female Students Association of Nigeria (Lagos chapter), Comrade Titilayo Ekundayo, said female students in Lagos State will shun any form of protest. "Lagos has been in peace and will continue to be in peace. We students are saying no to protest in Lagos State. We appreciate Governor Sanwo-Olu for giving opportunities to women in the state, and we female students will shun any form of protest."

However, the Pan Yoruba sociocultural group, Afenifere has supported the planned protest but reservation that it must be peaceful.

The Publicity Secretary of the Pa Ayo Adebanjo faction of Afenifere, Justice Faloye said that Nigerians have the right to protest and on that ground the body would be supporting a peaceful protest to tell the government that Nigerians are hungry.

Afenifere has always led the call for economic and political restructuring of the

state, adding "Palliative cannot resolve everything. Anywhere in the world, whenever government away subsidy people rise to challenge it and right from the days of Ali must go, Nigerians had been challenging bad policies," he

Faloye explained that 90 per cent of the small and medium enterprises rely on petrol to work but with subsidy removal, things had gone worse. "How do you want people to survive. We knew the implications of this policy. The protest is an organic reaction. We support anybody who wants to protest. In about 66 countries where their economies are like the present situation in Nigeria, people protest. We support peaceful protest not violent ones. We understand a protest is coming up but we don't want violence," he

According to Faloye, it is the government policy that is endangering the polity. We cannot say people should remain hungry. Tinubu should restructure the economy and stop running colonial economy.

"Afenifere believes in social welfarism but this government is operating liberal economy. The youths are entrapped. Economic and political restructuring is urgently needed," he said.









# LASUTECH To Partner LSMTL On research

### ... To Commence Aggressive Actions Against Substandard Steel Coming To Lagos

he Lagos State Materials Testing Laboratory Agency (LSMTL) is set to commence a Research Educational system to enhance undergraduates' learning process in the Engineering development field.

The symbiotic liaison is targeted at establishing a Materials Testing

Office within the premises of the Lagos State University of Science and Technology, Ikorodu Campus, as an educational fortress to conduct research on Soil, Steel, Concrete, Water, Cables and Plumbing techniques.

Welcoming a delegation led by the Dean, College of Engineering LASUSTECH,

Yakubu Bankole to the Agency recently, the General Manager of LSMTL, Engr. Olayinka Abdul disclosed that for Engineering learning processes to be well established, there is a need to stimulate a research scheme which is well-rooted towards practical experiences.

She said, "This collaboration is a learning process on the job to pattern the

wealth of knowledge acquisition towards development that is at par with International best practices. This impactful initiative will invoke a form of professionalism that will stimulate consistent research ideology towards a total rebranding of our processes for optimal customers' safety in averting building collapse". While deliberating on

the Module of Understanding being proposed for the initiative, the General Manager informed that the Agency will commence a stringent strategy against substandard steel materials coming into Lagos State, as measures to curb episodes of building collapse across the State. LASUSTECH, Dr. Yakubu Bankole Engineering should advance a synergy of experts towards a progressive Lagos State, with grassroots people accessible to resources and dividends of democracy for development.

He averred that the trend of development across settlements requires the Government's presence using durable infrastructures which students are being trained in maintaining through research processes and collaboration.

Still speaking, Dr. Yakubu stated that the initiative proffers first-hand information to students using the workspace environment of LSMTL as a case study, thus conducting practical engineering through such dynamism.



### Health Service Commission Holds Retreat, Tasks Medical Directors

he Lagos State Health Service Commission (HSC) recently held its Y2024 Second Quarter Forum for Medical Directors in all the State General Hospitals with a call for excellent performance in their various duties.

The Chairman of the Commission, Dr. (Mrs.) Atinuke Onayiga, who made the call in her address at the event held at the Lagos Continental Hotel Victoria Island, charged the Medical Directors to always learn to do better in all situations and in such a way that it will become a legacy for them.

She equally enjoined them to uphold the highest standard of excellence, reminding them that people are watching them and mindful of all their activities. The Chairman told them to align their expectations with that of the Commission's. "Do not be vindictive or hit back on people. You are a mirror and the legacy you leave behind is what matters", she said.

Dr. Onayiga further encouraged them to be compassionate in the discharge of their duties and to be sensitive to their surroundings and work environment by finding out who matters, within and outside the hospital community.

To the new Medical Directors, the Chairman urged them to understand the territory that they find themselves in, stressing that they must discover it, explore it, scope it and never disrupt the ecosystem, but manage it the best way they can to give them the needed results".

In her words, "It is necessary for you to foster healthy collaboration, to avoid enviable rancour within the ranks, to prioritise continuous learning and never be a know-it-all type, to develop the ability to accommodate other opinions, embrace digitalisation process, avoid conflict of interest, as well as being good at conflict resolution and not allowing conflict to linger unnecessarily, but to escalate to HSC for proper handling".

In his lecture titled: "MD as CEO", the Permanent Secretary of HSC, Dr. Ademuyiwa Benjamin Eniayewun noted that the so-called Leadership Management takes wisdom and courage, as extreme management is not for "rookies". He reminded them that as CEO, they are called to do extreme management, to lead, and to lead very well, as all things they do, as leaders have consequences.

Speaking further, the Permanent Secretary advised them to display



leadership qualities that involve humility, courage, integrity, pedigree, vision, empathy, and wisdom. He told them to engage in self-management, build teams, build platforms, promote staff involvement and not be naive as MDs. While advising them on



### Commissioner Unveils Waste Management Plans

Commissioner for the Environment and Water Resources, Mr. Tokunbo Wahab has unveiled plans to radically improve the waste management system in the state.

He disclosed this recently while speaking at a Waste to Energy Summit, themed, "Driving Environmental Sustainability" organised by Rack Centre in partnership with the NYSC Community Development Service (CDS), at the Radisson Blu Hotel, Ikeja.

In his keynote address at the event which brought together key stakeholders to discuss sustainable solutions to waste management challenges, Wahab, who was represented by the Managing Director/CEO of the Lagos Waste Management Authority (LAWMA), Dr. Muyiwa G b a d e g e s i n , emphasised the need for proper dumpsite management to mitigate environmental hazards.

"When Olusosun was established, it was actually on the outskirts, but development caught up with it. There's a lot of pressure on solid waste management, which is why we are working on reducing the amount of waste dumped on the Olusosun landfill through recycling initiatives", he explained.

He further outlined LAWMA's strategic plans to transform waste management in the state, by focusing

more on recycling, introducing various initiatives such as development of compost and biogas plants, to reduce the volume of waste going to landfills.

"We are working on developing composting and biogas plants on the site. The future state is that we are going to decommission the Olusosun landfill; we are already in the process.

Decommissioning the

dumpsite is necessary to address long-term environmental and health impacts. In doing this, we are going to comply with international best practices", he stressed. The Commissioner also announced plans to establish waste-toenergy plants across the state, saying "Waste-to-energy plants will be established at the Epe dumpsite. The plan is to have three waste-toenergy plants in the state at Badagry, Epe, Other speakers at the and Olusosun. We are exploring other alternatives to be used as landfills since we are working on shutting down the Olusosun landfill".

Dolapo Olaoluwa, the convener of the summit and a serving corps member, said he envisioned a gathering of key stakeholders to discuss solutions to the challenges posed by the of Urban and Regional Olusosun dumpsite and other management issues, as a way of contributing meaningfully to the community where he was serving.

Mr. Adetayo Odusole, Head Sustainability Coordination, Rack Centre, expressed their enthusiasm for sponsoring the event, noting that Rack Centre was pleased to support the initiative as it aligned with their goals of achieving a sustainable environment in the state, emphasising that achieving this required a collective effort.

Ekpo said that the defendant allegedly


obtained the sum of N1,150,000 million from Pan John, the complainant under the pretence of buying one Toyota Corolla car for him.



# Ikeja Electric Talks Tough On Energy Theft

keja Electric Plc (IE), Nigeria's leading electricity distribution company, has issued a stern warning to potential energy thieves, stating that any individual caught in the act of energy theft will be promptly charged to court, regardless of any previous loss of revenue (LOR) penalties imposed.

During the company's July Stakeholders Forum, an educational initiative designed to improve communication between IE and its customers, the company emphasized that it would no longer tolerate energy theft and will hold offenders fully accountable for their actions through legal means.

Kingsley Okotie, Ikeja Electric's Head of Corporate Communication, decried the recent surge in energy theft, particularly after the implementation of the revised tariff on Band A feeders, highlighting the detrimental effects of this trend on both the company and the electricity industry as a

He underscored that unchecked energy theft is unsustainable, emphasizing that neither Ikeja Electric nor the electricity value chain can continue to operate if these criminal activities persist.

"The theft is massive, and the company can not guarantee meeting customer expectations if this ugly trend continues. Ironically, some perpetrators believe that if they haven't been caught, there are no consequences. This is false, and we must change the narrative," he said.

According to Mr. Okotie, the survival of the Nigerian Electricity Supply Industry (NESI) depends on a unified fight against energy theft by all stakeholders. He warned that stealing electricity negatively affects the stability of

the industry as pilfering prevents the Distribution Companies (Discos) from

blowers.

To reinforce the company's resolve to combat energy theft, Ikeja Electric (IE) has instituted a reward system for whistle-blowers, offering up to 10% of the reconnection fee paid by residential and small to medium-sized enterprises (SMEs) offenders and up to 5% of the reconnection fee paid by commercial and industrial offenders to persons who provide verified reports on these illegal activities.

In his words, the whistleblowing platform is a powerful tool for customers and concerned individuals to anonymously report incidents of electricity theft. The platform, managed separately from the business, guarantees complete anonymity and confidentiality to protect the identities of whistle-

Okotie emphasized that energy theft is a serious



Act, punishable by a jail term ranging from six months to three years.

Interfering with meters or the works of licensees carries a sentence of 3 years imprisonment. Ikeja Electric can, under the law, prosecute people and companies for the criminal offence of energy

theft.

In line with regulations stipulated by the Nigerian Electricity Regulatory Commission (NERC), the NERC Order on unauthorized access, meter tampering, and bypass allows Discos to disconnect customers illegally connected to their network.

Reconnection is only possible after offenders have paid for the loss of revenue by paying backbills established by the Disco, along with reconnection costs and administrative charges.

The council boss added that Governor Babajide Sanwo-Olu has introduced various initiatives to ease economic pressures on residents.


