# Sanwo-Olu, Dickson, Jandor, Rhodes-Vivour in hot race for governor's seat

... As LP woos PDP to form allinace, says can't collapse own structure for PDP

ive days to the governorship election, the gubernatorial candidates in Lagos State have entered into a hot race, set on track, and struggling to outrun one another to secure the required votes to mount the covetous governor's seat in the state.

The incumbent, Babajide Sanwo-Olu, who is adjudged to be the front runner in the race, has been on his toes as well, making frantic effort to beat other contestants for his second term bid.

Though each of the candidates had been campaigning towards their ambitions in their different styles, the fashion and tempo of their campaigns have changed since the outcome of the results of the February 25 presidential/national assembly elections especially in Lagos State. Each party has been deploying new strategies to convince the electorate to buy their manifestoes and vote for them.

This week, on Saturday, March 11, 2023, the highest political race would be terminated when the winner would emerge and a new governor would be eventually chosen by Lagosians.

The political umpires, the spectators, the obeservers, the analysts, the

electorate, and even the contestants are eagerly waiting to see who rules the state for another year.

While the incumbent governor, Mr. Babajide Sanwo-Olu is carrying the flag of the ruling All Progressives Congress (APC) to the race, the Lead Visioner of Lagos 4 Lagos Movement, Olajide Adediran (Jandor) will bear the jersey of the Peoples Democratic Party (PDP), the former chairman of Surulere

Local Government, Hakeem Olaogun-Dickson will be contesting on the platform of Accord Party (AP) while Gbadebo Rhodes-Vivour, a former PDP senate candidate is going to the race kitted with Labour Party (LP) kits.

These major parties in the game are ready to slug it out with one another for the covetous post of the state governor on Saturday, as they have, in the last one week, been devicing new strategies to be

able to win the race, coming out of the experience of the last presidential/national assembly elections.

Apart from the normal door-to-door campaign, the ruling APC party has started engaging political leaders and other stakeholders, especially the youths in each community, convincing them on the reasons why they should vote for the party.

The party has also charged leaders in each polling unit, ward and loval

government to make sure they deliver their respective areas by canvassing their people's votes, showing them the achievements of the Sanwo-Olu led adnimistration and educating them on why the good works should continue in Lagos State.

The party leadership has been engaging different ethnic and religious groups in the state, making them understand that the best political party for them is APC and that the best

governor for them is Sanwo-Olu.

Having seen the stronghold of the APC and being afraid that the results of the gubernatorial election may not favour his party as it did during the presidential election, Rhodes-Vivour of LP said he has been trying to enter into alliance with PDP to form a strong hold to oust the ruling APC party.

He confirmed this to ECHONEWS in a telephone conversation with our correspondent, saying forming alliance with the PDP became necessary and that he has been discussing with the leadersip of party to forge a common front against the APC in the governorship election to be held this week.

He said: "Yes, we are in talk with the stakeholders and owners of PDP to work together to take APC out of this government.

"We are determined to emerge victorious during the coming Saturday gubernatorial election. We have made plans to ensure everybody comes out to vote. We will not be cheated twice, INEC has promised us that there would electronic transmission of the results; they decieved us because that was not what happened during the last

election, but we will not be deceived again. So, we are encouraging all our members to come out massively, and we have made sufficient security plans to ensure everybody is safe."

Though he did not disclosed whether the PDP has agreed with his alliance motive, when asked whether his own party will collapse its structure into that of the PDP to form the said alliance, Rhodes-Vivour quickly

said his own party cannot collapse its structure, explaining that his LP party has more followers than PDP, adding that his party has become stronger than the PDP. "How is that possible, Labour Party is strong, we got 900+ thousand votes and have higher votes than both APC and PDP, so it is not possible for us to collapse our structure for the PDP. We're working with the party,

and they are collapsing their structure for us so that we can deliver Lagos State."

Rhodes-Vivour has also planned to leverage what played out during the presidential election, believing that the Ndigbo in Lagos will also vote for his party and that their votes would give him victory He reportedly quickly added an Igbo name to his name to show the Ndigbo that he is their kinsman. Hence, his name was re-written as Gbadebo Chinedu

Rhodes-Vivour as shown on Wikipedia.

Rhodes-Vivour was said to be trying to remind the Ndigbo that though he is a Yoruba man, his maternal lineage is in the Igbo origin as his mother, Mrs. Nkechi Rhodes-Vivour was from the Southeast while he also married from the same region.

He also believed that the youths, who are the majority, would vote en mass for him, appealing to them to vote for his party as they did during the last election.

Though it seems the PDP is not putting more vigour into its campaign, political analysts said the emergence of the LP has weakened the party (PDP). They believe that LP and PDP would share their votes to give the APC upper hand and ample opportunity to emerge the winner seamlessly. For the Accord Party, it has still not been ascertained whether the party is going into an allinace with any other party or it is standing all alone in the race.

While speaking with ECHONEWS, the party's flag bearer, Olaogun Dickson said

he had contacted some parties to form allinace but did not get response from them, "hence, we are standing on our own and going into the competition as any other party. Though we are still expecting whether a party will come to us; for now, we are on our own as an independent party, and we believe in our success."

Earlier, ECHONEWS had reported that Dickson might pitch tents with the ruling APC party.

However, the Accord Party candidate said he has never been in any talks with APC before.



# Lagos Refutes Report on Poor Treatment to State Counsel

he Lagos State Ministry of Justice has debunked in totality a report by an online media platform that the leadership of the ministry has been mistreating the state counsel.

The online report with the headline" "LAGOS STATE MINISTRY OF JUSTICE: SHOCKING TALES OF WOE AND INJUSTICE: CLARION CALL FOR URGENT R E F O R M " w a s vehemently rebutted in a rejoinder signed Director, Public Affairs of the ministry, Mrs. Grace Alo.

It said, "The attention of the Lagos State Ministry of Justice has been drawn to a malicious and false publication by a faceless online platform and our reaction to the said publication is as follows:

The Ministry of Justice debunks in its entirety the false accusation leveled against the leadership of the ministry relating to the welfare and well-being of State Counsel as contained in the fabricated report by the platform. Nothing can be farther from the truth.

Alo said that the clamour for the payment of special allowances to law officers had been in existence since the year 2000 but past administrations could not actualize it,

However, the current administration of Governor Babajide Sanwo-Olu had since approved it in October 2021 while partial implementation of the harmonisation of salaries and allowances

commenced in November 2021, when State Counsel started receiving Security and Insurance Allowances. She said, "The only outstanding item in respect of the harmonisation of state counsel salaries and allowances with that of the Magistrates is the responsibility allowance and the same has reached the final stages of implementation."

According to her ,in the past couple of years, Robe allowances of State Counsel were not only paid yearly but were in fact increased substantially by 500% b a s e d on representations and memos presented by the Attorney-General to the governor.

"Apart from the above, other allowances are paid to State Counsel in their various departments

depending or the schedule of duties. On the issue of unpaid Litigation Allowance, unfortunately, the payment is delayed due to administrative issues relating to the CBN Cash Re-Design Policy which has nothing to do with the Office of the Attorney-General and Commissioner for Justice as well as the Solicitor-General and Permanent Secretary.

"Contrary to the unsubstantiated allegations in the writeup, there was no approval for payment of allowances to State Counsel during the NBA's AGC. The only approval obtained related to funds paid directly to the NBA for sponsorship of the AGC and funds for holding a Lagos State showcase session during the AGC. There was no item in the approval for payment of allowances

to State Counsel who were sponsored to attend the Conference as falsely and maliciously alleged. It is therefore false to allege that the Attorney-General refused to pay or release funds for the payment of allowances due to the State Counsel who attended the Conference," she said.

Alo stated that there h a d b e e n n o maladministration in the Ministry of Justice, rather the Ministry under the watch of the Attorney-General and Commissioner for Justice, Mr. Moyosore Onigbanjo SAN.

According to her, the commissioner has introduced innovations such as the Mentorship S c h e m e; t h e S e c o n d m e n t Programme (whereby State Counsel are posted to private law

offices for a period of between 2-3 months to enable them to experience legal practice in the private sector).

"Counsel had continued to enjoy sponsorship to local and International Training and Conferences including the International Bar Association Conference; the District Prosecutor Scheme (State Counsel are posted to Magisterial districts to vet/filter charges filed by Police prosecutors); ensuring that all the Laws of Lagos State are available online in Law Pavilion; Drafting of over 23 Laws which have been passed and other pending Bills, including the Administration of Civil Justice Bill; Creating the first Domestic and Sexual Violence Agency in the country among others," she said.

#### Lagos Set To Partner With Association of Estate Surveyors

he Permanent Secretary, Ministry of Waterfront Infrastructure Development, Esv. (Mrs.) Olayinka Patunola-Ajayi has urged the leadership of the Nigerian Institution of Estate Surveyors and Valuers (NIESV) to partner with the State Government in its drive towards economic sustainability and development of the State.

Patunola-Ajayi, gave the advice while receiving the President and Chairman in-Council of the Nigerian Institution of Estate Surveyors and Valuers, Esv. Johnbull Amayaevbo on Friday.

She noted that while the State Government continued to open up roads and maintain the existing ones for smooth road transportation, it has just inaugurated the first phase of the Blue rail services to

complement rail transportation, while work is in top gear for the completion of the red rail

The PS also revealed that in the area of water transportation where the Ministry is involved, the State Government has also commissioned a state-of-the-art Control Room at the Lagos State Waterways (LASWA) Jetty at Falomo where all activities on Water Transportation are monitored 24/7 for quick intervention when and where needed to ensure safety on the waterways. Esv. (Mrs.) Patunola-Ajayi said that wellequipped rescue boats were also purchased and deployed on the water for monitoring and quick response where necessary which had reduced to the barest minimum incidences of boat mishaps.

She noted that the Ministry of Waterfront Infrastructure Development is presently working on the

construction of 21 concrete Jetties across the State for safety and fast water transportation out of which seven are completed, and ready for commissioning and use by Lagosians.

She further disclosed that the State Government, through the Ministry, is working on the upgrade of the existing small Jetties in the rural areas to bring

them up to the established standard of the present administration for the safety and comfort of the citizens of the State. Patunola-Ajayi, therefore, implored the association to join hands with the state government to move Lagos forward.

In his remark, the President of the Nigerian Institution of Estate Surveyors and Valuers, Esv. Johnbull Amayaevbo said the essence of the visit was to engender a more cordial relationship between the Institution, State Government, Ministries, Departments, Agencies (MDAS) of Government and critical stakeholders.

# ILERA EKO Records 47 Sets of Triplets In Three Years

he Lagos State Social Health Insurance Scheme, Ilera Eko has recorded 47 sets of triplets since its inception about three years ago.

The General Manager, Lagos State Health Management Agency, LASHMA, Dr. Emmanuella Zambia said this during a visit to Ikorodu General Hospital where the state had recorded its first set of Quadruplets.

The set of four girls are the first birth of the family of Mr. and Mrs. Dayo Faniyi.

Dr. Zamba also said that 435 twins had been delivered on the scheme as she commended the Medical Director of the hosoital Dr. Taiwo Hassan and the entire staff for a job well done.

She added that the highest number of birth recorded on the Lagos State Health Scheme (LSHS) was triplets and that the Agency was extremely delighted in recording another milestone birth.

Dr. Zamba said that since the full commencement of the Scheme in the Year 2020, 47 sets of triplets and 435 sets of twins had been delivered on the Scheme.

Describing the birth as miraculous, she congratulated the parents of the Quadruplets on the safe delivery of the babies and promised that the Lagos State Health Management Agency (LASHMA) would do its best to ensure that the babies have access to medical care when due.

The General Manager urged residents in the State who are yet to enrol, to immediately tap into the opportunity provided by Governor Babajide Sanwo-Olu, in ensuring that every resident has access to quality and affordable healthcare.

She reminded that there was also an opportunity to pay by instalment for any resident who could not afford to pay N8,500 premium per annum for ILERA EKO individual plan or N40,000 per annum for ILERA EKO family plan comprising of the father, mother and four children below 23 years old.

The Medical Director, Ikorodu General Hospital, Dr. Taiwo Hassan, said that the facility would continue to partner with the Lagos State Health Management Agency (LASHMA) in order to give quality healthcare to the residents of Ikorodu and its environs.

He pledged that the Hospital would continue to improve the standard of healthcare delivered to ILERA EKO Enrollees.

Mr. Dayo Faniyi, father of the babies and a town planner with Isolo Local Council Development Area, commended Governor Babajide Sanwo-Olu, for his commitment to ensuring that ILERA EKO becomes a reality. He said, "ILERA EKO is a great relief to me, if not for the Governor, I wonder how much I would have paid in a government hospital for the delivery of my four babies".

He added that he would have been running helter-skelter to get money to pay for the operation of his wife, Mrs. Adeola Faniyi and the babies, especially at this crucial time when money is so difficult to get in Nigeria, if not for the good gesture of Governor Babajide Sanwo-Olu and ILERA EKO.

#### Pay Attention To Your Health, Govt Tells Lagos Health Workers

ealth workers in Lagos State and Nigeria have been advised to pay adequate attention and prioritise their health needs as they deliver health care services to citizens.

Permanent Secretary, Ministry of Health, Dr. Olusegun Ogboye who disclosed this at the Y2O23 Continuing Medical Education (CME) programme organized by the Ministry of Health for Health Workers and allied staff in the Ministry, noted that improving quality of healthcare delivery and enhancing effective service delivery in the health sector are direct consequences of mental, physical health and well-being of health workers.

Speaking at the Opening Ceremony of the five-day CME programme holding at the Lagos Chamber of Commerce and Industry, CBD, Alausa, Ogboye encouraged health care professionals to pay adequate attention to their own health just as they give professional care to

their patients, adding that maintain good health and wellbeing will go a long way in enhancing the much desired efficient and effective service delivery in the State health sector. He said: "This five-day capacity building workshop themed: 'Improving Quality of Healthcare Delivery' is targeted at encouraging health care workers to prioritise their health needs as well as educate them on trending health issues that will enhance their productivity during the discharge of their duties.



## Mint Leave benefit to skin, health

he most common and popular mints for growing are peppermint (Mentha piperita), native spearmint (Mentha spicata), Scotch spearmint (Mentha gracilis), and cornmint (Mentha arvensis); also (more recently) apple mint (Mentha suaveolens).

Mint grows natively on all continents except Antarctica. Peppermint and spearmint are likely the most commonly used mint varieties, but many others exist, such as wild mint and water

There are many varieties of the mint plant, and most fall under the genus Mentha. Because mint plants spread quickly, gardeners tend to grow them in containers. When planted directly into the ground, they can become invasive and take over a garden.

Some plants referred to as "mint" also fall under the genus Monarda. Both Mentha and Monarda genuses are within the same family, called Lamiaceae. Monarda mints include horsemint, catmint, and stonemint.

All varieties of mint leaves may be used fresh, in dried herb form, brewed as a tea, or concentrated in an essential oil.

Mint provides most of our commonculinary herbs (e.g., basil, oregano, marjoram, rosemary, sage, thyme, summer and winter savories).

Plus, there are dozens (perhaps hundreds) of traditional medicinal herbs, not to mention many aromatics for use in flavorings, perfumes, and cosmetics.

Many, if not most mint-family members, contain strongly aromatic oils (think lavender, rosemary, basil, thyme, and sage), which account for their many uses as seasoning, flavoring, and perfuming agents.

#### Uses for Mint Leaves

There are many safe uses for mintfamily herbs besides beautifying your gardens. Here is just a sampling:

Food: The peppermints are especially good culinary mints, ideal for chopping into salads, sprinkling over fruits or combining with basil or cilantro to make mint pesto. We like to add a couple tablespoons of fresh chopped mint to peas, green beans, carrots, Mint Leave

cauliflower, or zucchini to create a minted vegetables.

Drinks: Freeze a few trays of strong mint tea, then use the ice cubes for cooling summer drinks, add mint leaves or cubes to mojitos, iced tea, or fresh lemonade.

Tea: Why buy mint tea when it's so easy to make? What we usually call the "mints" (peppermint, spearmint, apple mint, etc.) are traditional tea herbs. Just steep your fresh mint leaves in boiling water for about five minutes and serve. It's a great digestive aid after dinner. Apple mint is one of my favorites with more mint flavor and less aftertaste.

Hair rinse: Add one part strong mint (especially rosemary) tea to one part cider vinegar for a conditioning rinse you can either leave in or rinse out. The vinegary smell dissipates after drying.

Facial astringent: Add a few finely minced leaves of fresh peppermint or other mint to a cup of witch hazel. Store in a glass jar for a week or more, shaking occasionally. Strain the herbs from the mixture after a week.

Mouthwash: Chop a quarter cup of fresh mint, bee-balm, lemon balm, basil, thyme, or oregano leaves and infuse in a quart of boiling water. When cool, strain the herbs and store in the refrigerator.

Mint bath. Steep a handful of mint leaves in a pint of hot water for about ten minutes, then strain. Add to bath water for an invigorating, stress-free soak.

Ease sunburn pain: Make a strong peppermint tea and refrigerating the mixture for several hours. To use, gently apply to the burned area with cotton pads.

Breath freshener: Just chew on a

few mint leaves, Sage teas and extracts have been used for centuries as a mouthwash for oral infections.

Don't use chew mint-family herbs if you're breastfeeding, as even small amounts or sage and peppermint may reduce milk supply.

Scent up a space: Keep your home smelling fresh by adding a few drops of mint essential oil to your favorite unscented cleaner or just take a cotton ball and dap onto a

Moth repellent/scented sachet: Tie a few branches of strongly scented mint (peppermint, sage, lavender, rosemary, bee-balm) together, or pull off a handful of leaves, and stuff them into the leg of an old nylon stocking. Suspend by a string inside a garment bag, tuck into bags of stored woolen clothing, or just place in your drawers to let your clothes soak up the scent. Refresh periodically to keep the scent fresh.

Bug repellent: When ants come into the kitchen during the summer, place a few stems of mint, gently crushed, near suspected entry points really does deter ants. You need to replace the mint with fresh material every few days. Also, keep pets flea-free by stuffing a small pillow with fresh spearmint and thyme and placing near your pet's bed.

Of course, mint isn't only used to deter bugs; it also attracts the beneficial insects. Bees and butterflies and hover flies love mint, which is rich in nectar and pollen, and this benefits pollinated plants and crops.

Medicinal Use of Mint Plants Mint has been long known as an

herbal remedy, easing queasy stomachs, calming stress and anxiety, and promoting restful

Peppermint tea has long been viewed as an excellent way to ease an upset stomach, calming the digestive tract and alleviating indigestion, gas, and cramps.

Brain Health: Consuming mint might promote brain health. One study found mint extracts have potential to treat Alzheimer's symptoms, although research is needed. Another study found that smelling peppermint could enhance memory and increase alertness, although it's unknown if ingesting it has similar effects.

Treats asthma: Mint leaves possesses relaxant properties and is considered to be extremely useful for asthma patients as it relieves congestion in the nasal pipe. However, the quantity and frequency of mint usage needs to be kept in check as excess use might lead to irritation in the nose and stomach.

Mint for liver: Mint is known to effectively boot the performance of the liver. Owing to the presence of nutritional essential oils and properties such as relaxing and soothing, mint is a highly beneficial herb to enhance the liver strength. Mint helps in cancer prevention: Research has suggested that certain active enzymes present in mint are equipped with the ability to prevent and cure cancer.

Mint has also been used for centuries in traditional medicine. Many, perhaps most, are also being uses for human and veterinary medicine, as insecticides or insect repellents,

and as antifungal or antibacterial protection for crop plants.

Mints are potent plants, full of phytocompounds that plants manufacture to protect themselves against harmful bacteria, viruses, and other assaults from the environments they evolved in.

Interestingly, there are studies that show spearmint is even beneficial to honeybees by cleaning out the mites that infect their hives.

#### **Use With Caution**

If herbal medicine interests you, please approach the mints, especially their essential oils, tinctures, and concentrated extracts, with care. This goes for both over-the-counter and homemade remedies.

Although many have been used by traditional healers around the world for centuries, most herbs haven't undergone rigorous testing for safety and efficacy, especially in pregnant/nursing women, children, elders, and people with chronic illnesses.

Seek out as much information as you can from books, online sources, and experienced herbalists in your area. Inform your healthcare practitioner whenever you begin using an herbal remedy.

#### Side-Effects & Allergies of Mint

In individuals with a gall stone disorder history, mint should be consumed only after careful consultation with a trained medical practitioner.

Same goes for pregnant ladies as it has rarely been seen to trigger a miscarriage. Excess dosage of mint is advised against as large quantity of menthol consumption is neither healthy nor advisable.

### How Obi Took Advantage of Our Youths To \_aunch His Ethnic And Divisive Politics-APC

he All Progressives Congress has described as divisive the politics of the Labour Party presidential candidate, Mr. Peter Obi.

The Special adviser on media and communication of the All Progressives Congress Presidential Campaign Council, APC PCC, Mr. Dele Alake said this at a news conference in Abuja on Friday.

Alake who was responding to the earlier press conferences held by the presidential candidates of the Peoples Democratic Party, Alhaji Atiku Abubakar and his counterpart for Labour Party, Peter Obi, challenging the results of the February 25 presidential election said that the former Anambra governor could not win the poll because he had no wide spread acceptance across the country.

He said that Obi's campaigns were laced with ethnicity and religiosity, which made it unacceptable to the majority of voters.

As he put it, "Obi, will go down as Nigeria's most dangerous and divisive politician. He elevated his well-known clannish mentality to a most unfortunate height by openly anchoring his campaign on religion and ethnicity. He presented himself as a poster boy for and a champion of our country's fault lines. He took advantage of our youths whose expectations are fast paced, who are uninterested in excuses, and who were in search of a hero. He pumped up their sentiments and rode on their emotions while grandstanding as a saviour. It was a false pretence. Obi's credentials are eternally stained as a former governor with no remarkable legacy."

Alake noted that Obi took the advantage of teeming youths to sell his clannishness agenda.

"Not a few of our youths thought Peter Obi looked like the leader they wanted and many of them could not tolerate any form of scrutiny of their newfound hero. They chose wilfully to canonise him while insisting no one should ask questions. The combination of the disgruntled youths, the ethnic champions, and commercial clerics were the reason Obi thought he could win a presidential election in Nigeria. Such illogic is not strange to the Labour Party.

If Labour Party could not fill up its quota for polling booth agents with a shortfall of over 40, 000, how did it intend to compete with political parties like APC and PDP? It would be interesting to see what evidence of rigging Labour Party will present before the court when the party could not appoint agents to monitor nearly a quarter of the venues of election.


As we look forward to an encounter with both the PDP and LP at the court, we want to enjoin the two of them to pursue their grievances with decorum. They should encourage their members, supporters, and ethnic and religious consultants to follow the path of the rule of law.

We note that both Atiku and Obi are claiming victory, wouldn't it make sense for them to agree who the actual winner is before challenging APC in court?", he said.

On Atiku and PDP, Alake commended them for finally opting for the rule of law as against the initial belligerent posture.

He said that those who lay claim to democratic credentials are expected to be conscious of those inimitable minimum requirements of law and order even in the face of a perceived injustice.

"The initial knee-jerk and hothead call for anarchy by their proxies was ill-

advised and would in no way serve any noble cause. It is good to know that reason has prevailed.

Let us say, unequivocally, that we welcome the decision of both the PDP and LP and also the NNPP candidates to test their claims, as ridiculous as they are, in the court of law as provided for by our constitution. This is without prejudice to the conciliatory efforts of the President-elect, Asiwaju Bola Ahmed Tinubu. He has reiterated in his post declaration speeches the need for all Nigerians, irrespective of whom we all voted for, to rally quickly together for the good of our

We must say, however, that listening to both Atiku and Obi yesterday left us in the APC family confounded. We understand that there has been an orchestrated campaign by the acolytes of PDP and LP in the media to discredit the Presidential election. What we did not expect is that the two presidential candidates and, indeed, their political parties, would shamefully re-echo the puerile and unimaginative arguments that are being canvassed by political illiterates and mischief-makers who are crying wolf on the social media," he said.

Alake continued, adding that the two otherwise experienced politicians are pinpointing lack of adherence to the guidelines as basis for discrediting the votes lawfully cast by Nigerians. We shall examine the socalled process that was purportedly breached by the electoral body and how it, in their wild imagination, undermined the credibility of the

He said, "The claim that INEC did not use the BVAS is false. Those who voted across Nigeria, including Atiku and Obi, were accredited by BVAS. Save for bad losers that these two people have proven to be, we should rather be celebrating tremendous improvement the use of BVAS has brought to our electoral process.

The complaint over the electronic transmission of the result is not supported

Quoting Section 38 of the Electoral Act 2022, referred to by the PDP and LP, Alake said the law has nothing to do with transmission of election

"Section 60, subsection 2 of the Act deals with transmission of results and it is at the discretion of INEC. The Act does not contain any mandatory provision regarding the transmission of results.

In any case, the process of transmitting results from polling units, whether realtime, two days later or at any time, cannot in anyway change the results that have been announced right after the counting in the presence of the parties' agents and to the hearing of the voters. It is, therefore, nonsensical to insinuate that time variation in uploading results would cause a change in the figures.

According to Alake, the 2023 Presidential election is a watershed as it produced unprecedented outcomes and defied conventions.

"The deployment and use of BVAS is the only reason the elections produced these strange outcomes and upsets in many cases. The loss of Katsina and Lagos to PDP and LP respectively were contrary to expectations. BVAS brought the intended credibility to voters' accreditation such that many governors and wellestablished politicians lost elections in what should be safe bet areas. The era of ghost-voting and stuffing of ballot boxes is gone. As the experience in the last

governorship election in Osun State has shown, over-voting would automatically lead to outright cancellation of the results of the polling units based on the provision of the new Electoral Act. The same PDP that is trying to pull the wool across the face of Nigerians was the culprit in the Osun State governorship election. Did they try to do it this time and it failed? Or did they do it in the areas they unexpectedly won? Did they have a grand plan to hack the INEC server if results were uploaded in real time? Nigerians will soon find out.

Contrary to the false claims of Atiku and Obi, the reasons for losing the elections were foretold. Besides the delusional expectations created during the campaigns to hoodwink the public, most PDP leaders knew their party had been decimated by Mr. Peter Obi. The South East and South South that were traditional strongholds of PDP constituted the core support base for the Labour Party. PDP went into this election without its limbs and lied to itself that it could win the race. It is worthy of note that Atiku also accepted this fact during his press conference yesterday, when he lamented that his party's votes in the South East and South South regions were carted away by the LP.

The PDP also found itself in No.3 in Kano, with a former member, Kwankwaso running away with over 900,000 votes. How far could the PDP have gone with what was left of it? Not so far as the results of the elections have shown. The members of G5 were key leaders of the party who had substantial political influence. They also went away with their own pound of flesh, leaving a crippled PDP to scavenge for crumps of votes" he said.

# You Are Not Electable, Relocate to Dubai, APC Tells Atiku
