Land Grabbing: Agbamuche Petitions DPP Against Anglican Church

rouble is gradually brewing between the family of the former Attorney General of the Federation Michael Ashikodi Agbamuche (SAN) and Our Saviour Anglican Church, Surulere over an alleged land grabbing by the church.

Agbamuche's son, Chief Michael Agbamuche who accused the church of illegally occupying his mother's landed property on 77 Adebola Street, Surulere said that he had taken a peaceful path to settle the matter with the church but the church authorities had preferred the legal route. Agbamuche who had already served eviction notice to the officiating priest, Rev Abiodun Oderinde in line with the Lagos State public notice of January 29, 2024 regarding illegal conversion of residential areas to business and worship centres, warned that the the church's continuous stay in 77 Adebola Street, Surulere would be at a own risk.

This is coming as Dr. Babajide Martins, the Lagos State Director of Public Prosecutions has revealed that 7,500 petitions concerning land grabbing were received in February alone.

While seeking a legal way to reclaim his mother's property, the church is also set to meet the family in court as the Bishop of Lagos Mainland, Akinpelu Johnson, has asked Agbamuche to meet with the Church's legal officer over the issue.

He said, "Only the church legal officer can react to the allegation." In one of the numerous letters that Agbamuche sent to the parish, the church's general

secretary simply replied: "Please report this at the Bishop's office in Lagos."

Also, the registrar of the Lagos mainland diocese sent a WhatsApp message to Agbamuche saying that he had read all his correspondences and had observed some errors.

As he put it "I have read all your correspondences and they are all appreciated. You see, as long as you continue to erroneously hold the position you are holding, it is a challenge to engage with you. That property was purchased by God and I will subtly refer you to Numbers 23 verse 19.

"We are an orthodox church that is well rooted in doctrines and faith in our God. Don't wish that away. On the other hand, our Bishop is not a roadside mechanic. He is, and rightly too, a very humble servant of the Most High and deserves every respect. God bless you sir."

At present, Agbamuche had accused Our

Saviour Anglican Church, Surulere of violating the land grabbing laws of Lagos state by occupying his bequeathed property illegally without offering any consideration for it. In the letter dated February 1, 2024, he

My late mother after 30 years of service for the Lagos state government from the 1950's when she returned from her studies abroad, ioined the Lagos medical services in the 60's and was opportune to take advantage of the relative ease of acquiring property in Nigeria, especially in Lagos those happy days.

"She, therefore, secured the mortgage that enabled her to acquire the property known as 77 Adebola Street, Surulere, using only her income as a civil servant and after years of such service she fully paid off the mortgage and decided to retire and return to her hometown in Akwa Ibom state."

According to Agbamuche, she decided to put the property up for sale, found an estate surveyor to market the property and set a reasonable price consistent with the value at prevailing market rate at that

time.

This registered surveyor, he said, was able to get several interested buyers including the Church.

"Whilst I was not party to the discussions between herself and the church officials, I was duly briefed by my late mother and she handed over to me her only copy of the deed of mortgage before she left Lagos to Eket, Akwa Ibom.

"It was at that period I got a hint of misfeasance in the entire way she was handled by both the church and the so-called surveyor as it turned out that she was never actually paid by the church directly," he explained.

He stated that the church did not pay the owner of the property till date, an indication that the transaction was invalid.

Agbamuche said despite drawing the attention of the Bishop of Lagos Mainland, Akinpelu Johnson to these facts, he has refused

to do anything about it and rather.

In 2016, Lagos state enacted an act to curb land grabbing. In a bid to tackle the unscrupulous

activities of land grabbers in the State, the Special Taskforce on Land Grabbers under the State Ministry of Justice was created.

The law is not limited to forceful occupation of the land, it covers those who may have used fraudulent way to commit the offence.

According to the Commissioner for Justice and the state Attorney General, Mr. Lawal Pedro, SAN, the law prohibits forceful entry and illegal occupation of landed properties, as well as violent and fraudulent conducts in relation to landed properties in the State.

Pointing out that resolving land-grabbing issues is of great importance to the Sanwo-Olu Administration, Pedro stated that the menace of Land grabbers has led to conflicts on lands in the State which has resulted in the destruction of properties and even loss of lives.

The Attorney-General emphasised that the law on land grabbing that was enacted in 2016 still stands regardless of one's status in society.

He explained some of the provisions of the Lagos State Property Protection Law, 2016 and in particular, Section 2(1) of the Law, which prohibits the use of force or self-help by anyone to take over any landed property or engaging in any act inconsistent with the proprietary rights of the owner of any landed property in Lagos.

Meanwhile the state government is considering revising its laws on land grabbing in response to evolving circumstances, as noted by the Coordinator of the Lagos State Special Task Force, Rukayat Shomade.

Lagos Assembly Intensifies Oversight On Department, Agencies

Committee set up by the Lagos State House of Assembly has embarked on an oversight to Ministries, Department and Agencies (MDA) in the the Assembly state to ensure progress and accountability for the state's growth The Committee on Judiciary, Human Rights, Public Petitions and LASIEC informed that the visits to the agencies is one of the core responsibilities of the Assembly and directed by the Legislative House Speaker, Hon. Mudashiru Obasa.

The exercise which is to run till May 8 is also put together in order to establish a cordial relationship between the Assembly and the MDAs for the progress of the State, as uttered by the Chairman of the

Committee, Hon. Oladipo Ajomale.

Leading the team, who led the team, Ajomale said that the the findings and recommendations during the visit would be deliberated on by members, hence, leading to necessary actions taken to curb any anomaly as well as improving on the strengths of the MDA's.

During the meeting with the Taskforce on Land Grabbers,

the Coordinator, Lagos State Special Taskforce, Shomade Rukayat, explained that the department oversees the issue of land grabbing in the State.

Listing some challenges of the Special Task Force to include court adjournments and



interference, Rukayat called for synergy with MDAs while urging for a full upgrade of the Office to an Agency for better efficiency.

She also expressed optimism that the Land Grabbers Law of Lagos State would be reviewed to meet new developments.

At the Domestic and Sexual Violence Agency, the Executive Secretary, Mrs. Titilayo

Vivour-Adeniyi, explained that the and sexual violence in agency is an organisation committed to ensuring total eradication of sexual and gender-based violence in the State.

She said, "Our mission is to provide sensitive services to victims of domestic and sexual violence while promoting healthy relationships as we strive to enhance our coordinated community

response to domestic Lagos State and indeed in Nigeria.

"The inadequacy of running cost, issues with decentralized services and sub-offices as challenges faced by the agency.

" We also seek for the establishment of more designated Police stations to facilitate reporting and investigation of cases, increased capacity during weekends.

Vivour-Adeniyi further requested for an amendment of the Law guiding the agency to make it possible to criminalize spousal battery a n d decentralisation of operations.

Ajomale thereafter, directed that all requests should be put in writing and submitted to his Office for further scrutiny The Committee head also said the team will visit the Citizen Mediation Centre (CMC) as well as the Office of the Administrator-General and Public Trustees, Office of Public Defender, and Lagos State Independent Electoral Commission (LASIEC) to complete the exercise.

Other members of the committee during the visit included, Hon. Kehinde Joseph, Hon. Ajani Owolabi, and Hon.Bonu Solomon.

80-Year-Old Protests At Lagos Assembly Over House Demolition

n octogenarian has led a mob to the Lagos State House of Assembly to stop the state's Attorney General from discontinuing a case of demotion of her house.

The complainant, Bello Muniat, on Tuesday, and other protesters, the members of Kumeifo Oba Olaribigbe in Lagos Island submitted a petition over the matter at the Legislative Complex urging the Assembly to appeal to the attorneygeneral to allow justice to prevail.

The 80-year-old who accused one NollahSikiru of the demolition of their family house said, "We

are here for a protest because of what is happening between the family KumuyifuAkinyigbe family with the Attorney-General of Lagos State, Mr Lawal Pedro, a n d SikiruNollah.

"Our prayer is that we want the House of Assembly to stop him not to strike out the case in court because if he does, there will be unrest in the area.

"We are begging the attorney-general to leave our case alone and let justice prevail on the issue.

"The civil side is in the high court before Justice Ogunjobi, while the criminal side against NollahSikiru is the one that the

attorney-general wants to strike out.

"We are just wondering how the attorney-general that said the accused person has a case to answer suddenly turned back and said Nollah has no case to answer," he

Bello disclosed that the Director of Prosecution in the Ministry of Justice did their findings and got to know that the the accused had a case to answer, according to the report of the Department of Public Prosecution

"The case was charged to court in February, so we have been in court for the first, second and the third adjournment but the Nollah has refused to show up in court, then the judge had no alternative than to issue a bench warrant against the accused person.

"After the bench warrant was issued the Attorney General of Lagos State had the gut to say that he didn't send the prosecuting panel to collect a warrant of arrest for the accused person.

"We are now wondering what is happening and how can he do that. He was the one that sent the DPP officials and they came and said the accused person has a case to answer.

"Now that the case is going on, the attorneygeneral allegedly filed a notice of withdrawal of the case," she said.

"We wrote a petition to

the Lagos State Control Building Agency (LASCBA) to know whether they were the ones that gave the order to demolish their house ,but the agency said they did not know anything about it.

"The Attorney-General wrote to them in another letter attached to the one he was using to strike out the case that the agency said they were the one that asked Sikiru to demolish the family building".

The Deputy Majority Leader of the House, n AdedamolaKasunmu, calming the situation said the lawmakers will look into the matter and provide necessary steps in bringing the laws of the state in it.

"We have heard your complaint you have brought to us because there is nobody that will labour and want another unknown person to destroy what the family has laboured for over the years," the lawmaker said. "So, because of this, we will receive the petition you have brought to us and we will present it to the Speaker and I want to assure you that the family will get justice at the end of the day.

"I appreciate your family for the peaceful protest and I urge you to go home peacefully and avoid any trouble so we could continue to remain on the right side of the law.

Five Okada Riders Arraigned In Court For Assaulting Policemen

ive suspects have been arrested by the Lagos State Police Command for assaulting police officers at Ikorodu area in Lagos

The accused commercial tryicyclists were charged with conspiracy, commit to felony, causing bodily injury, rioting and causing breach of peace in the area.

According to the Police Prosecutor, Haruna Magaji, the quintet: Damzuru Musa, Khalid Yaya, Shaaban Haruna, Bashiru Yinusa, and Tijani Musa allegely commited the offences on March 25, 2024, at 7:00 am.

Magaji stated at the Yaba Magistrates' Court where suspects were arrainged that a distress call was put through to the the Ikorodu Police Division that the alleged victims identified as Inspector Adebisi Michael and Sergeant Idako Yusuf, all attached to Mopol 2, Ikeja, were under attack from the okada riders at the Igbodu Junction, ljede in Ikorodu.

The prosecutor said that the okada riders were protesting over a matter in the area. They saw the police officers and proceeded to throw stones at them, physically assault them, and burn a motorcycle belonging to one of the officers.

Following the call, the Divisional Police Officer led a team to the scene and discovered that the service pistol of one officer was stolen, and a motorcycle belonging to one of

them was set ablaze. Magaji added that statements from eyewitnesses and the assaulted officers serve as evidence against the defendants. He said the alleged offences violate Sections 411, 162 (1) (d), 172, and 341 of the Criminal Law of Lagos State 2015.

The defendants pleaded not guilty to all four charges.

Magistrate Olatunde Adefope set the bail at N500,000 each, with two sureties in like sum. He ruled that the sureties must be gainfully employed with verifiable addresses.

Adefope adjourned the case till May 22, 2024.



Flood Control: Lagos Govt Embarks on Removal of Structures on Drainage Setback

he Lagos State Government has said that the ongoing removal of all contravening structures under the System I drainage channel midstream (Odo Iya Alaro) Ojota and Ogudu, will admajor flooding issues on the mainland and its environs.

State Commissioner for the Environment and Water Resources, Mr. Tokunbo Wahab made this assertion when he led some officials on an inspection tour to the enforcement sites to ascertain the level of compliance owners and the extent of work.

He explained that System I was established in 1974 and it is the biggest and widest Primary Channel that defloods the major parts of the mainland which cuts across Ogudu, Ojota, Ifako, Gbagada and Maryland, adding that the flyover bridge coming from Odo lyaloro will cut across these areas.

Wahab stressed that the Government has been having discussions with p r o p e r t y owners/residents since the year 2021 and the conversation ended in November 2023, stating that contravention notices have been served to owners of buildings lying within 140 metres of System I since year 2021.

"We found out that people have gone back to encroach on the right of way and alignments. Since 2021, we have been engaging the homeowners and residents where the residents where the government has been notifying them of i m p e n d i n g enforcement without which we cannot abate flooding", he

The Commissioner explained that property owners whose buildings fall within the approved 140 metres Right of Way of the channel had been given the option of voluntary compliance for almost three years now.

He added that the government also discovered that while contravention notices had been served and dialogue on a way forward was being explored, some of the

property owners continued with the construction of new buildings that surfaced in the areas now.

He explained that the property of the explained that the property of commenced the enforcement but were foot-dragging.

According to him, the conversation ended officially in November last year when they were asked to come forward with their documents and approvals and we found out that most of them do not have any.

He stressed that it has been observed that all the structures on the System I Right of Way have no valid documents from the government as such all the structures will have to be removed

He stressed that the original dimension was 140 metres before the alignment but the State government is willing to put a human face to the enforcement process.

the State Drainage Master Plan to avoid property demolition insisting that there was no going back on the decision of the state to enforce the law and reclaim Drainage setbacks following the expiration of the notices issued.

He advised residents to always visit necessary Government agencies when doing their land searches, especially the Ministry of the Environment and Water Resources to get their Drainage clearance as this will suffice for them in case of any occurrence in future.



NIN-SIM linkage: MTN Deactivates 8.6M Lines

o fewer than 8.6 million MTN network users have been barred from using their SIM cards for refusing to link their SIMs with their National Identification Number (NIN) following the directives by the Nigerian Communications Commission (NCC). This was disclosed by the company in its first quarter (Q1) 2024 financial report, noting that this impacted its business in the quarter.

However, to provide more time for the subscribers with less than five lines linked to an unverified NIN to complete the necessary verification exercise, MTN disclosed that the NCC has extended the 15 April deadline to 31 July 2024.

According to MTN, the lines that have been fully barred are those of subscribers who did not submit their NIN and those with more than five lines linked to an unverified NIN.

Highlighting the impact of the NIN-SIM linkage exercise and the regulatory directive, MTN Nigeria's CEO, Karl Toriola, said: "During the quarter, we also continued to manage the effects on our business of the industry-wide directive of the Nigerian

Communications Commission (NCC) for a full barring of subscriber lines not linked to their National Identity Number (NIN) – the NIN-SIM directive.

"This impacted the development of our user base across all of our key business units (voice, data, and fintech) in Q1 2024.

"Although we had to fully bar 8.6 million subscribers in line with the directive, we minimised the net effect of the barred subscribers, and our total number of subscribers only decreased by 2 million in Q1, closing with a total of 77.7 million subscribers." Toriola said this demonstrated the

effectiveness of the company's customer value management (CVM) initiatives, which helped it to retain affected customers and reduce churn, as well as to drive gross connections.

Meanwhile, the company also reported a decline in its data subscribers in the quarter under review. According to the MTN's CEO, active data subscribers declined marginally by approximately 78,000 to 44.5 million.

"Notwithstanding these headwinds, we recorded increased activity within the base, with voice traffic rising by 5.1% and data traffic by

40.6%.

"This is a result of the consistent growth in demand for data and voice, supported by our attractive offers to customers and continuous investment in network quality and coverage," Toriola stated.

Data from the NCC show that total active mobile subscriptions in Nigeria across the networks of MTN, Airtel, Globacom and 9mobile, which stood at 224.4 million in December 2023 had declined to 219 million as of March 2024 as all the telecom operators implemented the policy on the mandatory NIN-SIM linkage.
