n March 11, 2023, another history would be made in Lagos politics as a new political dispensation would birth with a new governor.

The governorship candidates of the ruling party, All Progressives Congress (APC) and the major opposition party, the Peoples Democratic Party (PDP) as well as other political parties will slug it out with one another for the covetous post of the state governor.

The sitting governor, Mr. Babajide Sanwo-Olu will be representing APC, the Lead Visioner of Lagos4Lagos Movement, Olajide Adediran (Jandor) will fly the PDP's flag while the former chairman of Surulere Local Government, Hakeem Olaogun-Dickson will be contesting on the platform of Accord Party (AP).

The race to 2023 governorship elections in Lagos State might shape up to be very fascinating considering the activities, popularity and weight of each candidate.

The primaries, held on May 25 and 26, produced Sanwo-Olu as the APC candidate and Adediran as the PDP flag bearer while the Accord Party's primary was held on May 30 where Dickson was unanimously picked by the party as its candidate. Before they emerged as the candidates of their parties, there had been internal crises in some parties especially the PDP.

For the PDP to present a formidable fight in the state in 2023, it has to find a solution to its never-ending internal crisis.

Though the Accord Party is trying to put its popularity and that of its candidate to test, with little or no action from the other political parties in the state, political analysts still believe that the 2023 governorship election in Lagos State will be, as has been the tradition for about two decades, a contest between the two major parties - APC and PDP.

Based on the internal politics which played out to produce Adediran, Jandor as he is popularly called, analysts said it might be difficult for







the party to put up a good fight during the general election.

PDP in Lagos is notorious for its infighting, particularly during election seasons, prompting speculations that the party is populated by APC moles.

The party had more aspirants for the party's ticket: Ade Dosumu, AbdulAzeez Adediran, David Kolawole, Olanrewaju Jim-Kamal, Adedeji Doherty, and Gbadebo Rhodes-Vivour.

Following the emergence of Adeniran, some other aspirants felt cheated and showed their grievances.

Adediran, a former member of APC. joined the PDP in January, this year and declared his intention to run for governor on the PDP platform two months later.

At his declaration in March, Adediran said the APC reign in the state had come to a terminal point.

"There is a terminal point for everything and the terminal point of APC in Lagos is 2023. We were the APC, we have created that implosion in APC and we are now in PDP.

"PDP has been doing between 30 percent and 34 percent in every election year. So, the 20 percent which PDP needs to cross that threshold is what we have brought in from APC to PDP."

Ade Dosunmu, an aspirant, was the party's candidate in 2011 when they lost to the then incumbent governor, Babatunde Fashola.

The margin of loss that year remains the widest margin of defeat in the state's gubernatorial election since 1999.

Dosunmu represented the party again in 2015 in the Lagos Central senatorial election. He lost to the APC's Oluremi Tinubu.

Adedeji Doherty, another aspirant and a founding member of the party in the state, was the state chairman in 2019 before a court removed him two years later.

Mr. Jim-Kamal, who also ran for the party's ticket, said the party has been losing elections in the state because of imposition.

"I opted out in 2015 when I discovered somebody was to be imposed on us."

Analysts said if the PDP in the state can put its house in order, and with a key APC member now in its fold, it might stand a chance of causing an upset at the poll in 2023.

A source within the PDP said Adediran's emergence as the party's candidate which was viewed by some as imposition could

further throw the party into a crisis. Apart from this, some of the political analysts who spoke to ECHONEWS believed that it would be difficult for Adeniran to break the stronghold of APC backed by the party's presidential candidate, Asiwaju Bola Ahmed Tinubu.

Kehinde Samuel said: "The contest is between Jandor of PDP and the incumbent governor from the ruling party, Mr. Babajide Olusola Sanwo-Olu. The other guy whose name you just mentioned will barely get sizeable votes and Jandor will only try. Sanwo-Olu will win for the second time because the calculations are in his favor.

"He is the incumbent and his party leadership is strongly with him. In governance, Sanwo-Olu has been at his best and he will hope to consolidate his achievements when he gets reelected. Jandor might come near but Sanwo-Olu will win." Another political watcher, Saheed Akintunde said: "PDP seems to be a stronger force now and I have this belief that they will give APC a run for their money this time around. It won't be business as usual come

"Jide Adeniran is contesting to win, unlike the party's last gubernatorial candidate who was just contesting to make money through negotiation. It will be a serious contest between APC, PDP and let's say Accord party too because they are there to spoil the vote.

"If either APC or PDP can approach Accord for negotiation it will be a plus to their side because having a loose end might be costly to either of the two strong forces. I can't say who will win now because it will be a keenly contested election."

Meanwhile, Dickson, following his emergence as the party's candidate, had boasted of victory in the coming governorship race in the

He appealed to the teeming youths for their collective support to the party to ensure total victory in the general elections.

He said: "We need the youths to take over governance and through seminars, workshops and professional training, we will get it done.

"We are not a violent party and we assure the people that there won't be any form of violence from us."

According to him, with the kind of unity among members of Accord, "We are ready and eager to take on the APC, PDP and other 15 political parties next year 2023."



CPN charges govts on child protection

hild Protection Network (CPN), Lagos chapter has called on the governments at all levels and other stakeholders to effectively prevent, protect and assist children who are victims or at risk of harmful practices.

According to the organization,, they should look critically at the challenges they are currently facing, address the harmful practices and list strategically steps that could be taken to improve the protection of children against harmful practices in Nigeria and Africa.

Speaking at the Day of the African Child (DAC) 2022 Celebration, organized by the body at Bimbo Odukoya Foundation, State Secretariat of CPN, Ilupeju, Lagos, the CPN Lagos State Coordinator, Aderonke Oyelakin, noted that Nigerian children still experience harmful practices and so also other children in Africa.

"CPN goal is towards the protection and assistance of children who are at risk and victims of harmful practices in Nigeria and we use this day to call on all relevant stakeholders who are working in the area of children's rights on the continent in order to reinforce their efforts in addressing the obstacles related to harmful practices affecting children.

state, our core is to prevent and respond to children related issues and provide apt and efficient

Identifying the harmful practices against children, Oyelakin said: "Harmful practices include, amongst other forms of abuse, child marriage, forced marriage, FGM, breast flattening, hate crimes, child abuse linked to faith or belief and so-called honourbased abuse.

"Harmful practices are persistent practices and behaviours that are grounded on

discrimination based on sex, gender, age and other grounds as "CPN is across the 20 LGA of the well as multiple and/or intersecting forms of discrimination that often involve violence and cause physical and/or psychological harm or suffering. Harmful traditional practices are particular forms of violence against women and girls which are defended based on tradition, culture, religion, or superstition by some community members.

"In a nutshell, harmful practices refer to behaviours and practices which are harmful to people's physical and mental health.'

A variety of harmful practices exist, including 'FGM, child and forced marriage, virginity testing and related practices, extreme dietary restrictions, including during pregnancy (force-feeding, food taboos), binding, scarring, branding/infliction of tribal marks, corporal punishment, stoning, violent initiation rites, widowhood practices, accusations of witchcraft, infanticide, incest and body modifications that are performed for beauty or marriageability of girls and

"Harmful practices affect the child's physical and mental health in the short and longer-term, impair their ability to learn and socialize and impact their transition to adulthood with adverse consequences later in life which we refer to as ACE- Adverse Childhood Experiences."

Mranwhile, she noted that progress has been made in some African countries but it is still not

Speaking on the theme of the celebration "Eliminating Harmful Practices Affecting Children: Progress on Policy & Practice since 2013", Oyelakin said it was selected by the African Committee of Experts on the Rights and Welfare of the Child (ACERWC) for the celebration of the DAC in 2022. She, therefore strongly advocated for proper education of children, saying: "Educating children lifts them out of poverty".

The state Engineer who simply wants to be addressed as Engr. Ifeanyi disclosed to ECHONEWS that a wall was constructed within the canal to help reduce

the flow velocity and direct flows to its right channel without interceptions.

He noted that the cause of the flood experienced by the community members was caused by flow interjection coming from the North, East and West side of the canal.

With the separation of curve lines within the canal, Engr. Ifeanyi stated that it will help regulate flows from different axis without hindering the major flow coming from the up stream of the canal.

He further explained that the curve lines constructed within the canal is about 20 meters long and 1.5 meters in height to reduce the flow pressure.

NSC predicts difficulty in Lekki port

he Nigerian Shippers' Council (NSC) has said import and export trade could be obstructed due to difficulty in executing cargo evacuation.

The Secretary of the council, Mr Emmanuel Jime said Lekki Port might in some cases experience a similar situation as Apapa and Tin Can ports which would jeopardize Nigeria's economy.

He noted that cargo evacuation specifically would both be influenced in the import and export areas as the road condition is not encouraging.

Jime noted that he has been

reaching out to the government, agencies and private stakeholders involved in the project but has yet to get a response based on the accessibility of the port ahead of the still-tocome September resumption.

He said government representatives have only been giving unrealisable promises to the media, saying there will be solutions to the road networks and other transport modalities.

In the meantime, he suggested the use of barges for the evacuation as the road connection cannot be possibly fixed before the operation commences.

The team of female lawyers recently made the call at the inaugural session of the FIDA Lagos 2022 Law Week, held at the Nigerian Institute of International Affairs, with the theme 'Education As A Catalyst For Boosting The Self-image Of The African

According to the conveners of the event, Nigeria records the largest figures of out-ofschool children, ranking 5th globally with about 10.19 million out-of-school children, amounting to 34 per cent of the total population of children in the country.

The FIDA Regional Vice-President, Joy Ezeigbo, hinged on parental primary responsibilities anchored on the principle of "intentional parenting", implying that parents should engage the children based on their academic or vocational interests, rather than foisting on them the parents' choice of career.

"Parents have the primary responsibility in the development and upbringing of their children, but in carrying out that primary responsibility, the best interest of the child should be bored in mind, adding that a situation where children study in a hostile environment would invariably reduce their productivity."

The Director, Institute of Humanities, Pan-Atlantic University, Ifeyinwa Awagu, expressed dismay over the poor handling of the curriculum in Nigerian schools and proposed a holistic overhaul of the curriculum and the education system as a

whole.

"The curriculum is not about what is in black and white, but more about what we do with it.

True, our curriculum has issues that should be looked into, but, it's more about how we teach the content than about what the content is." Other speakers insisted that "education does not have to be formal" and enjoined parents

to consider non-formal education that could help bring out the best in their children.

he Nigerian Bar Association (NBA) has started registration for its 2022 Annual General Conference billed to hold in Lagos between August 19 and 22, 2022.

A statement signed by Tobenna Erojikwe, Chairman, Technical Committee on Conference Planning (TCCP), indicated that registration for the conference opened on June 12, 2022 with an early bird registration window.

Erojikwe added that participants are to register for either physical or virtual attendance through.

Renowned Nigerian author, Chimamanda Ngozi Adichie. will be the Keynote Speaker at the conference which will hold at the Eko Atlantic City, Victoria Island, Lagos, under the theme "Bold Transitions".

The statement further indicated that early bird registration for the conference will run from June 12 to July 17, while regular registration will start on July 18 and end on August 5, 2022. Late registration will run between August 6 and 12, 2022, while registration for virtual attendance will be ongoing.

The statement reads: "The core objective of the 62nd edition of the NBA Annual General Conference is to host a world-class conference, with in-depth discourse on critical issues affecting the legal profession and the country, facilitated by the most eminently qualified resource persons able to galvanize all conference attendees towards the path of becoming better legal practitioners and experts in their chosen fields; shape public opinion on critical issues: and inspire lawyers to build the law firms of the future.

"The registration fees are broken down according to categories. There has also been a significant reduction in the fees for virtual attendance compared to 2021.

"Lawyers in the category of 1-5 years of practice will pay N15,000 for early bird registration, N40,000 regular registration, N80,000 for late registration, and N5,000 for virtual attendance as against N7,500 charged last year.

"Lawyers within the 6-10 years category will register with N22,000 for early bird, N60,000 for regular. N120,000 for late registration, and N10,000 if they want to participate virtually compared to N11.250 paid for virtual participation last year.

"Lawyers who have practiced between 11-15 years will pay N36,000 registration fee if they make use of the early bird window, N70,000 for regular registration, N140,000 for late registration, and N15,000 for virtual attendance, N3,000 less than the N18,000 charged last year.

"For lawyers between 16-20 years, the cost is N54,000 for early bird, N80,000 for regular, N180,000 for late registration, and N20,000 for virtual registration compared to N27,000 paid in 2021.

"Lawyers who have more than 20 years of practice will pay N95,000 if they come as early bird, N150,000 for regular, N300,000 for late registration, and N30,000 for virtual attendance, a whopping N17,500 reduction from what it cost them to attend virtually in 2021.

"Senior Advocates of Nigeria. Attorneys General, and Benchers will pay N190,000 early bird, N300,000 regular, N500,000 late registration, and N50,000 for virtual participation, N45,000 less than the N95,000 they paid last year.

"It will cost Magistrates and other Judicial Officers N50,000 to register if they use the early bird window, N50,000 regular, N50,000 late registration, and N20,000 for virtual attendance compared to N25,000 for last year.

"Honourable Justices. Honourable Judges, Grand Khadis and Khadis will pay N75,000 registration whether they come as early bird, regular registration or late registration. However, if they wish to participate virtually. the cost is N25,000 instead of N37,500 they paid in 2021.

"For non-lawyers who want to attend the conference, the fee is N100,000 irrespective of whether it is early bird. regular or late registration. If they want to register to attend virtually, the fee is N30,000, N20,000 less than last year's fee. Onabanjo pointed out that the club saw the need to assist the community with provision of water as an intervention to prevent possible outbreak of water borne diseases in the community as the residents have been compromising their hygiene by depending solely on water supply by itinerant vendors dispensing the commodity in plastic kegs.

He added that apart from not being sure of the source of

the water supplied by the residents clean water vendors, the residents pay exorbitant prices to enjoy the service which puts an additional burden on them in the face of the worsening economic situation in the country.

"Up till now, the people in the area have no access to the government pipe-borne water. majority of the people seek succor from mallams for their daily water supply which is quite expensive and unhygienic. But beyond the convenience of giving the

nearby, we are also saving the community from possible outbreaks of waterborne diseases."

However, he felt disturbed by the stop of the water supply from the club due to the sudden hike in the price of diesel used in pumping the water for the public.

He assured that very soon the challenge would be surmounted to pave way for the residents to start fetching water again. courtesy of his organization.
