Lagos insists Parks Ad-Hoc Committee Legal

No doubt, the Lagos state government is not happy with the verdict of the National Industrial Court that nullified a purported caretaker committee from managing the garages and parks in the state and reinstated the operations of the Road Transport Employers Association of Nigeria (RTEAN).

The government described the caretaker committee as purported because, as it claimed, at no time did it inaugurate a body with such name and that the only committee it created was the Garages and Park Administrators Ad-hoc Committee to oversee its garages and parks.

It has therefore dissociated its own committee from the one addressed in the judgment given in the case brought against the Lagos State Government by RTEAN insisting that both are not the same.

It said the Garages and Parks Administrators Ad-Hoc Committee has not been nullified by the Court.

This is the kernel of the case that the Lagos State Government will argue when the appeal comes up soon.

Recall that RTEAN instituted a suit with ID number: NICN/LA/381/2022, in October 2022 to challenge the Lagos State government for allegedly dissolving the elected executive committee of its union in the state and appointing a caretaker body, known as the Parks and Garages Administrators.

The defendants in the case are the Governor, the Attorney-General of the state, and Sola Giwa, who is the Special Adviser to the state governor on

transportation.

In her judgement, Justice Maureen Esowe held that the act of the Lagos State government in suspending the national union operations in the state and setting up a caretaker committee is illegal and against the provisions of Sections 4 (1), (2)& (3), and 5 (1) &(3), read along with item 34 of the exclusive legislative list, of the 1999 Constitution, as amended.

However the counsel to the state, Adebayo Haroun held that government did not violate the law nor dissolve any union national body's operations in the state but had sought to maintain law and order by creating an ad-hoc committee when violence ensued between the unions.

He said, "The government issued a document to ensure public safety and order. And since the ad-hoc committee was set up, there has been peace,"

Giving her verdict, Justice Esowe however held that the government and the Police should have intervened by arresting and prosecuting those behind the fracas and not to set up a committee to usurp the union executive.

Disturbed by the judgement, the state has begun a process to appeal the judgement as the Ministry of Justice has requested for a copy of the judgment to enable it study and raise more counter-arguments on why the verdict of the Lower Court should not stand

In a statement by the Director of Public Affairs, Mrs. Grace Alo, Lagos Ministry of Justice, the state government said it has applied for the copy

of the judgement and would be filing an appeal.

The statement reads in part, "Our attention has been drawn to reports on various media about a Judgment delivered by Honourable Justice Maureen Esowe in respect of Suit No NICN/LA/381/2022 between Road Transport Employers Association of Nigeria and the Executive Governor of Lagos State and 36 others.

The statement argued that It is on record that what the Lagos State Government set up is known as the Lagos State Park Administrators Ad-Hoc Committee on the Operations of Commercial Road Transport Workers Activities within Garages and Motor Parks and not a Caretaker Committee.

It stated that the Ad-hoc committee was not set up to run the affairs of the Road Transport Employers Association of Nigeria (RTEAN) in Lagos State as being interpreted by the association.

With this argument, the statement said that the reliefs sought from the court by the claimant, which includes a declaration that the purported dissolution of the Elected Executive Committee of the claimant operating in Lagos State and appointment of a Caretaker Committee to run its affairs in Lagos State had nothing to do with the Lagos State Park Administrators Ad-Hoc Committee and its functions.

It stated that several of the reports in the media had mistakenly attributed to the Judgment that the Lagos State Park Management Committee (Committee) has been dissolved.

"The validity of the Lagos

State Park Management Committee was not an issue before the Court and the Committee was not a party to the suit. The dissolution of the Committee is totally unrelated to the issues before the Court", it stated.

However, the statement said that the Lagos State Government had applied for the Certified True Copy of the Judgment and intends to file an appeal in respect of same.

"All affected parties are enjoined to remain calm and be law abiding," it

said.

There has been renewed hostilities in the transport sector following the verdict as loyalists of RTEAN and Garages and Parks trade words over the orders of the courts.

No date has been fixed to hear the appeal.

Ministry of Tourism Trains Staff on Communication and Writing Skills

The Permanent Secretary, Lagos State Ministry of Tourism, Arts and Culture, Mrs. Oyinade Nathan-Marsh has underscored the need for the staff of the Ministry to be eloquent in speaking and prolific in writing, saying that the place of effective communication in the public service cannot be overemphasised. Nathan-Marsh stated this on Thursday during the closing ceremony of a three-day in-house training organised for staff of the Ministry on "Communication Skills and Effective Writing Workshop", held at STO Resource, Alausa Ikeja. She said that the training session was designed to expose some of the newly recruited Tourism and Cultural Officers to acceptable writing patterns and styles within the Civil Service and also hone the communication skills of other staff who are also participants in the training workshop.

According to her, the nature and schedule of duties of the officials of the Ministry, require everyday interpersonal and intra-personal communication and interaction with both local and international tourists, hence the need for the officers to sharpen their skills both in speaking and writing. She added that the Ministry can only deliver on its mandates of promoting and marketing the State's tourism assets, potentials and tourism products if the officers are skillful in effective communication through the writing of convincing submissions and justifiable proposals that give credence to the

Ministry's plans, programmes and Policies. The Permanent Secretary emphasised the fact that writing for the government is different from other forms of writing, and as such, government officials, especially newly employed staff, require special training sessions, workshops and on-the-job learning processes to be able to communicate effectively within the public sector. In her words: "The Public Service thrives on communication. Whether inter-service or with external stakeholders, the effectiveness of Public Service communication is a critical factor in the measurement of Government activities. Public Servants must therefore possess excellent writing skills if the intentions of the Government must be communicated

effectively". Nathan-Marsh, who expressed confidence in the capacity of facilitators for the training workshop based on their impeccable track records, urged the trainees to be prepared to bring to practice all they have learnt such that there will be a noticeable improvement in their

various work schedules going forward. One of the facilitators, Kemisola Jiboye, told the trainees not to be complacent with the knowledge acquired during the workshop but be deliberate about self-improvement through learning, relearning and unlearning, stressing that

learning is a continuous process and a journey that has no destination. The training consultant, who is also a retired Director from Lagos State Public Service Staff Development Centre, Magodo, explained that during the three days programme, the participants were

exposed to "Effective Speech Writing", "Effective Report Writing", "Effective Writing Skills", "Essentials of Public Service Writing" and "Writing Submissions, Memos", in addition to several practice sessions and group presentations.

FG May Open Rehabilitated Eko Bridge on May 31

Works on the rehabilitation of Eko Bridge may have been completed before end of May and the road open to motoring activities by May 31.

This Federal Controller of Works in Lagos State, Engr. Umar Bakare said this a few days ago while briefing journalists on the cooperation of the federal and state governments to manage the traffic gridlock on Lagos-Ibadan Expressway.

He said, "On Eko Bridge, the rehabilitation works of

the bridge are ongoing, especially at the fire-damaged section of Apongbon. Work is being concentrated on the restoration of the structural defect caused by the inferno, and once it is completed, the bridge will be opened to traffic by the 31st of May, 2023 while work will continue on the other sections of the rehabilitated bridge.

On the Lagos-Ibadan Expressway, Bakare solicited the cooperation of the motoring public in terms of compliance with traffic rules and regulations which will further improve

movement around the construction zones.

Umar Bakare explained that the three existing lanes which the contractor usually worked with had to be reduced to two at each of the construction sections, thereby resulting in traffic buildup. He, however, assured that the FRSC, LASTMA, and TRACE officers are usually on site to control traffic.

He said the contractor is rounding up work around Opic and with the completion of the Asphalt works, the section will be open to traffic by Monday while the Berger axis too will

be completed by the end of April.

The Controller of Works further explained that the contractor has increased the number of working gangs to four in order to increase the pace of work towards meeting up with the deadline of April.

The Lagos State Government has reiterated its commitment to continue consultation with the Federal Ministry of Works and Housing on Traffic Management of the construction corridor of the Lagos-Ibadan Expressway even as the work is ramping up to

completion.

The Lagos State Commissioner for Transportation, Dr. Frederic Oladeinde, who disclosed this during his working tour of the construction zones at Opic, Kara, and Berger axis, assured the motoring public that he will continue to hold strategic meetings with the Federal Ministry of Works and its project Engineers to review the mode of works and proffer solutions that can ease the strain of traffic impact faced by road users.

Reiterating that the Federal Government is expediting actions to

complete the project at record time as announced by the Minister of Works and Housing, the Commissioner stated that the Lagos State Traffic Management Authority (LASTMA) and its Ogun State counterpart, TRACE, are working in collaboration with the Federal Road Safety Commission, (FRSC) to ease the gridlock on the corridor.

Oladeinde expressed sympathy on the plight of motorists plying the corridor, appealing for calm as the construction works will soon be completed.

Ijegun-Ijagemo Road: Lagos Govt Urges Affected Property Owners To Tidy up Documents For Compensation

The Lagos State Lands Bureau has urged those whose property would be affected by the construction of Ijegun-Ijagemo road construction to tidy their documents and submit to the Permanent Secretary, Lagos State Lands Bureau to allow the State Government perfect their compensation.

The representative of the Permanent Secretary of the Land Bureau, Mr. Deji Ige made this call at a stakeholders meeting to sensitise the beneficiaries. Meanwhile the traditional leaders of the community, the Onijegun of Ijegun Kingdom, Oba Nureni Akinremi Olomitutu and Baale Ijagemo, Chief Jimoh Balogun thanked the Lagos State Government for bringing the project to their domains, whilst pleading for the execution of its second phase.

Speaking at the meeting, the state Commissioner for Physical Planning and Urban Development, Engr. Tayo Bamgbose-Martins said that the construction of Ijegun-Ijagemo Road in Alimosho Local

Government Area, like similar projects, would be preceded by preliminary activities such as the delivery of Right of Way (RoW) and assessment of affected properties for compensation purposes. He said that the essence of engaging beneficiaries of the proposed road project was to pass correct and adequate information on the modalities for the establishment the Right of Way and other connected issues. His words: "Part of the process of establishing the

RoW is the serving of statutory notices and marking of affected properties by the staff of the Ministry of Physical Planning and Urban Development, and assessment visit by the Lands Bureau towards the payment of compensation". The Commissioner, who spoke through the Permanent Secretary, Ministry of Physical Planning and Urban Development, Engr. Oluwole Sotire stated that information about the

process leading to the construction of the road had been published in the national dailies, in line with regulations guiding the delivery of RoW. He said that the proposed road construction, which is in furtherance of the T.H.E.M.E.S Agenda of the Lagos State Government, would be instrumental to the socio-economic development of host communities by improving accessibility and the environment. "It is inspiring that the administration of Mr.

Babajide Sanwo-Olu is setting the direction for the State's development with iconic projects such as the lite rail, tagged the Lagos Red and Blue Lines, the Imota Rice mill and the Dangote Fertilizer plant and Eleko-Epe road among others, including the new fire station in Ijegun corridor. The construction of Ijegun-Ijagemo Road, no doubt, adds to the retinue of roads that the administration has either completed or embarked upon across the length and

breadth of Lagos State to take development to the next logical level of attaining a world-class city-state", he said.

The Special Adviser, Works and Infrastructure, Engr. Aramide Adeyoye, who was represented by the Director of Road Construction and Rehabilitation, Engr. Tokunbo Oyenuga said that the Lagos State Government was determined to deliver a durable 5km dual carriageway in the Ijegun-Ijagemo corridor through the ongoing project and enjoined the people to give their support to realise this aim within the stipulated time.

She urged them to assume ownership of the project and protect it for posterity. The General Manager, Lagos State Planning and Environmental Monitoring Agency (LASPEMA), Tpl. Daisi Oso said that members of the project host communities should discourage all forms of encroachment on road setbacks, adding that setbacks serve the purpose of protecting the road.

Lagos To Plant 1000 Coconut Seedlings In Schools and Beaches

The Lagos State Government is set to plant 1000 seedlings of coconut as parts of its plans to promote coconut production, processing, commercial and utilization.

The General Manager of the Lagos State Coconut Development Authority, (LASCODA), Dapo Olakulehin disclosed this at a stakeholders meeting held recently at Oniru Beach on Victoria Island, Lagos.

According to him, in order to meet the needs of the public at large, LASCODA has partnered with the Rotary Club of Eko Atlantic

to distribute and plant coconut seedlings in public schools, coastal areas and communities across the state.

Olakulehin explained that the project extends beyond environmental benefits to the entire coconut value chain actors and stakeholders whose livelihoods depend on the coconut crop.

He said, "This project is an offshoot of the Coconut Development and Growth Project which aims to plant 1,000 coconut seedlings in public schools, coastal areas and communities".

"The proposal is to promote coconut production, processing,

commercial and utilisation of Coconut to ensure it meets the needs of the public at large. The General Manager noted It also aims to rebuild the Atlantic green wall in order to save Lagos land from the vagaries of the ocean.

On his part, the President, the Rotary Club of Eko Atlantic, Gboyega Bada, said, "We are partnering with the state government to restore the beauty of the coastal lines, combat rising sea levels, curb erosion, and break torsional winds by planting trees, particularly coconut trees which is the tree of life due to its enormous benefits to mankind".

He presented a Certificate of Partnership to the General Manager of LASCODA in recognition of his effort and achievement in the value chain sector, promising that the Rotary Club would work hand in

hand with the state government to build a better Lagos.

Similarly, the Oniru of Iruland, Oba Gbolahan Lawal, who was represented by the Chief of Ituri community, Baale

Wasiu Okoya, commended the initiative and implored the agency to ensure the coconut is properly distributed to all communities in the State to enhance the value of coconut.

Lagos Loses \$7bn Annually To Circular Economy-Study By World Bank

A study by World Bank has shown that Lagos State loses \$7 billion annually for not recycling its waste, especially the plastic wastes generated cross the metropolis.

This was revealed by the General Manager, Lagos State Environmental Protection Agency (LASEPA), Dr. Dolapo Fasawe at a one-day workshop on circular economy organised by the Agency, in collaboration with United Nations Industrial Development Organisation (UNIDO, the Federal government and other organised private sectors.

Circular economy is the type of economy in which waste are recycled and turned to wealth.

According to Fasawe, Nigeria by 2025 will be the largest producer of plastic waste, therefore, there is an urgent need to step up our activities in recycling and practicing a circular economy. Once the plastic is used, it should not just be

deposited anywhere. It can be reused, recycled, rethought and reduced to something else because plastic is not degradable".

She said "And when we say economic and plastic, it means that there's a lot of money that can be made out of plastic waste. A study done by the World Bank a few years ago shows that the cost of not practicing a circular economy in plastic waste is about 7 billion dollars just for Lagos State.

We are losing 7 billion dollars annually; and the essence of this workshop is to invite investors to join us in this advocacy for recycling, reusing and creating industries, job opportunities and more importantly a cleaner environment. You will not see these plastics on the road again if we put this approach of the circular economy on plastic waste".

In the light of this, Fasawe announced that the state would be partnering with the United Nations Industrial Development Organisation (UNIDO) to

advocate and deepen the value chain in the circular economy.

She stated that the workshop was designed to broaden the knowledge of the participants and stakeholders about the economic benefits of adopting friendly lifestyles as well as a holistic approach towards achieving the goals of a circular economy.

The UNIDO National Programme Coordinator, Mr. Oluyomi Banjo, disclosed

that UNIDO was pleased to work and achieve a circular economy in Lagos, adding that this would set the stage for other states in Nigeria as well as other regions in Africa.

He declared that to achieve the aim of the project, Lagos state would be developing its action plan on the circular economy of plastics in Nigeria and also embark on some activities with UNIDO and other relevant stakeholders.

"We will bring everybody

together to sensitise them on what circular economy is about; the benefits of a circular economy for the environment, socially and economically. The private sector would be encouraged to be more productive and efficient to make more profit. We will also look at the informal sector to see how we can incorporate them in achieving this, knowing that we cannot achieve this without the informal sector", Banjo said.

Also speaking at the event, the Managing Director/Chief Executive Officer (CEO) of LAWMA, Mr. Ibrahim Odumboni, reaffirmed the commitment of the government to promoting the reuse and recycling of plastics in the State.

Odumboni said that LAWMA was partnering with Polysmart, one of the largest plastic recyclers in Africa on converting many tonnes of plastic waste in the state to reusable products.

According to him, the authority is enforcing its adopt-a-bin policy to inculcate the value of waste separation at the source.

He also hinted that LASEPA, LAWMA and some other agencies of government had banned the use of single-use plastics in their offices to lead by example.

Earlier, the Commissioner for the Environment and Water Resources, Mr. Tunji Bello, expressed gratitude to the UNIDO delegation for partnering with the state government on the circular economy.

“Sequel to the need to prevent further loss of lives and properties through truck crashes on Ojuelegba Bridge, LASTMA had deployed trained officers to be redirecting heavy-duty trucks/tankers from Ojuelegba Bridge at Ikorodu Road”, Oreagba said.

He maintained that for fairness, equity and quick dispensation of justice on all traffic violators including truck drivers, the Lagos State Mobile will be part of the

Earlier in his remark, the new Sector Commander of FRSC Lagos, Corps Commander Babatunde Farinloye said the FRSC was primarily established to maintain safety on highways

Corps Farinloye maintained that FRSC has been collaborating with individual State Traffic Management Agencies in maintaining standards on road safety management across the country.

The Lagos State Government has inaugurated a 7-man technical committee to probe the recent collapse of a building under construction in Banana Island.

The inauguration was conducted by the Commissioner for Physical Planning and Urban Development, Engr. Tayo Bamgbose-Martins in Ikeja on Thursday with the Special Adviser, e-GIS and Planning Matters, Dr. Olajide Babatunde, the Permanent Secretary, Ministry of Physical Planning and Urban Development, Engr. Oluwole Sotire and General Manager, Lagos State Materials Testing Laboratory, Engr. Funso Elulade, in attendance.

The Committee, headed by a reputable Engineer and retired Permanent Secretary, Engineer Wasiu Olokunola, has the mandate to determine within two weeks, the immediate and remote causes of the collapse, the appropriateness of the construction work on the site and the culpable parties about the collapse of the 7-floor structure.

The committee is also expected to make recommendations on the remaining three structures under construction within the same vicinity and proffer solutions to building collapse in the state.

Other members of the Committee are Tpl. Ayo Adediran, a reputable town planning consultant; Engr. Aileme Unuigbe, a structural engineer; Arc. Oludayo Uhansohia; Akogun Kola Onadipe, a builder and project management consultant; Mr. Kuyebi Ayo Olanrewaju, a developer and Oluyemi Shonubi, a

renowned project manager, while Akinyemi Olajunwon Rasaan Martin will serve as the Committee Secretary. Bamgbose-Martins said

members of the technical committee were appointed based on their good reputations and urged them to provide insights into how such

ugly occurrence could be prevented in the state by unraveling the cause of the Banana Island building collapse.

Lagos Court Arraigns Bishop Over Alleged raping two members

The Lagos State Government has arraigned the founder of I Reign Christian Ministry, Bishop Oluwafeyiropo Daniel for allegedly raping two of his church members (names withheld).

He was arraigned before Justice Rahman Oshodi of the Lagos State Sexual Offences and Domestic Violence Court sitting in Ikeja.

According to the prosecution, the defendant allegedly committed the offences sometime in June 2020 in Ikota Villa Estate, Lekki, Lagos, and the offences contravene Sections 260 (2) of the Criminal Laws of Lagos State, 2015.

The clergyman pleaded not guilty to the charge against him and his counsel, Olukunle Oyewole subsequently asked the court to grant him bail.

While moving the arguments for bail, the defence counsel urged the court to grant bail to the defendant on liberal terms.

Oyewole argued that the defendant had been on police administrative bail since May 20, 2022, and had made himself available to the police.

"My lord, the defendant was not informed on the day the matter came up for the first time before this court.

"The defendant is a well-known religious leader and he has shown by his actions that he will not jump bail.

"The offence for which he is charged is a

bailable offence and he has credible sureties that can stand for him," the lawyer said.

The lead prosecution counsel for the state, Babajide Boye, had however urged the court to refuse the bail application of the defendant.

Boye argued that the offence was a serious one and that the likelihood of conviction might put the defendant at flight risk. "There is also the possibility of the defendant interfering with the prosecution witnesses.

He is a bishop of so many branches and if granted bail, he may use his position to influence the prosecution witnesses as he is regarded as a man of authority who has the possibility of committing the same crime.

"We urge the court to deny the defendant bail

because he has failed to provide the court exceptional circumstances to grant him bail," the prosecutor submitted. After listening to both parties, Justice Oshodi admitted the clergyman to bail in the sum of N20 million with two sureties in like sum.

He said one of the sureties must be the owner of a landed property in Lagos State and the property must be enough to cover the bail sum.

"The original document of the landed property must also be submitted to the chief registrar of Lagos State," the court held.

Other conditions of bail include that the sureties must reside within the court's jurisdiction and must have paid three years' tax payment to the Lagos State Government.

The judge also ordered the defendant to deposit his international passport with the chief registrar of the court while ordering an accelerated hearing of the case.

Pending the perfection of these bail conditions, the court ordered the remand of a clergyman at the Kirikiri Correctional Centre.

Justice Rahman then adjourned till ninth May for trial.

Before Monday's arraignment, legal advice issued by the Director of Public Prosecutions (DPP), Dr. Babajide Martins disclosed that, "after a consideration of the facts available in the duplicate case file, the office of the DPP is of the view that there exists prima facie, offence of Rape under Section 260 of the Criminal Law, Ch C17,

Vol.3, Laws of Lagos State, 2015 against the Suspect Oluwafeyiropo Daniel." Excerpts of the legal advice also said, "Facts from the duplicate case file reveal that the suspect – Oluwafeyiropo Daniel is a pastor and the Founder of I Reign Christian Ministry, that he had a church branch in Akungba Akoko where he had young people as Pastors and Assistant Pastors.


"It is also revealed that Oluwafeyiropo Daniel invites the branch pastors and assistants to his house from time for one reason or the other.

"The Complainant was an assistant Pastor at the Akungba branch who Oluwafeyiropo Daniel took advantage of whenever she visits his Ikota residence. It is revealed that Oluwafeyiropo Daniel

having presented himself as his victim's spiritual father whom they must be loyal to and must never hide anything from him including their body lures the complainant and his other victims into having sexual intercourse with him.

"Although Oluwafeyiropo Daniel denied all allegations and states that he had never at any time assaulted the complainant or any of his other victims, the evidence of the victims in the duplicate case file is cogent, direct and unequivocal and is sufficient evidence against Oluwafeyiropo Daniel.

"In the light of the foregoing, this office shall prosecute Oluwafeyiropo Daniel for the offence of Rape under Sections 260 of the Criminal Law, Cap C17, Vol.3, Laws of Lagos State, 2015."

11 Years after: Agbowo-Ikosi gets ready to Install New Abowa

Settling 11 years old tussle between two ruling houses, a new traditional ruler has been finally picked to be installed in Agbowo-Ikosi, a community in Ikosi-Ejirin Local Council Development Area. The community has been existing without a traditional ruler for the last 11 years owing to legal tussle between two ruling houses in the community. The two families in dispute over the traditional stool are the Mabudeje-Aduloju and Mabudeje-Tugbobo ruling houses. After the demise of Oba Akinlolu Bolaji Joseph Odumeru in 2012, the Kingmakers swung into action the following year upon

receipt of notice from the Local Council Development Area. This prompted the nomination of Prince Owolabi Saheed Momson of the Mabudeje-Aduloju family as the Abowa-Elect. The process was protested against by the Mabudeje-Tugbobo ruling house who claimed to be the rightful ruling house to produce the next king and not Prince Owolabi Saheed Momson's Mabudeje-Aduloju ruling house. Amidst these protests, in 2015 the claimants, Mabudeje-Tugbobo ruling house approached the court to seek redress. In defence of the suit, the Mabudeje-Aduloju ruling house came up with a counter-claim against the claimants.

The matter was initiated at Ikorodu High Court, but in the course of prosecuting the matter, it moved from Ikorodu to a Lagos High Court sitting at Tafawa Balewa Square (TBS) Lagos Island, back to Ikorodu and later Ikeja High Court. The matter commenced before Hon. Justice Salvade who granted the claimants interlocutory injunction restraining the state Governor and all other defendants in the matter from installing a king in the community. However, all efforts to speak with the regent, High Chief Odufowora Shakirudeen proved abortive after several visits to his residence at Odusanya close, beside victory house, off Ikosi beach road, Agbowo Ikosi.

It was confirmed that Oba Edward Alausa Thomas Olufuwa was the first king of Agbowo-Ikosi, he

ruled from 1956 to 1972 and was succeeded by Oba Ahmed Kolawole Hassan who ruled

from 1973 to 2006 and the late Oba Akinlolu Bolaji Joseph Odumeru ruled from 2007 to 2012.

means to "Find Work." Founder and Chief Executive Officer, Rísé.ng, Mrs. Olawunmi Akalusi, said the platform was created to bridge the gap between vendors, artisans, service providers and Micro,

Small and Medium Enterprises (MSMEs) and their end-users, clients or customers. She revealed that the Chairman, Surulere Local Government, Mr Bamidele Yusuf, and the Speaker of the House of

Representatives, Mr Femi Gbajabamila, had paid N6,000 for each vendor for the year, covering insurance and the verification process.

"The good thing for traders and artisans in Surulere is that the chairman has paid for the verification and insurance for the whole year for 1,000 artisans.

"The verification costs N3,000 while the insurance costs N3,000.

"The verification ensures security for both parties, (the artisans and customers) while the insurance ensures that if anything happens to them when delivering goods or services, they

are covered to an extent. "We are still working on a general life insurance in cases of accidents," she said.

Akalusi said they had put measures in place on the app to ensure artisans delivered quality goods and services to customers.

"We have a rating system where artisans are rated by their customers based on their service delivery.

"If a vendor or an artisan gets three strikes based on negative ratings, we will automatically remove the person from the system. This is to ensure that customers get quality services and products," she said.

Gbajabamila, who was represented by his Chief of Staff, Mr Olarenwaju Smart, said the platform was one of the safety nets that artisans in the constituency needed to increase the portfolio of their businesses.

He said that partnering with the local government was to ensure that artisans in the area migrate to e-commerce platforms like Rísé.ng to increase their market access.

"It is an electronic platform that enables them to interface with customers online and provide services to them seamlessly.

"There is no doubt that this will add to the income of artisans in Surulere.

"This programme will be extended to Itire-Ikate, Coker Aguda and other local government areas in the state," he said.
