## 2023:TINUBU TIPPED TO WIN

arly feedback from situation rooms of candidates running for the presidency indicate that the All Progressives Congress candidate may be coasting to victory on the crest of votes delivered Northern and South western states,

The Independent National Electoral Commisione is charged with the responsibility of declaring the figures.

However, results obtained from polling units on the close of poll yesterday tipBola Tinubu to win.

The results so far have indicated the landslide victory for the APC as its presidential candidate, Asiwaju Bola Ahmed Tinubu is expected to be officially announced the winner today.

Though the results from some few polling units especially in the Igbo dominated areas in Lagos seemed to favour the presidential candidate of Labour Party (LP), Peter Obi, the results across the state indicated that APC is on the topmost of the ladder in so many polling units. Aside from Oshodi-Isolo and Amuwo-Odofin LGAs where the Igbo residents voted en mass for the Labour Party, APC cleared the votes in so many LGAs. The PDP has no place withing the winning box.

The APC leadership in Lagos State had pledged to deliver the state with overwhelming votes for the party, though their expectation fell short due to some circumstances as the state recorded low turnout of voters as obtained in other states, they were able to fulfil the promise.

Prior to the election day, there were agitations on whether the elections would hold as scheduled

due to various circumstances heralding the conduction of the 2023 general elections. The major issue that hit the polity and affected the general wellbeing of Nigerians was the introduction of new naira notes.

CASH CRISIS ISSUE

The Central Bank of Nigeria (CBN) had in October, 2022 announce the redesign of three denominations of Nigerian currency - N100, N500 and N200 notes. On December 15, 2022, it c o m m e n c e d t h e circulation of the new notes while mopping up the old ones from circulation.

It, therefore, gave January 31, 2023 deadline for everybody to deposit their old notes at the bank. After the January deadline, the Apex bank was forced to extend the deadline to February 10. By this time, the populace has started feeling hardship as the new note in circulation was too meager compared to the amount of the old note that has been out if circulation. It was reported that only

N300 billion new notes were released into circulation while about N2trillion old notes had been taken out of circulation. By February 17, the new extended deadline, the old note had ceased to b legal tender, putting more Nigerians in agony.

While the country was battling with cash crisis, the Independent National Electoral Commission (INEC) had complained that it could not hold the election without getting son amount of cash. With this, there was still insinuation that the election might not hold.

However, the CBN later, less than 56 hours to the election, released the required cash to the Commission to be able to conduct the election as scheduled.

While some people claimed that the policy was deliberately made at the time to scuttle the general elections, the CBN governor, Godwin Emefiele said the monetary policy was to reduce the size of the cash in circulation and enforce the

cashless economy as done in the developed countries. According to him, the exercise has achieved a success rate of over 75 percent of the N2.7 trillion held outside the banking system.

"So far and since the commencement of this programme, we have collected about N1.9 trillion; leaving us with a bout N900 billion (N500 billion plus N1.9 trillion).

He further said that aside from those holding illicit and or stolen Naira in their homes for speculative purposes, "we do aim to give all Nigerians that have naira legitimately earned and trapped, the opportunity to deposit their legitimately trapped monies at the CBN for exchange.

"We therefore appeal to all Nigerians to work with the Central Bank of Nigeria to ensure a hitch free process for the implementation of this very important programme."

He noted that the apex bank's aim is mainly to make Nigeria's Monetary Policy Decisions more effective "and like you can see; we've started to see inflation trending downwards and exchange rates relatively sta"Secondly, we aim to support the efforts of our security agencies in combating Banditry and Ransom taking in Nigeria through this programme and we can see that the Military are making good progress in this important task in Nigeria.

"Ordinarily, when CBN releases currency into circulation, it is meant to be used and after sometime, it returns to the CBN thereby keeping the volume of currency in circulation under the firm control of the CBN. "To achieve effective distribution, of the new currency the CBN has taken the following steps: We held several meetings with our Deposit Money Banks (DMBs) arid provided them with Guidance Notes on processes they must adopt in the collection of old notes and distribution of the New Notes to all Nigerians.ble."

"These includes specific directives to DMBs to load new notes into their ATMs nationwide to ensure an equitable / transparent mechanism for the distribution of the new notes to all Nigerians. "We commenced a nationwide sensitidation through the Print and electronic media to create an awareness on the redesigned notes to Nigerians including collaboration with the **National Orientation** agency to reach all Nigerians across multiple channels." **EFFECT ON ELECTION** Apart from subjecting many people to hardship as note than 60 per cent of Nigerians do jot have bank accounts while majority of them are not used to cashless economy, the scarcity of cash in circulation also affected the

assembly elections. It greatly reduced vote buying by political parties. Despite the larger number of registered voters and those who collected their permanent voter's cards (PVCs) as published by INEC, the number of those who actually came out to vote was relatively small. As reported by our correspondents who monitors the election at various polling units across Lagos State, many eligible voters refused to go out to exercise their civic right. For instance, the total number of vote counts in many PUs was not up to 100 in some local governments not only in Lagos but also in some many other states as gathered. When inquired by ECHONEWS, it was gathered that people had refused to vote due to the current cash crisis they experience. The residents complained of scarcity of

cash as a factor that

restricted so many voters

from going out to vote. A notable monarch told ECHONEWS people were hungry, hence, they were not happy to "come out and vote. On my own, as part of my own effort to mobilise people in my community to come out and vote, I organised a cook who fried akara and bought bread for people to eat very close to the polling booth. Despite that, you see, people are still not motivated but it helped as some who would have remained indoor came out to vote.


"If other community leaders can do this, I think the turnout will be huge during the governorship election in March. This is another way by which we can encourage our people to cone out and vote. Again, we appeal to the federal government to ease this hardship of cash on us. If this is done, people will surely come out to vote. People are hungry, we don't expect hungry people


to go out and vote." Again, political observers and analysts said many people decided not to come out to vote since they could not get cash "bribe' they used to collect from political parties at the polling booths. In the past, some desperate political parties would bring money to the polling booths, entice the voters with the money to buy their votes. At least, a voter who knew his way could go home with more than N10,000, collecting money from various parties that tried to woo him with the money. However, the cash crisis induced by the new monetary policy currently rocking the country has put an end to that; money is no more flowing at polling booths. Indeed, majority of the


political agents could not get their money instantly in cash, as their parties appealed to them, promising to do bank transfer to their various accounts after the election.


Journalists as well as the INEC officials who normally waited for monetary gains during elections were last week disappointed as money did not flow as it used to during the previous election periods. CREATION OF NEW PUs Due to the noticeable increase in population of voters especially in places like Lagos where the average of 5,000 new people migrate to daily, the Independent National **Electoral Commission** created new additional 56,872 polling units to make a total of 176,846 across the country as a way of bringing the PUs closer to the voters. With this, voters would no longer have to trek miles before getting to their polling units.

In Lagos for instance, the Commission created 4,861 additional polling units, increasing the number in the state from 8,000 to 13,325 to ensure there are no more than 700 voters at a polling unit









The aim behind the new creation was to decongest the few existing polling units and provide unhindered access for the citizens to exercise their fundamental rights to vote.

It was also geared towards shaping citizens confidence in the electoral process and similarly determine the level of their participation or apathy as well as security and safety during elections.

However, many voters faced challenge in locating their new PUs as they were moved from their old PUs to the new ones by the commission. This, as gathered by ECHONEWS, also contributed to the low turnout for the election on Saturday. It was also reported that some people were restricted from voting by the leadership of the community where their new PUs are domiciled just because their faces were not familiar in the area.

#### INEC's LATE ARRIVAL

Another factor that affected the 2023 presidential election held on Saturday last week as

noted in Lagos was late arrival of INEC officials to the polling units.

As at 3:00pm, there were PUs where the voters were still expecting the INEC officials. Some voters returned home after waiting for hours for arrival of the officials.

ECHONEWS reported polling unit in Ejigbo LCDA where the voters had to wait for hours before they could cast their votes as INEC delayed in operating the BVAS machine, claiming they did not know the machine's password.

Lamenting in the late arrival of INEC officials at her polling unit, the All Progressives Congress (APC) Lagos West Senatorial Candidate, Dr Idiat Adebule urged the INEC to improve on the logistics surrounding electoral process. She said the voting process was not smooth and short of the people's expectations.

Adebule, who arrived early at the Polling Unit 029 at Iba, was surprised that the INEC officials did not turn up until 10:40am.

She appealed to the aggrieved electorate who had been at the centre as early as 7:30am to

be patient, which was evident in some other polling units in Lagos.

According to the former Lagos State Deputy Governor, the late arrival of the INEC officials caused a lot of apprehension and agitation.

Adebule said: "Majority of voters are more agitated. It has not always been like this. I've been voting here for quite a while. The turn out of voters during this election is commendable. It was better than the previous polls. People are eager to vote.

"INEC should tidy up preparation and logistics early enough and be responsive to the people. People have been waiting here from 8am and voting didn't commence until 11am. The electorate are not happy about it. I'm sure the INEC can improve on this."

Meanwhile, the low turnout in Lagos State may dash the hope of the APC party leaders who had earlier promised to deliver about 5 million votes for their presidential candidate, Asiwaju Bola Ahmed Tinubu.

WINNING PARTY

While the situation of cash




Going by the results coming in



However, the election was said to be relatively free and fair in Lagos State.












































































## New maternity centre in Agege commences operation

# Residents accuse LASBCA of illegal demolition

esidents of A b a r a n j e community in Igando/Ikotun LCDA have appealed to the state government to request the Lagos State Building Control Agency (LASBCA) to account for the illegal demolition of their homes in the area.

The victim's families, Mr. & Mrs. Adeoye Kayode, and Mr. & Mrs. Saka Akeem had complained that the demolition was carried out by the agency without a court order.

According to them, the first notice from LASBCA was issued in February 2021, stating a sevenday quit notice requesting them to vacate their homes as it intended to demolish the properties.

Their attorney, Ahmed Dada Abass, Principal Partner of PISE Associates said after the next meeting in April 2021, there was no resolution as the petitioner insisted on the demolition of the properties. For over 19 months, following the said last meeting, there was no communication

between the parties.

They said the land sellers have also reported that the land sold is okay without any controversy over ownership while requesting the Lagos State Commissioner of Police, Idowu Owohunwa, to find out the policemen who supervised the demolition exercise.

They insisted that they were not informed about the demolition, hence, they could not remove anything from their houses as they lost all their properties when the building was demolished.

### Couple arraigned for alleged theft

Couple, Cordelia Dike and Frank Dike, who were arraigned for alleged theft, has been granted bail Magistrate, K. A. Ariyo at the Ejigbo Magistrate Court sitting at Ejigbo.

They were reported to have stolen

jewellery and cash worth N2.2 million at Abesan Housing Estate in Alimosho Local Government Area.

They are on standing trial on a three-count charge bordering on burglary and theft, to which they pleaded not guilty.

The prosecutor, Benedict Aigbokhan, told the court that the husband, 63, and the wife, 50, broke into the house of one Doyin Ogunbiade on February 1st, 2023, and stole a container containing jewellery worth N215,000. He said the

defendants also broke into the house of another person, Adewunmi Dada, and stole a cash in the sum of N1.5 million and jewellery worth N500,000.

Magistrate Ariyo ordered that they should provide two sureties who must be gainfully employed and show evidence of tax payments to the Lagos State government.

She then adjourned the case till March 3, 2023 for mention.

# Judges may not sit Monday, election recess lingers

here are fears that Lagos State Judicial Service may not sit today Monday in view of the tension that marked the Presidential and National Assembly weekend.

A few lawyers told Echonews that private inquiries from the staff working in courts where their cases are pending reported that the judges prefer to watch events unfold on Monday from the comfort of their homes hoping that the tense security situation would be doused by evening.

The Chief Judge of Lagos State, Hon.Justice Kazeem Olanrewaju Alogba issued a directive Thursday, February 23,

this year asking judges and all other staff of the Lagos State Judicial judges of the Service to observe a halfwork day on Friday February 24 this year to prepare for the Presidential and National Assembly polls. The directive, issued by elections over the the Acting Chief Registrar, Mr. T.A. Elias read:

> " I have the directive of the Honourable Chief Judge of Lagos State, Hon. Justice Kazeem Olanrewaju Alogba to inform all members of staff of Lagos State Judiciary, that Friday, 24th February, 2023 has been declared as Half Working Day for members of staff.

> The reason for this is to ensure all members of staff are not hindered from exercising their political franchise during



the forthcoming Presidential and National Assembly Elections scheduled for Saturday 25th February 2023.

In view of this, offices at all Divisions and districts of Lagos State judiciary are to close by 1 pm on Friday 24th February 2023."

Meanwhile, A lawyer, Barrister Kayode Ademiluyi has advocated for a review of the laws to enable state high courts handle election cases too. In the alternative, he urged the establishment of a specialised court to

handle election matters. Ademiluyi, who was counsel to Rep. Ganiyu Johnson (Oshodi-Isolo II) during the election petitions in 2019 said such provisions will aid the dispensation of justice.

His words: " Pre-election cases should not be

handled by the Federal High Court alone. There should be provision for other courts of the same hierarchy to also assist so that justice can be gotten fast. In the alternative, a specialized court should be created to handle pre and postelection matters."

### Half-day directive slows down 98 cases before 10 judges

ot less than 98 cases before 10 judges were affected by the decision last Thursday of Chief Judge Kazeem Alogba asking employees of the Lagos State Judicial Service Commission to work half a day on Friday February 24 to prepare for last Saturday's Presidential and National Assembly polls.

The worst hit is the court of Hon. Justice A.O. Idowu expected to take 24 cases listed in the Cause List. The court, which sits in room 59 had planned to deliver the ruling in the case of Nafisat Kareem & ANR Vs Morenikeji Adejoke Erujeje (suit NoLD/11777LMW/12)

It was also listed to take 23 mentions including All States Trust Bank & ANR Vs Loftrade Nigeria Limited & ANR, (LD/1473/05); Mr. Patrick Umunna & ANR Syndicape Properties Limited, (LD/4491/GCMW/17); Mrs. Oghenero Ozobieme Vs Nicholas Hospital & ANR, (LD/3634GCMW/17); Mr. Ademola Odugbesan Vs Mr. Olatunji Odugbesan, (LD/3634GCMW/17); Pamther UK Limited Vs Candoli Nigeria Limited, (LD/99/09) and Quality Finance Limited Vs U.O.O Nwachukwu Holding Nigeria Limited.

The court of Justice A.M. Lawal, sitting in Room 31, was billed to

There are no foods that contain aloe vera, so it must be taken in supplement or gel form.

Some forms of aloe vera are safer to take than others, and chronic use is discouraged.

The nutrients found in aloe vera juice can provide some health benefits. Beta-carotene is a yellowred pigment that's found in aloe vera plants. It acts as an antioxidant that can help support eye health, including retinal and corneal function.

It relieves heartburn. Heartburn is a painful condition that involves acid leaving the stomach and traveling up the esophagus. A recent study has shown that aloe vera juice can reduce the symptoms of heartburn without any

uncomfortable side effects.

Treats constipation. Aloe vera juice contains several compounds known to act as laxatives. While drinking aloe vera juice is unlikely to cause digestive issues in people with normal bowel movements, it has shown promise as a way to relieve constipation.

May improve IBS symptoms. Aloe vera juice may be a potential treatment for irritable bowel syndrome (IBS). This condition involves the inflammation of the intestine, leading to pain and other issues.

Aloe has been shown to have anti-inflammatory properties. In one trial, people with IBS who drank aloe vera juice said some of their symptoms improved. However, scientists need to do more research.

Aloe Vera Nutrition

Aloe vera juice is a rich source of antioxidants, which help fight free radicals. This lowers oxidative stress on your body and reduces the risk of chronic conditions such as diabetes, heart disease, and cancer.

Aloe vera juice is also an excellent source of: Vitamin C, Vitamin A, Vitamin E, Beta-carotene Folic acid, Calcium, Magnesium

Aloe vera juice contains high levels of magnesium, which is a vital nutrient for nerve and muscle use. Magnesium helps your body with more than 300 different enzyme reactions, including those that regulate your blood pressure. It also helps regulate heart rhythm.

Aloe Vera Uses

Research backs up the ancient use of topical aloe vera as a skin treatment, at least for specific conditions. Studies have shown that aloe gel might be effective in treating skin conditions including: Psoriasis, Seborrhea, Dandruff, Minor burns, Skin abrasions, Skin injured by radiation, Acne, Herpes sores and Anal fissures.

There's also strong evidence that aloe vera juice, which contains latex, taken by mouth is a powerful laxative. In fact, aloe juice was once sold in over-the-counter constipation drugs.

Aloe vera gel taken by mouth seems to help lower blood sugar levels in people with diabetes. It may also help to lower cholesterol. The results of aloe vera studies for other medical conditions have been less clear.

How much aloe vera should you use?

Creams and gels with aloe vera vary in dosage. Some creams for minor burns have just 0.5% aloe vera. Others used for psoriasis may contain as much as 70% aloe vera. As an oral supplement, it has no set dose.

For constipation, some use 100-200 milligrams of aloe vera juice - or 50 milligrams of aloe vera extract - daily as needed. For diabetes, 1 tablespoon of the gel has been used daily. High oral doses of aloe vera or aloe vera latex are dangerous. Ask your doctor for advice on how to use aloe vera.

How to Prepare Aloe Vera Juice

Aloe vera juice can be found in supermarkets around the country. It typically comes in bottles, mixed with water to make it less thick.

It's also possible to make aloe vera juice yourself. Take an aloe vera spike from a plant and trim the pointed edges off of the sides. Then, carefully slice off the skin on the flat side of the leaf and remove the gel from inside. This gel is the edible part of the plant. Make sure you remove all traces of the skin from the plant. The skin adds a

bitter, unpleasant flavor. You can rinse the gel under running water to help remove all traces of it.

Once you have the gel, you can toss it in a blender. Blend until smooth, then add water until it reaches the thickness you like. The result is a fresh, cleantasting beverage.

Here are some ways to add aloe vera juice to your diet: Drink the juice on its own. Add aloe vera juice to smoothies. Use aloe vera juice in cocktails. Mix aloe vera juice into lemonade, Use aloe vera juice in gelatin.

Aloe Vera Risks

Talk to your doctor before using it. Researchers warn against the chronic use of aloe vera. But if the aloe vera product is free of aloin an extract of the plant that has been found to cause colorectal cancer in rats - it may be OK as a topical remedy for sunburn. Aloin is found between the outer leaf of the aloe plant and the gel inside.

Side effects. Topical aloe vera might irritate your skin. Oral aloe vera, which has a laxative effect, can cause cramping and diarrhea. This may cause electrolyte imbalances in the blood of people who ingest aloe vera for more than a few days.

Interactions. If you take any drugs regularly, talk to your doctor before you start using aloe vera supplements. They could interact with medicines and supplements like diabetes drugs, heart drugs, laxatives, steroids, and licorice root. The oral use of aloe vera gel may also block the absorption of medicines taken at the same time.

Given the lack of evidence about its safety, aloe vera supplements should not be used orally by children and by women who are pregnant or breastfeeding.




