### Rainy Season: Govt Sets Strategies In Motion To Abate Perennial Flood

aking steps to avert flooding in floodprone areas of the state and also in preparation ahead of rainy season, the state government has set strategies in motion to tackle flooding this season with the deployment of over 228 officials of Emergency Flood Abatement Gang (EFAG) deployed to the 57 Local Government Areas (LGs) and Local Council Development Areas (LCDAs), complemented with another 50 drainage attendants under the Tertiary Drains Squad (TDS) recently launched by the state government.

Flood has been one of the major challenges faced by Lagosians; the negative effects of the menace are not bearable as it sometimes leads to death and renders some homeless.

As the rainy season gains momentum in the state, it has become a daily struggle for motorists, commuters and for pedestrians going through most major roads and streets.

This is occasioned by the daily heap of garbage, rain water that cannot go into the drains due to the drain blockage with excess refuse, push and disperse all over, floating and causing flood after every single rain drop.

Despite the efforts by the governments at the state and local levels, the challenge keeps reoccurring.

The major cause of flood is blocked drains and canals across the state, though the government has continued to spend fortunes on the evacuation



of drains and canals yearly. Apart from indiscriminate refuse disposal, pet bottles and single-use plastic constitute major blockage of drains according to one of the Emergency Flood Abatement Gangs, Mr. Adeniyi Dairo.

Dairo, while speaking to ECHONEWS said Lagos State Government is much concerned over the uncontrolled use of plastics and pet bottles by the residents and its negative effect on the secondary drains. environment.

To curb the menace, there are officials of Emergency Flood Abatement Gang (EFAG) in the 57 Local Governments and Local Council Development Areas in the State.

ECHONEWS gathered that there are at least four officials of EFAG in each local council working on the evacuation of drains while the government is expected to employ more hands.

Dairo told ECHONEWS that the state government has procured the needed equipment for the to work. To complement the effort of The Special Adviser

the EFAG, the state government last month created Tertiary Drains Squad (TDS) in each local council.

Speaking, the Special Adviser on Drainage and Water Resources to the governor, Engr. Joe Igbokwe, said the Squad will complement the Emergency Flood Abatement Gang already in existence to ensure that tertiary drains properly discharge into primary and

While urging the Council authorities to think big but start small, he explained that with the employment of 50 drainage attendants that would be paid a minimum of N35,000 monthly, the councils would spend less but achieve more, compared to what they presently spend to clean tertiary drains, adding that there is no straight-jacket approach to implementing the directives of the state government, as each council must adopt the strategy that suits it.

reiterated that the stakeholders meeting is one of the proactive measures put in place to have synergy between the State and Local Governments in terms of interdependence as it affects drainage channels. He declared that it's high time that LGs/LCDAs take ownership of tertiary drains to reduce the pressure of desilting and cleaning of the secondary and primary channels, where the State Government has continued to engage human and financial resources.

The Special Adviser commended the enormous efforts of the Emergency Flood Abatement Gangs (EFAG) created by the State Government and deployed to undertake quick fix to free manholes or clogged up tertiary drains across the State.

Permanent Secretary, Office of Drainage Services and Water Resources, Engr Lekan Shodeinde, said the time has come for Local Government Councils to take up their constitutional roles of tertiary drainage

maintenance across the State, stressing that all hands must be on deck as the present administration is determined to ensure a flood-free Lagos in line with the T.H.E.M.E.S Agenda.

Shodeinde explained that there should be no excuse of inhibitions from political leaders in the discharge of their duties as far as such projects and intentions are well laid out.

He informed that the State Drainage Engineers and Coordinators are available in all the 57 Local Governments and Local Council Development Areas to complement the efforts of Local Government Councils with the maintenance and cleaning of tertiary drains at all times.

The Permanent Secretary also appealed to Lagosians to always report cases of drainage blockages, indiscriminate dumping of waste into canals and other unauthorised places to the State Government, through the CITIMONITOR APP available on Google Play and App Store.

On the ban of use of plastic materials in the state, Shodeinde said the government is making effort.

He noted that the government has recently declared formal ban on the use of plastics and pet bottles among all staff of the Lagos State **Environmental Protection** Agency (LASEPA).

According to him, this will be extended to curb increasing rate of singleuse plastics, pet bottles, polythene and other nonbiodegradable items by Lagosians, stressing that there is an urgent need to reverse the trend through the use of reusable plastics or biodegradable materials.

The Permanent Secretary, therefore, advised Lagosians to be mindful of the health implications of their attitudes to the environment, saying unhealthy environmental behaviour has a vicious cycle effect on the lives of every resident.

#### How I escaped "One-chance" Bus -Woman shares terrible experience

barrister based in Lagos. identified as Adunni Ade has explained how she unknowingly entered a bus filled with criminals popularly called " One Chance".

The woman, who lives in Ipaja-Ayobo but works in Yaba, said she was on her way home from work on Thursday, March 10, when the incident occurred.

She had gotten to Iyana-Ipaja and then boarded a bus going to Ipaja-Ayobo.

According to her, an elderly woman entered the bus and she followed. But immediately she got in, the men in the bus attacked her and the elderly woman, beating them and collecting all their valuables.

She said they even passed a police checkpoint during the ordeal but the men made her lie put a bag over her head.

She said she lost consciousness at a point and was revived with a blow.

After taking the valuables she had on her and also taking her ATM and her PIN, she said she and the elderly woman were pepper sprayed and thrown out of Jesus blood of Jesus beside of the moving bus at Ikeja Along, miles away from their woman to the back seat and put destination.

"On Thursday evening March 10, 2022 at about 7:30pm or 8pm, let's just say I got very unfortunate because I fell into the hands of the wicked beasts living among humans. I work at Yaba and I live at Ipaja just right after Iyana Ipaja.

"All the way from Yaba, I already got to Iyana Ipaja and I was already happy I had almost gotten home, just right in front of GB Iyana Ipaja was a mini bus


down on the floor of the bus and calling Ipaja Ayobo. Before me was a woman in her 60s I guess. She entered the bus and then I hopped in right after her. We only just asked for the price and under split of seconds one of the supposed passengers from the back just came to the front and the next thing I heard was blood me and then they pulled the me in the Middle.

> "The next thing I knew I tried to get off the bus and then I kept struggling and I was terribly beaten after which they now took my phone and asked me to remove my icloud and then took my ATM, asked me for the pin and took all my valuables removed all my jewelries and beat the hell out of me. They even asked that I borrow a million naira or I better start calling family.

"All these were happening while the vehicle was on motion. We even got to a police check point but at this time I was asked to lay down between the driver's seat and front passengers' seat where they kept their legs on me and put a bag on my face in case anyone had to look into the bus.

"I was strangled and I think I lost consciousness for a while, and the next thing I felt was a blow on my face and I woke up they pushed me off the bus alongside the old lady and put pepper spray in our eyes dropped us at the airport fence around Ikeja

"I was particularly beaten more because I struggled for my life, this wicked souls carted away all my valuables, clients document, clients money, the little change in my purse too, left me high and dry vomiting foam and bleeding from the nose, but as bad as it







#### Businessman docked for alleged N4.1m Bitcoin fraud

31 - y e a r - o l d businessman, Damilola Onasanya, was recently docked at Magistrates Court, Ogudu, for alleged N4.1million Bitcoin fraud.

The police had charged Onasanya who resides in Ikeja area of Lagos with conspiracy, obtaining money under false pretences and theft.

He, however, pleaded not guilty to the charges.

The prosecution counsel, Insp. Donjour Perezi, told the court that the defendant committed the offence with some others at large on February 5, 2022 at Ikorodu Road, Ketu, Lagos.

Perezi said the defendant

fraudulently obtained N2.7million from Valentine Okoye on the pretence of buying Bitcoins for him.

The prosecution also said that the defendant collected N1.4million from Ikechukwu Nwachukwu for the purchase of Bitcoin.

The defendant, he said, bought fake Bitcoins for the complainants and converted the money to his personal use. The offence, he said. contravened the provisions of Sections 287, 314 and 411 of the Criminal Law of Lagos State, 2015.

He added that Section 287 stipulates three years imprisonment for stealing, while Section 314 attracts 15 years for obtaining money



under false pretences. Magistrate O. M. Ajayi admitted the defendant to bail in the sum of N500,000 with two sureties in like sum. Ajayi ordered that the sureties

should be gainfully employed with evidence of tax payments to the Lagos State Government and adjourned the case till April 22 for mention.

The council boss urged the residents

to take ownership of the healthcare facilities and other physical infrastructure in their neighborhoods. He said the public facilities provided by the government belong to the people because they were built through taxes and levies collected from them.

He stated that the Otunba Olufemi Olusegun Pedro Primary Health Centre, Edumare is the second of its kind commissioned since he assumed office.

In his first one hundred days in office, the first Health Centre built by the Folawiyo administration at the Anikantamo quarters was named after the wife of Lagos State Governor, Ibijoke Sanwo-Olu.

Otunba Pedro was full of commendation to the council boss whom he described as a man who understands grassroot governance and local government administration.

#### Tenant insists on old 1958 lease rate

he administrators of the estate Prison Street, Lagos Island, with title The family engaged an estate valuer, of Regina Omoloto Wright have rejected a bid by the tenant of their Lagos Island property to pay a 1958 lease of £130 (about N60,000)

Thomas and Mrs. Oyinkansola Obasi (nee Thomas), contended that the yearly rental value of the property as of 2016 was put at N15 million by estate valuers, but that the occupiers have insisted on paying the old rate. The tenant, Star Properties Limited, whose directors and founders. including Chief Chris Ogunbanjo, filed a suit at the Lagos State High Court seeking an interpretation of the 1958 lease agreement on the property at 3, Ganiyu Smith Road, opposite St Nicholas Hospital, Lagos Island.

The family, in their counter-affidavit, said the late Mrs. Wright owned the property, which was formerly on 3,

number L01630 registered with Lagos Ministry of Lands on April 16, 1948. She also built on it.

The administrators said the late The family, represented by Adediran Mr. Maroun Daakour on June 16. 1958, for a 99-year lease on the property commencing April 1, 1958, at £130 yearly.

> Based on the agreement, Daakour subsequently sub-let the property to Vensimal Sawlani and Hotchand Sawlani on August 31, 1961, before Star Properties eventually took over from the Sawlanis.

After the original estate administrators passed on, Mr. Thomas and Mrs. Obasi were appointed as the administrators.

They briefed their lawyer to open negotiations with the applicant to seek an amicable settlement of the

Jide Taiwo & Co., which estimated the property unpaid rental income for 14 years (2003-2016) as N90 million.

The family asked the applicant to pay owner signed a lease agreement with half of it, but Star Properties refused the reduction and rejected the

> The administrators said when the matter could not be resolved amicably, they asked their lawyers to issue a quit notice to Star Properties partly for non-payment of rent, which as of 2016, was 14 years overdue.

Two months after the quit notice, Star Properties sent a cheque of N1,082,000, which in its view was supposed to cover the 14 years of unpaid rent, but the administrators rejected it. It filed the suit to challenge the quit notice.

The respondents said Star Properties did not pay the outstanding rent or move out at the expiration of the quit

They said their lawyer notified the tenant on August 1, 2017, of their intention to recover possession of the property, but the tenant is "still retaining possession of the landed property... and has refused to pay its

The family, in an earlier suit which is now on appeal, is praying the court to order Star Properties to pay the arrears of rent from March 2003 to July 2017 in the sum of N90 million and a Mesne profit from August 1, 2017, at the sum of N1, 250,000 per

month until possession is given up. The administrators are also contending that Star Properties was not a party to the original lease agreement with the late Mrs. Wright and therefore cannot seek to enforce

"There is no lease agreement between the respondents and the

applicant (Star Properties)," the family said.

But, Star Properties in its suit pending before Justice Taofiquat Oyekan-Abdullahi, is praying the court to hold that the quit notice issued them by the family was not in accordance with the lease agreement

"with the same yearly rent as agreed in the head lease".

Star Properties told the court: "Since settlement has broken down between parties and the defendants were insisting that the unilaterally reviewed rent should be paid, the claimant in compliance with the agreed terms of the head lease issued a cheque dated March 21, 2017, in favor of the defendants for the sum of N1, 082,250 calculated at £130 yearly multiplied by the current exchange rate being the rent due for the property."

The property firm added that since parties were unable to resolve the

rent review, "it will be in the interest of the justice" for the court to determine what the appropriate rent should be. Star Properties said it "acted in good faith by issuing the cheque for the rent due in compliance with the lease agreement between parties, moreso that efforts to resolve the rent review The firm said the Sawlanis and valuation of the reversionary transferred residue of the lease to it interest in the 41 years residue of the lease granted to the claimant have

> The company argued that it was not part of the terms of the lease that the rent will be reviewed before its expiration, adding that it only agreed to a review "on compassionate ground" and is "not even bound to concede to the review of the agreed rent".

> The case, filed in 2017, has suffered delay due to numerous adjournments.

# Isolo NYCN calls for immediate evacuation of silts from roadside

orried by the threat posed by the silts left by the roadside, the National Youth Council of Nigeria (NYCN), Isolo Local Branch has called on the Emergency Flood Abatement Gang (EFAG) and other concerned authority for necessary action.

In a statement signed by its

secretary, Comrade Damilola Kushimo, the youth body explained that while the work of the evacuation team is commendable, the exercise is not complete if the silts which are made up of sand and wastes are not completely evacuated from the roadside.

The body noted that while the efforts made by the government through the ministry in preparation for the rainy season and to ultimately avert flood is commendable the efforts might end up defeated before the rainy season as the silts abandoned by the roadside as seen on Osolo Way area fast returning into the gutter.

The statement read: "It's commendable that the state government is proactive by

taking steps to avert flooding in flood-prone areas of the state and also in preparation ahead of rainy season. From observation, in recent weeks, the evacuation team has intensified its efforts in Isolo LCDA as it had been moving from one major drainage channel and gutters to another for evacuation exercise. We've seen them on Osolo Way,

Ajao Estate and other areas but our major concern is the fact that they are yet to cart the evacuated silts away from the roadsides, especially on Osolo Way. The silt is already finding its way back into the gutters. If this issue is not addressed as a matter of urgency we fear that the effort will be defeated and this means the efforts and resources will be

in futility. We are calling on the relevant agencies to do the needful with urgency."

It cautioned residents against indiscriminate waste disposal as the rainy season approaches, noting that maintaining a clean environment is a collective responsibility of everyone and not the government alone.


